Notice of this meeting was posted on the bulletin board in the Borough Hall on January 4, 2017 and it was published on January 12, 2017 in the Beach Haven Times and the Asbury Park Press, newspapers designated by Mayor and Council on January 4, 2017 to receive such notice, and by filing a copy of the notice with the Acting Borough Clerk on January 4, 2017.

ROLL CALL: Spark, Sharpless, Wellington, Reynolds, Mikuletzky and Warr

**Also present**: Mayor Larson, Terry Brady, Elaine Tollison, Edward Sulecki, Sponge Washburn, newly elected councilmember, Mary Ellen Foley and Brenda Kuhn.

**Discussion:** Councilman Sharpless began the caucus meeting talking about plans for the redesign of the existing skate park. The councilman said he has been talking to professionals about the designs and said that the first thing they need to know is how much is the budget. He asked council to give him a number what they were willing to appropriate for the rebuild. When asked for a recommendation he said \$165,000 and another \$20,000 for engineering costs. There was talk about the asphalt pad, concrete, height and drainage. Councilman Sharpless said that there were some people that wanted to volunteer their time to help with this project. The council also talked about the tennis courts and pickle ball courts. Mayor Larson said that a lot of the people using our pickle ball courts live in High Bar Harbor. He talked to the Mayor of Long Beach Township and asked if they would consider putting pickle ball in High Bar.

Councilwoman Reynolds said that she didn't agree with the dog park fee ordinance that had been introduced at the last regular meeting. She went over the expenses for the dog park. She felt that there was no basis on which to raise the fee and council agreed. She said that she would prefer to raise the weekly fee but not the annual fee. They talked about rewriting an ordinance and not adopting the one that was introduced at the November meeting. Mayor Larson said that another ordinance could be introduced at the reorganization meeting.

Mayor Larson asked Councilman Warr if he had anything to say about his retiring from all the years of being on council. Councilman Warr said that he has seen a lot of changes through the years, some good and some bad. He said that he came across a letter of congratulations from Ethan Alan Smith that was dated 1991. He said that back in those days the council was like a battlefield. It was an embarrassment that council couldn't get along. He said that it has been a pleasure working with council and working with the staff. He said that there has been a lot of good people over the years. George she said that he had some health issues and it was time to go. He said that one time Eleanor Pearson told him that councilmembers are like baby's diapers, they should be changed and often for the same reason. He closed by saying that it has been a pleasure. Mayor Larson read a proclamation. Mayor Larson presented a plaque to Councilman Warr for his years of service to the Borough.

#### **COMMITTEE REPORTS:**

**WATER/SEWER: Council President Spark** said that he wanted to make the Water/Sewer report a part of the minutes.

**PUBLIC WORKS: Councilman Sharpless** said that Public Works has been working on fencing on the beach, the 9<sup>th</sup> Street Handicap ramp, they have been helping the Pavilion and at the docks. He said the staff was very hard working.

**DOCKS AND HARBORS: Councilman Wellington** said that the dock revenue was down from last year despite stripper season. He said that \$1100 was taken in on Black Friday. He said that the dredging was completed. He said that the framing was almost done at the pavilion and the next step is the trusses.

**BEACHES AND PARKS: Councilwoman Reynolds** said the statewide there were 105 pairs of Piping Plovers at 20 sites. She said that Barnegat Light had 5 pairs and 8 chicks that fledged. She thanked everyone for avoiding the nesting areas and for keeping the dogs away. She said there was success and that we had to try to improve each year.

**PUBLIC SAFETY: Councilman Mikuletzky** said he would like to make the court report a part of the meeting minutes. He also said that we were in negotiations with the Long Beach Township Police Chief and Mayor for the Police contract. He said that it looks like the cost will increase by 2-2 ½ %.

**FINANCE: Councilman Warr** said that the bills paid for the month were \$519,833. He said that of that \$169,335 paid regional school taxes and \$113,951 paid local school tax.

**OPEN PUBLIC SESSION:** Mayor Larson asked for a motion to open the public session. On a motion by Wellington seconded by Reynolds and carried by all the public session was open.

**John Tennyson**, West 22<sup>nd</sup> Street, on behalf of the Taxpayers Association, thanked George Warr for the 27 years of dedicated service to the Borough. He said they also wanted to wish him tremendous success. Councilman Warr thanked him.

**John Patterson** asked about opting out of having the new smart water meter installed at his home and **Kimberly Patterson** asked if the install started. Councilman Spark and Mayor Larson addressed this. Mayor Larson said that nothing has been finalized regarding opting out.

**Mayor Larson** began talking about the issue of banning plastic bags. He said that a town on the Island has banned plastic bags and he would like to see how that works out. **Ed Wellington** urged everyone to Google paper vs. plastic and do some research. He said there was a lot of credible research and paper bags use 4 times the energy to make thank plastic.

Tim Brindley, talked about the Wawa and Walmart bags that are found in floating drift nets.

**Barry Mescolotto,** brought handouts for the Mayor and Council concerning the bag issue. He said that the canvass bag isn't the answer because you can't recycle them. He said they are made out of cotton and it takes a lot more energy to make cotton than it does plastic. He said that we all should skip one meat dinner a week we would do more for the environment than any of this. **Councilwoman Reynolds** said that plastic straws are a problem too.

**Tim Brindley** said he was here at the meeting with his two sons who are in the Boy Scouts of America. He said they were there to work on getting a badge. He said his other son is a Life Scout which is the second highest rank in Boy Scouts of America. Tim said that he was Assistant Leader of Troop 65 of Manahawkin. The young men introduced themselves as Nathan and Scott Brindley. They both said that they were Star Scouts in Troop #65 from Manahawkin. They were congratulated.

Mr. Rodman asked when the pavilion was expected to be done. Ed Wellington said he expected it to be complete by March or April.

**CLOSE PUBLIC SESSION:** Mayor Larson asked for a motion to close the public session. On a motion by **Warr**, seconded by **Revnolds** and carried by all the public session came to an end.

#### **ORDINANCE 2017-017**

AN ORDINANCE OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING <u>SECTION 215-16</u> OF THE BOROUGH CODE, ENTITLED "ADMINISTRATION AND ENFORCEMENT," TO REQUIRE A ZONING PERMIT FOR ALL IMPERVIOUS GROUND COVERAGE SURFACES.

**BE IT ORDAINED** by the Mayor and Borough Council of the Borough of Barnegat Light, County of Ocean, State of New Jersey, as follows:

**SECTION 1.** Chapter 215 of the Borough Code of the Borough of Barnegat Light, entitled "Zoning," is hereby amended and supplemented to provide a revised paragraph (3) of subsection D of Section 215-16, entitled "Zoning permits," to read as follows:

# Chapter 215 ZONING

# § 215-16. Administration and enforcement.

### D. Permits.

- (3) Zoning permits.
  - (a) No construction, alteration or excavation for any building or other structure, nor any use of building or land, nor addition or alteration of impervious coverage surfaces, shall be begun without the issuance of a permit by the Zoning Officer indicating that the proposal is in compliance with the provisions and requirements of this chapter.
  - (b) All applications for a zoning permit shall be made on forms provided by the Zoning Officer and shall contain such information as he shall require in order to make a determination as to whether the zoning permit should be issued.
  - (c) Before a certificate of occupancy is issued for any new construction, including residential, industrial or commercial, a certified location survey must be submitted to the Zoning Officer showing that the location of the completed structure, including all additions or alterations of impervious coverage surfaces, complies with all setback, side yard, backyard and all other provisions of this chapter.

All other paragraphs, subsection and sections of Barnegat Light Borough Code Section 215-16 shall remain in full force and effect.

**SECTION 2.** This zoning regulation amendment shall be referred to the Barnegat Light Planning Board, as required by N.J.S.A. 40:55D-26.

**SECTION 3.** This ordinance shall be filed in the office of Ocean County Planning Board.

**SECTION 4.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.

**SECTION 5.** All ordinances of parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 6.** This ordinance shall take effect immediately upon its enactment after second reading and publication as required by law.

AN ORDINANCE OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING <u>SECTION</u> 21-46 OF THE BOROUGH CODE, ENTITLED "ZONING FEES," TO REVISE THE SAME.

**BE IT ORDAINED** by the Mayor and Borough Council of the Borough of Barnegat Light, County of Ocean, State of New Jersey, as follows:

**SECTION 1.** Chapter 21 of the Borough Code of the Borough of Barnegat Light, entitled "Land Use Procedures," is hereby amended and supplemented to provide a revised Section 21-46, entitled "Zoning fees," to read as follows:

#### Chapter 21

**LAND USE PROCEDURES** 

Part 2. Land Use Development Fees

Article VI. Schedule of Fees

### § 21-46. Zoning fees.

The following fees are hereby established as required by Chapter <u>215</u>, Zoning, of the Code of the Borough of Barnegat Light:

A. Sign permits as required by § 215-12B(5): \$50.

- B. Zoning permit fees pursuant to § 215-16:
  - (1) Residential single-family dwelling, new construction: \$150.
  - (2) Residential duplex, new construction: \$200.
  - (3) Residential, single-family dwelling and duplex, expansion of dwelling by alteration or addition to existing structure: \$75.
  - (4) Business, marine commercial and multifamily structures, new construction: \$200.
  - (5) Business, marine commercial and multifamily structures, expansion of structures by alteration or addition to existing structures: \$50.
  - (6) Any accessory building or swimming pool: \$100.
  - (7) Addition or alteration of impervious coverage surface: \$50.
- C. Certificates of zoning occupancy pursuant to § 215-17:
  - (1) Fifty dollars for single-family dwelling.
  - (2) One hundred dollars for residential duplex, multifamily dwelling, business and marine commercial structures.
  - (3) Twenty-five dollars reinspection fee.
- <u>D.</u> Fences. The permit fee for the construction of a fence shall be \$0.10 per linear foot of fence; provided, however, that the minimum fee is \$25.
- **SECTION 2.** This zoning regulation amendment shall be referred to the Barnegat Light Planning Board, as required by N.J.S.A. 40:55D-26.
- **SECTION 3.** This ordinance shall be filed in the office of Ocean County Planning Board.
- **SECTION 4.** If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions hereof.
- **SECTION 5.** All ordinances of parts of ordinances inconsistent herewith are hereby repealed.
- **SECTION 6.** This ordinance shall take effect immediately upon its enactment after second reading and publication as required by law.

**ORDINANCE 2017-019** 

AN ORDINANCE OF THE BOROUGH OF BARNEGAT LIGHT, IN THE COUNTY OF OCEAN, NEW JERSEY PROVIDING FOR THE ACQUISITION OF A FUEL TANK FOR THE BOROUGH AND APPROPRIATING \$75,000 THEREFOR FROM THE BOROUGH'S CAPITAL IMPROVEMENT FUND

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF BARNEGAT LIGHT, IN THE COUNTY OF OCEAN, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring), AS FOLLOWS:

Section 1. The sum of \$75,000 is hereby appropriated from the Borough of Barnegat Light, in the County of Ocean, New Jersey (the "Borough") Capital Improvement Fund for the acquisition of a fuel tank for the Borough, including all work and materials necessary therefore or incidental thereto.

Section 2. The capital budget or temporary capital budget, as applicable, of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency and amendment, the resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget or temporary capital budget, as applicable, and capital program as approved by the Director of the Division of Local Government Services is on file with the Borough Clerk and is available there for public inspection.

<u>Section 3</u>. This ordinance shall take effect as provided by law.
