PROCLAMATION: National Library Week. Linda Feaster, Branch Manager of the Long Beach Island Branch of the Ocean County Library was in attendance. She said that the new digital sign was a gift from the Friends of the Island Library. She said there is a lot of resources and programs available at the library and that it is a very important institution for the community. She said that they were very concerned about President Trumps proposed budget cuts for the elimination of the Institute for Museum & Library Services and the National Endowment for the Humanities. She said that this would be a loss of \$250,000 and many of the

library's offerings would be eliminated. Mayor Larson presented Ms. Feaster with the signed Proclamation.

COMMITTEE REPORTS:

WATER/SEWER: Councilman Spark stated that he wanted the water/sewer monthly report to be a part of the minutes. He talked about the water meter project. He said that the cost would be 100% the responsibility of the Borough with the exception if the property owner's meter pit was under paver or other inaccessible material.

PUBLIC WORKS: Councilman Sharpless said that Public Works have been busy getting ready for summer. He said that the Easter Bunny will be at the Easter Egg Hunt on Saturday at 10am.

DOCKS AND HARBORS: Councilman Wellington said that the ramp is open for business and \$640 in revenue has been collected. He said that the docks are in with the exception of one of the floating docks. He said we were waiting for a new floating dock to be delivered that we will be trying out. Councilman Wellington talked about the new pavilion. He said that the structural engineer hasn't reported back to what is needed for construction of the pavilion. He estimated that it would be the middle of summer before we start construction.

BEACHES AND PARKS: Councilwoman Reynolds said that the beaches will be ready by Memorial Day. She said that the beach badge preseason price is good until June 9th. June 10th the beaches will be open with limited guards. She said that the tennis courts may be used with a seasonal beach badge or by \$10.00 per hour. She said the dog park now has access with a key card. To obtain a pass you had to present a current dog license or rabies vaccination certificate.

FINANCE: Councilman Warr said that our bills for the month were a lot less than last month. He pointed out that there was a handout showing how the tax dollars are spent and a comparison budget since 2013.

PUBLIC SAFETY: Mayor Larson, in Councilman Mikuletzky's absence, said that the court report showed that \$1064.00 was collected in fines and \$591.50 stayed in Barnegat Light. He said that the Barnegat Light court is now being held in the Township of Long Beach. Their courtroom has all the safety features that are required by the court system.

Mayor Larson said we would have the 2017 Budget Hearing prior to the Open Public Session. Resolution 2017-065 was read by title.

ORDINANCE 2017-003

AN ORDINANCE OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING THE RECONSTRUCTION OF WEST 19th STREET IN THE BOROUGH OF BARNEGAT LIGHT AND APPURTENANCES THERETO, AND APPROPRIATING \$175,000.00 THEREFOR, AND PROVIDING FOR THE ISSUANCE OF \$166,250.00 IN GENERAL IMPROVEMENT BONDS OR NOTES OF THE BOROUGH OF BARNEGAT LIGHT TO FINANCE THE SAME.

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Barnegat Light, County of Ocean, State of New Jersey, as follows:

SECTION 1. The capital project described in Section 3 of this Ordinance is hereby authorized to be made by the Borough of Barnegat Light, in the County of Ocean and State of New Jersey. For said capital project, there is hereby appropriated the sum of \$175,000.00, said sum being inclusive of all appropriations heretofore made and including an \$117,500.00 grant expected to be received from the New Jersey Department of Transportation and a \$8,750.00 down payment for said capital project required by law and now available therefor by virtue of a provision in the Capital Improvement Fund in a previously adopted budget or budgets of the Borough.

SECTION 2. In order to finance the cost of the project, negotiable bonds or notes are hereby authorized to be issued in the principal amount of \$166,250.00 pursuant to the Local Bond Law. In anticipation of the issuance of the bonds, negotiable bond anticipation notes are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

SECTION 3. (a) The capital project hereby authorized and the purpose for the financing of which the bonds are to be issued is the reconstruction of West 19th Street and appurtenances thereto, including all work and material necessary therefore or incidental thereto.

- **(b)** The estimated maximum amount of bonds or notes to be issued for the capital project is as stated in Section 2 hereof.
- (c) The estimated cost of the capital project is equal to the amount of the appropriation herein made therefor.

SECTION 4. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the Chief Financial Officer, provided that no note shall mature later than one (1) year from its date. The notes shall bear interest at such rate or rates and be in such form as may be determined by the Chief Financial Officer. The Chief Financial Officer shall determine all matters in connection with notes issued pursuant to this ordinance, and the Chief Financial Officer's signature upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time subject to the provisions of N.J.S.A. 40A:2-8.1. The Chief Financial Officer is hereby authorized to sell part or all of the notes from time to time at not less than par, at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The Chief Financial Officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the notes pursuant to this ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the notes sold, the price obtained and the name of the purchaser.

SECTION 5. The capital budget or temporary capital budget (as applicable) of the Borough of Barnegat Light is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. In the event of any such inconsistency and amendment, the resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget or amended temporary capital budget (as applicable) and capital program as approved by the Director of the Division of Local Government Services is on file with the Borough Clerk and is available there for public inspection.

SECTION 6. The following matters are hereby determined, declared, recited and stated:

- (a) The capital project described in Section 3 of this Bond Ordinance is not current expense. It is capital project that the Borough may lawfully undertake as a general improvement, and no part of the costs thereof have been or shall be specially assessed on property specially benefited thereto
- **(b)** The period of usefulness of the capital project within the limitations of the Local Bond Law, according to the reasonable life thereof computed from the date of the bonds authorized by this Bond Ordinance, is ten (10) years.
- (c) The Supplemental Debt Statement required by the Local Bond Law has been duly-prepared and filed in the office of the Clerk and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey. Such statement shows that the gross debt of the Borough as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided in this Bond Ordinance by \$166,250.00. The obligations authorized herein will be within all debt limitations prescribed by that law.
- (d) An aggregate amount not exceeding \$35,000.00 for the items of expense listed in and permitted under NJSA 40A:2-20 (Section 2-20 expenses) may be included as part of the cost of said improvement and is included in the foregoing estimate thereof.

SECTION 7. The full faith and credit of the Borough are hereby pledged to the punctual payment of the

principal of and the interest on the obligations authorized by this Bond Ordinance. The obligations shall be direct, unlimited obligations of the Borough, and the Borough shall be obligated to levy <u>ad valorem</u> taxes upon all taxable property within the Borough for the payment of the obligations and the interest thereon without limitations of rate or amount.

SECTION 8. Any grant moneys received for the purposes described in Section 3 hereof shall be applied either to direct payment of the cost of the improvements or to payment of the obligations issued pursuant to this bond ordinance. The amount of obligations authorized hereunder shall be reduced to the extent that such funds are so used.

SECTION 9. The Borough hereby covenants to take any action necessary or refrain from taking such action in order to preserve the tax-exempt status of the bonds and notes authorized hereunder as is or may be required under the Internal Revenue Code of 1986, as amended, and the regulations promulgated thereunder (the "Code"), including compliance with the Code with regard to the use, expenditure, investment, timely reporting and rebate of investment earnings as may be required thereunder.

SECTION 10. To the extent that any previous ordinance or resolution is inconsistent herewith or contradictory hereto, said ordinance or resolution is hereby repealed or amended to the extent necessary to make it consistent herewith.

SECTION 11. This bond ordinance shall take effect twenty (20) days after the first publication thereof after final adopted as provided by the Local Bond Law.

ORDINANCE 2017-004

AN ORDINANCE OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING THE FEES AND ACCESS RULES FOR VARIOUS PUBLIC RECREATIONAL FACILITIES.

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Barnegat Light, County of Ocean, State of New Jersey, as follows:

SECTION 1. Section 57-18.1 of the Borough Code of the Borough of Barnegat Light, entitled "Municipal Dog Park," is hereby amended and supplemented to provide revised subsections C and D to read as follows:

§ 57-18.1. Municipal Dog Park.

- C. Any person desiring to use the Borough's dog park for any dog(s) owned and licensed by him may do so only after registering said dog(s) with the Borough of Barnegat Light by completion of access card application form, acceptance of risk and release of liability form and payment of fee. Any person who has been issued a license for his/her dog(s) in another municipality may register his/her dog(s) by completion of access card application form, acceptance of risk and release of liability form, payment of fee and by producing a copy of the other municipality's license and/or valid rabies certificate. The Borough shall issue to said registrants one keycard for entry into the dog park and an ID tag for each registered dog.
- D. Proof of licensing and registration with the Borough shall be required annually. There shall be no fee for residents and homeowners, and for nonresidents a \$30 annual fee or a weekly fee of \$10 payable to the Borough of Barnegat Light. Passes are not transferrable between owners. The annual keycards will expire on January 31st of the next ensuing year and the weekly passes will expire 7 days from the date of issue. Applications and passes may be obtained from the Barnegat Light Borough Hall offices weekdays from 8:00am to 3:00pm or at the beach badge booth when in operation. The application may also be obtained from the Borough website and mailed in with the required documents and fee. The keycard and ID tag may be picked up at Borough Hall offices weekdays from 8:00am to 3:00pm or at the beach badge booth when in operation. If necessary the card and tag can be mailed to applicant when a self addressed stamped envelope is provided by applicant.
- E. Lost or replacement keycard passes may be issued upon payment of a \$10 fee for the same. Only the registered card holder will be issued replacement cards. The lost card will be deactivated and no longer valid.

All other subsections, paragraphs and provisions of Borough Code § 57-18.1 shall remain in full force and effect.

SECTION 2. Article II of Chapter 144 of the Borough Code of the Borough of Barnegat Light, entitled

"Municipal Tennis Courts," is hereby amended and supplemented to provide a revised Section 144-20, to be entitled "Fees, reservations," to read as follows:

§ 144-20. **Fees, reservations.**

- A. Municipal tennis courts may be accessed by presenting a current Barnegat Light pre-season or seasonal beach badge. In lieu of a pre-season or seasonal beach badge a fee of \$10.00 per hour is required. There shall be no fees for off-season use of these courts.
- B. Barnegat Light residents and property owners may make reservations, by presenting a preseason beach badge prior to the beginning of the season, for the use of the courts for the same day of the week and the same hours of the day for the entire season. Thereafter, Barnegat Light residents and property owners may make individual session reservations no more than 2 weeks in advance; all others may make individual session reservations no more than 1 week in advance. Use of the tennis courts may be continued after the hour session if there is no one waiting to use the court; otherwise the court must be vacated after the end of the hourly session. Reservations shall be forfeited if not used within 10 minutes of its start time.
- C. Municipal pickleball courts may be accessed by presenting a current Barnegat Light seasonal beach badge.

SECTION 3. Article III of Chapter 144 of the Borough Code of the Borough of Barnegat Light, entitled "Municipal Skate Park," is hereby amended and supplemented to repeal Section 144-24, entitled "Skate Park badges required; fees," which shall be eliminated.

SECTION 4. All ordinances of parts of ordinances inconsistent herewith are hereby repealed.

SECTION 5. This ordinance shall take effect immediately upon its enactment after second reading and publication as required by law.
