Mayor Larson asked if anyone had anything. He said we can talk about the Loveladies Homeowners agreement. George Warr said he wants to understand that a little better. Terry Brady explained. The Borough has the Riparian Grant along the water that borders Loveladies. A couple of the homeowners want to develop a dock into the area that would be our riparian grant. As it exists now there cannot be any docks. The homeowners are asking at their cost, expense, etc. is to see if they can get DEP to lift that restriction. Once that is lifted they will ask if they can purchase development rights so they can develop their docks. If we spend any money they will pay for it. Mike said as if we were the Mike said it would only be at that area, not the whole waterfront. Ed said we should request a survey of the area so we know exactly what we are talking about. Mike said he is sure it shows on the tax map. George asked if we want to do this. Would the DEP allow us to even do this? Terry said by allowing the restriction to be removed it doesn't mean that they have the right to go there. They can't go across the land, they can't use our water. Mayor said it would increase their property values. Let's get all the information we need for the next meeting. Ed said he could not determine what we are talking about from the tax map. We also need from the interested parties what they are looking for with some sort of a sketch. We need to know what they plan to do. Mike said we can put the same restrictions on their docks that the township puts on their docks. Length and things like that. COMMITTEE REPORTS:

WATER/SEWER: Michael Spark asked that the water report be a part of the minutes. It is still going down. The snow birds from Barnegat Light don't leave until February and March. Loveladies leaves earlier. Remind everyone that it has been so far a mild winter and he hopes they have their sprinkler systems blown out and drained. Also shut off your outside shower. It cost for the town to shut off and turn on your water.

PUBLIC WORKS: Scott Sharpless said the public works report is at the back. They have spent a lot of time in the lifeguard house trying to fix little issues in there. They put up the holiday decorations. We are looking into 19, 22 and 21 ramps to repair same. They are doing a good job.

DOCKS AND HARBORS: Ed Wellington said after Thanksgiving we shut the workforce down. We ended up about \$2900 less than last year. No fish! Salary was basically the same as last year. We lost our flagpole in the wind the other Monday. Kat said he could order it by the end of the year. Get something to her.

BEACHES AND PARKS: Dottie Reynolds said Beach Badge revenues are still behind last year. Our dailies were up more than \$2,000. Our checkers were doing a good job. Our seniors were up a little bit. Our weekly, season and preseason were all lower. We still have a chance to make it up but we are under \$8,000.00. Dottie said she should have brought one of the holiday badges to show everyone.

PUBLIC SAFETY: Frank Mikuletzky mentioned he had a report from Chief Mike Bradley. The Long Beach Police station has been designated as a drop off point for prescription drugs 24/7 in the lobby. Keeps drugs out of waste, landfills and they are disposed of properly. Keeps them out of the wrong hands. Emergency Management reentry placards are ordered and should be in this month. They will go out in the Township in February with their water bill. The old placards will be honored until we get the new ones. Go to the Police Web site to register for vacant homes. You can also go there and register for the nexel or the reverse 911. The arrests were made and they were juveniles and have been charged. The investigation is still going on.

FINANCE: George Warr spoke of the bills being paid this evening. We are having a budget workshop tomorrow afternoon. Being no further comments

WHEREAS, this interlocal service agreement is being amended to provide for a monthly fee of \$165 from all municipalities to compensate Long Beach Township for said reporting services to NJDCA.
