REGULAR MEETING OF MAYOR AND COUNCIL DECEMBER 9, 2015

THE CAUCUS MEETING of the Mayor and Council was called to order by Mayor Larson at 4:30pm at the Borough Hall, on East 7th Street. He stated that adequate notice of this meeting has been provided in accordance with the New Jersey Open Public Meetings Act by posting a copy of the notice of this meeting on the bulletin board in the Borough Hall on January 5, 2015 and by mailing a copy of the notice to the Beach Haven Times and Asbury Park Press, newspapers designated by Mayor and Council on January 5, 2015, to receive such notice, and by filing a copy of the notice with the Borough Clerk on January 5, 2015.

ROLL CALL: SPARK, SHARPLESS, WELLINGTON, WARR, MIKULETZKY, REYNOLDS

ALSO PRESENT TERRY F BRADY, ESQ., MAYOR LARSON, ELAINE TOLLISON, ADMINISTRATIVE ASSISTANT/TAX CLERK, KATHLEEN FLANAGAN, CFO, EDWARD SULECKI, SUPERINTENDANT AND BRENDA KUHN, ACTING MUNICIPAL CLERK/TAX COLLECTOR

The Mayor said he wanted to talk about the Community Block Grant money and suggested that we use it for the 9th Street ramp. Councilman Sharpless said the ramp was in bad shape. He talked to Eddie about getting an estimate for resurfacing the ramp. He said the pilings and the joists were ok.

Councilman Warr wanted to set up a Budget Workshop. It was decided that it would be on January 13, 2016 at 3:00pm, the afternoon of the first regular meeting of 2016.

Mayor Larson said he wanted to talk about the dog park. He talked about redoing the dog park and bringing back the baseball field. Councilwoman Reynolds said as long as we have plenty of room. She said they had discussed about charging for an entry card and they said that Cape May was charging \$40.00 for a card to enter the park but she said she talked to someone in Ocean Co. and they told her it was \$5.00. Mayor Larson said that County residents are \$5.00. Mayor Larson said he would like to just give people the card but put a lock on it so that people wouldn't be showing up at 6am. Councilwoman Reynolds said she still didn't know how that would work. Mayor Larson said there would be a timer. Councilwoman Reynolds said it would be good because they would have to show their rabies certificate in order to get their card. Then fencing was discussed and possibly having a fence co. come in and draw it out so everyone could see what was going on. Kirk said to get a price and if it's under \$40,000 (Kat said "Not yet") that we could just have them install it.

Council President Spark asked if they wanted to talk about the vacancy in the Zoning Board. They said that Kathleen Clark will be the replacement.

Terry said we will be conducting the auction for the 5 year livery leases. The resolution is ready and Kathleen Flanagan is ready to take the deposit.

Mayor Larson said this is the last meeting before reorganization and wanted to ask everyone if the 2^{nd} Wednesday of the month works for the regular meeting in 2016 and everyone said it was good. Mayor Larson said that we have a notice out for hiring a Court Administrator. Salary isn't in the ad but the hours are. It will weed out the people looking for a full time position.

Mayor Larson said that Public Works is doing a great job on the boardwalks and Councilwoman Reynolds said we still need the roll ups in the south end of town where we are building up the dunes. Everyone is building up their dunes on the Island. Dunes build up over the winter and then Eddie and the crew have to plow them out in the spring. The roll ups get taken up by Public Works in the fall and in the spring put on top of the sand. She said one place we could have a permanent boardwalk is right at the end of street where there are boardwalks now. The rollups don't start at the street in most places they start in further and the dunes don't build up at the street end. Councilman Sharpless said we could put 2 or 3 sections to get started. Councilman Sharpless said we are up to 17th Street now.

Councilman Sharpless said if there was any grant money left over they could use it for new beach wheels or to refurbish the old ones. Another idea would be Moby mats. The kiddie beach on 25th Street has a T shaped section that washes out. Maybe we could find something to make the entrance more accessible. We can't pour concrete but for handicap accessibility you can get to the Moby mat but there's a gully when you past the wall. Maybe they make a T for Moby mats. Kirk suggested wood. Scott thought that the DEP would frown on that but Eddie said he didn't think that wood would be a problem.

Mayor Larson said we received the deed on the Coast Guard property. Now that there is a garage door on the new PW/Firehouse building, we can store the refrigerators, dishwashers, stoves, etc. to

auction off at GovDeals. The police have already been in there with the dogs. We're not going to tear it down until after the 1st of the year. Councilman Sharpless said that Winnie told him that the Lifeguard house needed a couple of refrigerators. The dock building needs a window and there's one that will fit. Kat said that the sliding glass door needs to be replaced on the Lifeguard house. Winnie will measure. Council President Spark asked if we were tearing it down ourselves and Kirk replied that he's been trying to get someone to give him a price, but no one has come forward. He said that we could rent a machine for \$3000.00 and Public Works could do it. Kirk said that the garbage contractor is ready to take it away.

Councilman Warr brought up the appointment of a Code Enforcement Officer. He was concerned that the Code Enforcement Officer would be a bad idea. He was concerned that the Code Enforcement Officer would go around looking for trouble like in Surf City Council President Spark said it's not James Bond, not a license to kill! Terry Brady said that Code Enforcement Officer serves at the pleasure of the Governing Body. The position would be "as needed" officer.

Council President Spark introduced Brenda L. Kuhn as the new Acting Municipal Clerk. He said we are extremely happy to have this lady to step up. Kirk said that we have a new QPA, Kat Flanagan.

Mayor Larson asked if we had anything else. Mayor Larson said we'll take a 10 minute break, all in favor and all were in favor.

LIVERY LEASE AUCTION: Terry Brady said that the auction had been advertised. He announced that the parcels being auction were Block 16.01 Lot 3, commonly known as Livery #1 with the minimum bid being \$24,045.00 and Block 16.01 Lot 4 commonly known as Livery Parcel #3 with the minimum bid being \$23,520.00. Both are 5 years leases with a 1% increase per year. 20% deposit is required for the first years rent. Winners of the bid will be entering into a lease contract. Properties are currently tax exempt and if that changed the leases would be responsible.

The Livery # 1 was bid on by Robert Holzwarth and the bid was \$24045.00, there were no other bidders. Livery #3 was bid on by Vince Chiaro and his bid was \$23520.00 and there were no other bidders. Terry Brady did the resolution for the Livery Lease immediately after the auction. Terry Brady did the resolution so that they could complete the lease agreements.

Terry Brady said that they would go into the other room to enter into the lease agreement.

TREASURER'S REPORT: Mayor Larson asked for a motion to approve the Treasurer's Report. On a motion by Scott, seconded by Reynolds and carried by all the report was approved.

BUILDING AND ZONING REPORT: Mayor Larson asked for a motion to approve the Building and Zoning Report. On a motion by Reynolds, seconded by Wellington and carried by all the report was approved.

COMMITTEE REPORTS:

WATER/SEWER: Michael Spark reported that during the summer a total usage of water is around 29 million gallons and in November on 6 million gallons were used with the majority of that being used by Barnegat Light. Mayor Larson asked if there was anything on the new meters and Eddie informed him that Frank Little is working on the specs. Michael asked Eddie if the new ones would fit into the old meter pits. He was concerned about the cost to each property owner. Eddie said the old meter pits would fall apart as soon as you touch them because they have been in the ground so long. Michael said that it might cost \$1500 per owner. Eddie said that for the last five years they were putting in the new style pits.

PUBLIC WORKS: Scott Sharpless said that Public Works has been busy. 261 hours of work last month were at the beaches. There have been a couple of water leaks. They are up to 17th St. with the boardwalks. They're doing a great job!

DOCKS AND HARBORS: Ed Wellington said that due to the good fishing and weather that \$3100.00 more favorable than last year on boat ramp fees. Almost \$42,000 compared to \$38,700 last year. He reported that he spoke to Scott Stevens who's running the dredging project and was informed that they were reopening the bidding and the bid opening will be Dec. 29. There's a provisions in the contract that the entire job, including Barnegat Light, must be completed by December 2016.

BEACHES AND PARKS: Dottie Reynolds said she's sure that everyone is happy that DPW has done such a good job on the boardwalks. With budget time coming up does anyone have thoughts for BEACHES AND PARKS please let her know.

PUBLIC SAFETY: Frank Mikuletzky said he would like to make the court report part of the minutes. \$614.00 was collected. The Police Chief told him to register vacant homes with the PD.

You can sign up for Nixle (Emergency notification system). You can get email notifications on your computer or phone. He talked about the accident on the bridge.

FINANCE: George Warr said that the vouchers that were submitted for approval were in the amount of \$548,394.34. We're having a budget workshop on the afternoon of January 13, 2016 at 3:00pm.

OPEN PUBLIC SESSION: On a motion by Sharpless and seconded by Spark and carried by all the public session was opened. Dick Feehan whose address is 12 E 15th St., asked if they could go out to bid for meters that would fit the existing pits. Michael asked Eddie if the pits are breaking where does the Boroughs responsibility stop. Eddie said that the Borough's responsibility stops on the street side of the meter pit. Connie Higgins spoke in regard of the code official and how the owners would know what's in the code. Some examples were given. Then she wanted to talk about restricting parking on the Blvd in the summer. She thought it was great but you will lose a lot of parking spaces. Connie said that a lot of the people of the popular parking streets don't know about the 20' ordinance. (Driveway) She said she got a warning ticket in the summer. We need to make homeowners aware. Mayor Larson said that he talked with Scott about even going to changing the parking on the streets and marking out designated spots. Scott said we could send out something in the next mailing to let everyone know about the parking ordinance. Connie said that the Police need to know too. Kirk asked what was thought about 2 spots at the beach end of the streets. Scott said there were two problems with that. People drop off their things when they're going to the beach and some places there's an incline that would make parking difficult. They said they should just mark off the parking spaces and the driveways. They discussed how borough code states that you can only claim 20' of your frontage as driveway and people can park on the remainder. The Blvd. is becoming a hazard. Tim Brindley said there was a lot of volume of cars parking from 30th-22^{nd Streets}. Ed Wellington said this problem isn't unique to Barnegat Light. Henriette Richard, 22nd Street, wanted to talk about the poopie law. Someone with a big dog keeps doing it and she asked what you can do. They council told her to take a picture. Dotty said that's where our code enforcer would be used. She also brought up the problem with the bridge. The high beams of the oncoming traffic were very dangerous and asked if there could be signs put up to discourage the use of high beams. Mayor Larson asked Frank to look into it. With there being no further comment, on a motion by Spark, seconded by Wellington and carried by all the public session was closed.

ORDINANCE 2015-012

WHEREAS, upon the appointment of a qualified purchasing agent, NJSA 40A:11-3 provides that the contracting unit may increase its bidding thresholds to the adjusted amounts established by the Governor, in consultation with the Department of the Treasury, every five years; and

WHEREAS, Kathleen Flanagan currently holds the licenses and qualifications to be certified as the Borough's Qualified Purchasing Agent.

NOW, THEREFOR, BE IT ORDAINED by the Mayor and Borough Council of the Borough of Barnegat Light, County of Ocean, State of New Jersey, as follows:

SECTION 1. The Borough of Barnegat Light does hereby appoint Kathleen Flanagan as the Borough's Qualified Purchasing Agent.

SECTION 2. The Borough of Barnegat Light does hereby further establish as its bidding thresholds the amounts set forth in the State adjustments, per NJSA 40:11-3.

SECTION 3. This ordinance shall take effect immediately upon its enactment after second reading and publication as required by law

The Acting Municipal Clerk read the above by title and number and the Mayor announced that it is time to consider same for passage on second reading according to law. ORDINANCE 2015-013

AN ORDINANCE OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 32 OF THE BOROUGH CODE, ENTITLED "OFFICERS AND EMPLOYEES" TO CREATE THE POSITION OF CODE ENFORCEMENT OFFICER.

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Barnegat Light, County of Ocean, State of New Jersey, as follows:

SECTION 1. Chapter 32 of the Borough Code of the Borough of Barnegat Light, entitled "Officers and Employees," is hereby amended and supplemented to provide a new Article IX, to create and establish the position of Code Enforcement Officer, to read as follows:

OFFICERS AND EMPLOYEES

Article IX Code Enforcement Officer

§ 32-50. Creation of position of Code Enforcement Officer.

There is hereby created the position of Code Enforcement Officer for the Borough of Barnegat Light.

§ 32-51. Appointment of Code Enforcement Officer; term of office.

The Code Enforcement Officer shall be appointed by the Mayor with the advice and consent of the Borough Council and shall serve at the pleasure of the Mayor and Borough Council.

§ 32-52. Powers and duties of Code Enforcement Officer.

The Code Enforcement Officer shall conduct field inspections and special investigations to ensure compliance with variance municipal ordinances, enforce rules and regulations related to the enforcement of ordinances, prepare reports, maintain files and records, and perform all such duties as are assigned from time to time by the Mayor, Borough Council and/or Borough Administrator.

§ 32-53. Compensation of Code Enforcement Officer.

Compensation for the Code Enforcement Officer shall be determined by the Mayor and Borough Council from time to time, which shall be in accordance with the Salary Ordinance of the Borough of Barnegat Light. **SECTION 2.** All ordinances of parts of ordinances inconsistent herewith are hereby repealed.

The Acting Municipal Clerk read the above by title and number and the Mayor announced that it is time to consider same for passage on second reading according to law. Sharpless moved to open public hearing, seconded by Spark and carried by all. Michelle Wellington asked if we had anyone in mind and Mayor Larson said yes and that Sponge Washburn has been hired and that he would be good. Mrs. Wellington agreed. There were no further comments. 3. That the Borough is aware that the adoption of this Resolution does not free it of the obligation to pay for post-retirement medical benefits of retirees or employees who qualified for those payments under or Chapter 48 Resolution adopted previously by this governing body.

4. That the Borough agrees that this Resolution will remain in effect until property amended or revoked with the State Health Benefits Program, and that it recognizes that, while the Borough remains in the State Health Benefits Program, it is responsible for providing the payment for post-retirement medical coverage as listed in the attached Chapter 48 Resolution Addendum for all employees who qualify for this coverage while this Resolution is in force.

5. That the Borough understands that it is required to provide the Division of Pensions and Benefits complete copies of all contracts, ordinances and resolutions that detail post-retirement medical payment obligations this it is undertaking, and that the Borough further recognizes that it may be required to provide the Division with information needed to carry out the terms of this resolution.

6. That a certified copy of this resolution shall be forwarded to the State Health Benefits Bureau of the State Division of Pensions & Benefits
