REGULAR MEETING OF MAYOR AND COUNCIL FEBRUARY 10, 2016

THE CAUCUS MEETING of the Mayor and Council was called to order by Councilman Warr at 4:30pm at the Borough Hall, on East 7th Street. He stated that adequate notice of this meeting has been provided in accordance with the New Jersey Open Public Meetings Act by posting a copy of the notice of this meeting on the bulletin board in the Borough Hall on January 4, 2016 and by mailing a copy of the notice to the Asbury Park Press, newspaper designated by Mayor and Council on January 4, 2016 to receive such notice, and by filing a copy of the notice with the Borough Clerk on January 4, 2016.

ROLL CALL: Spark, Sharpless, Wellington, Reynolds, Mikuletzky, Warr

Also present: Mayor Larson, Terry Brady, Brenda Kuhn and Ed Sulecki

The Mayor said this is the caucus. Councilman Sharpless stated that he had a lot to talk about. He started with the letter that he sent to the county regarding additional crosswalks. The reply from the county came in and said that they would review the locations and schedule installation for late April or early May. Then he started talking about the barriers at the end of the streets. He spoke to Frank Little about the barriers and Frank said there was nothing in the DOT regulations that require the barriers. Frank advised Scott to reach out to the insurance company to see if they require them. The insurance co. said they are not required. A suggestion for the barriers was take out one side, take out the bottom on the other side, paint the cross bar and put all signs up there and by putting the signs up there would eliminate the need for reflectors because our signs are reflective. Councilman Wellington said before we take them completely down we should talk about the idea that someone had at the last meeting regarding bicycle racks. Maybe some of the posts that are there could be used to secure the racks. Mayor Larson asked if anyone considered bike racks in the budget and what streets were being considered. Mayor and Council discussed it and determined that 20th -30th Streets would be the best place to install bike racks. Next, Councilman Sharpless wanted to talk about the CDBG money. The concern about our application was if the money could be used strictly for materials and not the labor. The estimate for materials is a little higher than what we expect to receive and we need to be able to budget for the additional cost to complete the project. Then Mayor Larson wanted to talk about parking. He asked the county and Rojas about parking on the county roads. He said that we were getting a little feedback from the county. He said that the shoulders were wide enough to accommodate trailers but his problem was just leaving it there. He said he doesn't even want them there in the summertime. They he said they discussed side streets which doesn't have anything to do with the county. They said that no trailers should be parked there overnight. Mayor Larson said that we need to do something because an ordinance takes two months and May will be here soon. Councilman Spark said he didn't agree with banning the parking. Councilman Warr said he agreed. Councilwoman Reynolds said she didn't think we should have parking on the Blvd. in the summer. Mayor Larson said that we will send a resolution to the county that would request the banning of parking on Central Ave. from June 1st to September 15th. Councilman Sharpless said that he also asked Frank about the 100' line buffer and he said that it was not required but it's more a convenience for emergency vehicles. Mayor Larson said that this would be a resolution to the county and once they adopt it then we can pass a local ordinance. Mayor Larson said that the insurance company came by and gave us the opportunity to purchase flood insurance for our buildings and deductibles and it would cost approximately \$100,000. Then they talked about the email that came from Long Beach Township about charging a nominal fee for the shuttle.

Mayor Larson asked for a motion to adjourn. On a motion by Sharpless, seconded by Spark and carried by all the Caucus was over.

THE MAYOR stated that we have a second hearing on the Community Development Block Grant and he asked for a motion to open to the public.

Mayor Larson said that the project that we want to use the block grant funding for is "Rehabilitation and Retrofit of 9th Street Ramp for Handicap Access" Mayor Larson asked if anyone else had any other ideas and no one did. Mayor Larson asked for a motion to close the hearing. On a motion by Councilman Warr to close, seconded by Councilman Sharpless and carried by all, the CDBG Hearing was over.

COMMITTEE REPORTS:

WATER/SEWER: Mayor Larson asked Councilman Spark if he has heard anything about meters and he said no. He also said that he spoke to Frank Little about them at the Christmas party. Councilman Spark said that Barnegat Light is using a lot more water than Long Beach Township. He stated that LBT used 1.7 million gallons and Barnegat Light used 3.1 million gallons.

PUBLIC WORKS: Councilman Sharpless said that he wanted to make the Public works report a part of the minutes. He said that we would be hiring a PW employee tonight but he already left and now we have to find another employee. He stated that the department was building boardwalks but the weather hasn't been very good so they are building them but not installing them. 15th Street is still torn out and they have to do a little grading there and then they can install. Councilman Sharpless said that they had the bands booked for the summer and the first concert will be July 4th and the last one is on August 15th. The Memorial Day Parade will be Sunday, May 29th. The 4th of July Parade will be on Saturday, July 2nd. The Beach Olympics will be Thursday, July 14th with a rain date of July 21st. Councilman Sharpless stated that this year we are trying something new. He said that he was trying to get Our Gang players to do a couple of Broadway reviews. He said he would like to do one in July and one in August. He said that they had the younger singers at Barnegat Light Day and it was a huge hit. He was still trying to work it out the details with the directors.

DOCKS AND HARBORS: Councilman Wellington said that we still have 5 boat ships available. He stated that he had a conversation with the DOT about the dredging of our channel. They awarded a contract to Great Lakes Dredge and Dock on January 28, 2016 for the maintenance dredging of Oyster Creek, Double Creek, and the Barnegat Light State channel. DOT will conduct a pre-construction meeting to outline the schedule order of work and start date. The bid that was accepted for the project leaves the schedule open for the contractor to complete the work in the manner that works best for them; however the work must be completed by December 31, 2016. Councilwoman Reynolds asked if there was any decision on the boats that were left at the bay beach. Councilman Wellington said that he had a couple ideas what to do with them and that he wanted together with Frank and Scott before anything is done.

BEACHES AND PARKS: Councilwoman Reynolds said there wasn't much happening in Beach and Parks but we had correspondence from the YMCA requesting beach badges for their youth camp. She also said the Taxpayers Assoc. are also interested in bike racks and that she would get the estimates for the racks.

PUBLIC SAFETY: Councilman Mikuletzky reported that the Police Dept. is encouraging the residents to report street light outages. He stated that you can report it straight to the electric co. through their friendly website. The PD is also urging residents to drop off their unused prescription medications. There is a drop box down at the Township. They will also schedule a drop off in Barnegat Light in the near future.

FINANCE: Councilman Warr reported the amount of payments made last month was \$1,692,511.00 and \$130,691.00 went to regional school taxes.

OPEN PUBLIC SESSION: On a motion by Reynolds and seconded by Spark and carried by all the public session was opened.

John Tennyson, of 6 W 22nd Street, said he was speaking for the BL Taxpayers Assoc, and he had two items that he would like to discuss. The first thing was that Dottie made a presentation to the trustees about bike racks. The Association authorized \$8,500.00 to contribute for the bike racks. The second item pertained to the Associations newsletter which would be going out this week. Enclosed in the newsletter is the membership drive which includes a survey. They wanted to give the Borough a copy before it went out 1242 residents. They put the question about the "Coast Guard Property" on the survey but left it as a free form answer. Mayor Larson said maybe the Open Lands meeting could be put off until the results of the survey come in. The mayor said that yesterday and today the buildings are being torn down. Connie Higgins, 10 East 11th Street, wanted to say thank you for sending out the letter about the driveway ordinance.

Mary Ellen Foley, 6 East 10th Street, said that she has had guests come down for a week with a boat and trailor. Barry Mescolotto, 11 West 19th Street, stated that there's a lot of leaking water services in town. He said one example was West 23rd Street. Councilman Spark said that that was all ground seepage. Mr. Mescolotto said that the meter boxes have water bubbling out. He said someone should go around and check it out. Councilman Spark thanked him for his concern.

ORDINANCE 2016-001

ORDINANCE OF THE BOROUGH OF BARNEGAT LIGHT,
COUNTY OF OCEAN, STATE OF NEW JERSEY,
TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS
AND TO ESTABLISH A CAP BANK
(N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, *N.J.S.A.* 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 0% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, *N.J.S.A.* 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Mayor and Council of the Borough of Barnegat Light in the County of Ocean finds it advisable and necessary to increase its CY 2016 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Mayor and Council hereby determines that a 0.0% increase in the budget for said year, amounting to \$ 62,866.80 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Mayor and Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Mayor and Council of the Borough of Barnegat Light, in the County of Ocean, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2016 budget year, the final appropriations of the Borough of Barnegat Light shall, in accordance with this ordinance and *N.J.S.A.* 40A:4-45.14, be increased by 3.5%, amounting to \$ **62,866.80** and that the CY 2016 municipal budget for the Borough of Barnegat Light be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.
