REGULAR MEETING OF MAYOR AND COUNCIL JANUARY 13, 2016

THE CAUCUS MEETING of the Mayor and Council was called to order by Councilman Warr at 4:30pm at the Borough Hall, on East 7th Street. He stated that adequate notice of this meeting has been provided in accordance with the New Jersey Open Public Meetings Act by posting a copy of the notice of this meeting on the bulletin board in the Borough Hall on January 4, 2016 and by mailing a copy of the notice to the Asbury Park Press, newspaper designated by Mayor and Council on January 4, 2016 to receive such notice, and by filing a copy of the notice with the Borough Clerk on January 4, 2016.

ROLL CALL: SHARPLESS, WELLINGTON, REYNOLDS, MIKULETZKY (VIA SPEAKER PHONE), WARR SPARK WAS ABSENT

MAYOR LARSON WAS ABSENT.

Councilman Wellington asked if there was anything for discussion. Councilwoman Reynolds stated that she liked like having all the resolutions and minutes online. She said that we did a great job getting everything presented to council. Councilman Wellington passed the information on to the audience. He told them that instead of getting a stack of paper through the month the ladies in the office where putting them up on a private website so that it could be viewed by council and then after approval it would be posted to our regular website. Councilwoman Reynolds stated that some things you just need to read and you don't need the paper. Everyone said that it was a great idea. Councilman Warr said that it would be a learning experience for all.

Councilman Sharpless wanted to discuss the CDBG prior to the public hearing. PW got 2 quotes for redoing the 9th Street walkway. The first quote was \$110,000 just to resurface it. He stated that Winnie also got a quote for just the materials for the Borough guys to do it. His question to Terry Brady was if the grant money could be used for just materials and not the labor. Sharpless said the total is approximately \$37,000 for the decking and everything. Councilman Sharpless wanted to find out if all the money could be used for materials and our PW department do the work. Terry Brady said we could check with the CDBG people. Councilwoman Reynolds asked if we had to go with \$110,000 quote, would we drop this project and are there any alternative suggestions. Sharpless said that we should still move forward with 9th Street because it really needs to be done. He asked what the alternative would be and Councilwoman Reynolds suggested bike racks. Councilman Warr asked Terry Brady what the money could be used for and Terry Brady said that the short answer is the Block Grant is Federal money that is funneled through the state, to the county and then to us that's designed for capital projects, usually construction of public improvements. Councilman Sharpless said it was his understanding that it had to be existing and also had to be handicap accessible. Councilman Warr asked if the money could be used to do repairs or upgrades on the ramp. Terry Brady said that Frank Little has been working with the borough every year to be sure that the grant application is put together appropriately. Councilwoman Reynolds said that we need bike racks. She said she did a little research and they would cost approximately \$250.00. Then they talked about barriers, parking and the 100' line at the street ends. Councilman Wellington asked about the resolution regarding parking on Central Ave. that we forwarded to the county. I informed them that Pat, from the county called last week. Mayor Larson spoke to her and told her what the concerns were. Councilman Wellington said that we would have change zoning for every street in town. It would be a big job but he didn't see any reason why we couldn't because it would provide us with more parking. Councilwoman Reynolds asked how it ties in with the 100' line and Councilman Wellington said that if we were doing away with that 100' line, we could do the whole thing at the same time. That would give a couple more spaces at the end as long as it didn't interfere. Councilman Mikuletzky suggested more handicapped parking on some of the streets. Councilman Sharpless asked we needed to keep the 100' line for emergency vehicles. He also said that he would call Frank Little and ask about the line and the block grant money.

Terry Brady wanted to take a moment to express his thanks for his appointment. The appointment is never taken for granted. He said that he greatly appreciates the confidence and support that he has gotten from council for over 20 years.

Councilman Warr said it was the end of caucus.

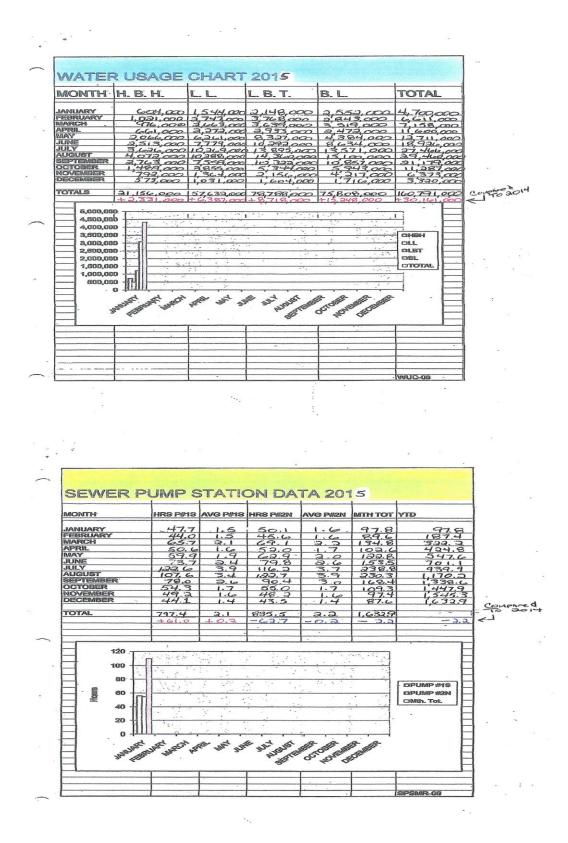

PUBLIC WORKS: Councilman Sharpless said that DPW was busy. He proceeded to breakdown the hours that was spent on each area. Boardwalks took up a lot of hours. He stated that they were up to 15th Street. Councilman Sharpless said that he would be having a Recreation Committee meeting within the couple of weeks. He polled the room and asked how many people would be in favor a concert on the 4th of July. Tim Brindley said he thought it was a good idea. It seemed to be favored by most. Councilman Sharpless said that the parade would be on Sunday.

DOCKS AND HARBORS: Councilman Wellington stated that the ramps and docks are closed for the seasons therefore there's not much to report. He said we are busy getting the boat slips rented for next season.

BEACHES AND PARKS: Councilwoman Reynolds said that no preseason badges were sold yet but 197 holiday badges were sold which was 56 more than last year. She told the audience to purchase your badges before June 10^{th to} take advantage of the preseason prices. She stated that we are starting the budgeting process and if anyone had ideas for the beaches or the parks. One thought has been bike racks and if you can think of anything other improvements please let us know.

FINANCE: Councilman Warr said that bills for the month were \$327,127.86. \$130,000 went to the Southern Regional School taxes. He stated that he wanted to hold a **Budget Workshop on February 10, 2016 at 3:00**.

PUBLIC SAFETY: Councilman Mikuletzky said the Chief of Police said that if you are going away for the winter that you could sign up to have your house checked. He said that you could also sign up for Nixle reports. You could get information on storms and other important information.

COMMUNITY DEVELOPMENT BLOCK GRANT 1st HEARING:

On a motion by Councilman Sharpless, seconded by Councilman Wellington and carried by all the CDBG Hearing was open to the public.

Councilman Warr said we talked about the block grant in caucus and the 9th Street ramp seemed to be the project that we want to use the block grant funding for. Tim Bindley asked if we were using a composite material for the reconstruction and it was confirmed by Councilman Sharpless. Councilwoman Reynolds asked if we needed an alternate plan. Tim Brindley said that he like the little alcove that's about half way up and he was told that nothing would change. There would be better accessibility for the handicapped because of the new decking and railings. Councilman Warr asked if the public had anymore comments or ideas and there were none. On a motion by Councilman Wellington to close, seconded by Councilman Sharpless and carried by all, the CDBG Hearing was over.

OPEN PUBLIC SESSION: On a motion by Councilwoman Reynolds, seconded by Councilman Sharpless and carried by all, the public session was opened. Tim Brindley wanted to address the 100' buffer. He didn't think it would be good to use this area for parking. He stated that he felt it was there for a reason such as bikes, ice cream man, ambulances and fire trucks. He suggested if we were going to try it, perhaps we just try it on one street to see how it plays out. He suggested the higher streets like 22nd, 25th and 29th where there's more impact. John Tennyson from 22nd Street applauded Councilwaman Reynolds for her idea of bike racks especially for 22nd Street because that is the street that the Life Guard in Training huddles to. He said that several times a week there are a number of bikes up there and their all over the place. He asked for council to continue to look into that. With there being no further comments, on a motion by Wellington, seconded by Sharpless and carried by all, the public session was closed.
