Scott Sharpless brought up a meeting they had and decided to ban smoking on our beaches. Signs would be put up. He said the lifeguards could help with enforcement. People throw their butts on the ground. He said he would like to do something about it. The Governor left it up to the municipalities. Dottie said what if we did it within the swimming area. People could go and sit up by the dunes if they really needed a smoke. George said he feels it will create a worse situation. We will do an ordinance on first reading this evening by title only. Scott and Michael think other beach goers will help enforce. Also Cleaning of our beaches with a beach rake was discussed. We do not intend to do this. Shells on the beach keep our beaches together. DEP has told us we are not allowed to rake the beach in the summer due to plovers. Dottie said she gave everybody a copy of the trap, neuter, return ordinance to read.

Animal control can help us more if we have this ordinance. Mayor wondered what studies had been done on neutering of the cats. Dottie said they have sterilized hundreds of cats. The kittens go to foster homes. George does not like the return part. The adults can't go out for adoption. Scott said the turtles are out like crazy! Ed Wellington said if you capture an adult you become the caretaker for that adult. Dottie said that is true. George said you can have a problem with people having too many cats.

Kirk said we have Great Bay Dredge working out of 16th Street street end. He threw them out the other day when they were pumping fuel. He said he thought they would buy fuel locally. However they cannot do this. Mike asked if they had been paying. Kat just invoiced them. They are going to be here for a whole year.

PUBLIC SAFETY: Frank Mikuletzky said three people have been chosen to go to the nationals. This is in the fall. The races will be in Barnegat Light this summer. There is a bin to drop off used clothing in the

recycle yard. The police will receive \$6000 annually from American Recycling. Lock your doors on your house and cars.
