MAYOR AND COUNCIL MEETING BARNEGAT LIGHT JUNE 11, 2014

THE CAUCUS MEETING of the Mayor and Council was called to order by Mayor Larson at 4:30pm at the Borough Hall, on East 7th Street. He stated that adequate notice of this meeting has been provided in accordance with the New Jersey Open Public Meetings Act by posting a copy of the notice of this meeting on the bulletin board in the Borough Hall on January 7, 2014 and by mailing a copy of the notice to the Beach Haven Times and Asbury Park Press, newspapers designated by Mayor and Council on January 7, 2014, to receive such notice, and by filing a copy of the notice with the Borough Clerk on January 7, 2014.

The Mayor asked if anyone had anything for caucus. Frank Mikuletzky said he wanted to talk about the bus. Mayor said there was a gentleman from 19th street who planned to come to the meeting. Ed Wellington wanted to know what the story was with the conversation Mayor Larson had with Mayor Mancini about the cost. Mayor Larson said we have the funding and will decide what to do. It wasn't the Mayor it was Commissioner Latanzi. So we are going in on the bus but we are not paying until later. Mayor Larson said he is meeting with the Mayor of Beach Haven who wants to send more people to Barnegat Light. Ed Wellington said he thought the Mayor was talking to Barry on 19th Street. Ed said he talked to him earlier. Maybe he will be here at 5:00pm. Mayor brought up overgrown properties and what we should and can do about same. What do you want to do about that? We can send a letter first and go from there. Frank mentioned there are spots in town on different streets where trees are hanging out over the street. On East 11th street there is a problem. 10th Street right next to the playground is another spot. Gail said in the past the police used to go around and give us a list of bad corners. Maybe they will do that again. Frank will ask the Chief or Paul Verbe. Frank asked when do we want the lights on in town. George said turn them on as late as you can and off as early. Right after Labor Day we want to turn it off. Dottie said she had a couple of complaints about loose dogs and dogs on the beach. Gail asked if Dottie had gotten the pictures of many piles of dog droppings at the dog park. Dottie said she did not. Dottie said she made a nice little sign. Scott said people let their dog in and just go away. (Like to the Post Office). Or they let them in and just sit in the car. So much for the nice little sign! Mayor said we should get the Police ATV on the beach before and after the guards for dog patrol. Scott said a dog peed on him and his backpack when he was at the beach with his boys. The owner was not concerned. Gail asked Frank if the police were indeed going to lock the dog park. George asked Terry about Segways. Terry said there is no state law against them, and the town could make a lot against them if they wanted. They do not want to. The people who asked have been told they can ride them. Mayor asked about the pictures on the dog park and did we decide what we are doing. We did tell Cricket she can hang some in the Children's Playground as well. The Bay Beach Train is being shipped on June 16. We already have the mats down. Scott said it should be easy to put together according to Ed Sulecki. Scott mentioned bikers going the wrong way against traffic. It is a big problem on the boulevard. Frank said he has always been in favor of single file bike riding. Dottie wanted to make no parking at the south end of town on the boulevard. Scott thinks it is safer for pedestrians for cars to ride in the left hand lane. On a motion by Wellington, seconded by Sharpless and carried by all there was a 10 minute break in the meeting.

COMMITTEE REPORTS:

WATER/SEWER: Michael Spark was absent so the Mayor asked that the water/sewer report be made a part of the minutes.

PUBLIC WORKS: Scott Sharpless said they have been really busy. Installed the new beach signs. The Post and Rail fencing at the dock. Cleaning up the boardwalks sporadically. They repaired and rebuilt 2/3 of the 28th street walkway. Installed all the roll up walkways that Dottie has had up to this point. Trashcans are out. Turned on and repaired water at the docks. Dock repairs are done. They cleanup a dumpster full of trash off the beach - logs, and sticks. Train for kiddie beach is being shipped on the 16th. Guard house repairs, refurbished the tram. That was in a state of disrepair. They are moving along. Temporary summer guys are here. They can start concentrating on cutting lawns and running dune fence. Dine Fence was put in on the bay beach on the swimming area. July 5 is the Fourth of July Parade. Line up at 6PM and 6:30 start from 11th Street Post Office Area. Concert afterward and trophies for the kids who decorate their bicycles. There is no theme. Half of the people would do the theme and half would not so no theme - just red, white and blue.

DOCKS AND HARBORS: Ed Wellington said we are up \$780.00 at the ramp. Ed

had been lamenting the bad weather and now it is looking up. The great striper season and some better weather brought us up.

BEACHES AND PARKS: Dottie Reynolds will be opening this weekend. The guards are hired. The guard house is filled. The landscaper that has been donating his time there is doing some more improvements to the property. The walkways are all installed. Unfortunately we are still not selling enough beach badges. Remember to get them by the 15th. The price will go up \$10.00. We are still \$8,979.00 behind last year. She asked Paula for figures from years before because she thought it was the Holiday Sales that made a difference, but each year the Holiday have gone down. The tennis fees are the same as last year. \$850.00 for tennis fees. The police will be enforcing dogs running on the beach. The guards are good during the say but before and after they go on is the problem. If you have any concerns let us know at the open public session. Have a good summer. Brenda designed the badge for holiday this year and will do it again next. Scott said she is also working on something for the participation medals we give out at events. Something more appealing to kids. Gail explained that Brenda is our Tax Collector and is a wonderful artist and crafter.

PUBLIC SAFETY: Frank Mikuletzky said that 3 of the 4 summer cops are trained as EMT's. That makes about 20 of the police who are EMT's. They are also equipped with Narcon - the heroin antidote. Phone and computer and contractor fraud are going on. Be aware of it. Deal with people you know. The lights will be going on the 19th. People cross on green lights in the crosswalk and you should not stop - it can cause accidents. You must be very careful. It is against the law for people to cross on green. He wanted to alert people to the proper way to stop at the firehouse. When the truck is coming in or out there are two white lines that go out on an angle. If the truck is in that area -STOP. Everybody has to stop - walkers, bikes, cars, etc. whether there is a fire police person there or not. Mayor mentioned a 4 foot rule for bikes and pedestrians. Your car may not come within 4 feet of either. How do you feel about driving through Harvey Cedars? Let alone drive through Surf City. Mayor made himself clear to the powers that be. It is already a law in Pennsylvania. Election year coming up, the bicyclers have a big lobby and it will probably end up going through. You thought stopping for somebody in the cross walk - wait till this happens.

FINANCE: George Warr said light month with bills. Second month in a row more money stays in Barnegat Light.

OPEN PUBLIC SESSION:

On a motion by Reynolds, seconded by Sharpless and carried by all the public session was opened. Tina Harrison from LBI Xxpress Taxi Service and she wanted to talk about the free shuttles. She felt it would cost the towns a lot of money. She heard there was some kind of service agreement that the towns have been asked to sign. She just wants to know how this brings revenue to your town. Mayor said we do not know. She has her taxi service for 4 years and they are very successful with what they do. It is a great door to door service. Who is really paying for this? We have not put any money in yet. We have money aside for it but have yet to decide. She said she has been to the Chamber Meetings so far and unfortunately Mancini and Latanzi were not there. She has a lot of hard questions about the ramifications. They are supposed to be running under Emergency Management Vehicles and shuttle people around to dinner and back. She said she did not understand. She said it is all on the municipality if someone gets hurt. Kat Flanagan said that Tina's

questions want to be proposed to Long Beach Township. They are the ones who are heading this up. You need to address them at their council meeting. They are the ones who have all the rules that went out and met with the Joint Insurance Fund. Go to their meeting and the rest of the info you can get from their municipal clerk. Scott said we have had a lot of concerns and reservations and that is why we haven't acted on this year. We are taking a look and see attitude and our questioning a lot of things that are happening. She said she spoke with Trolley Tour Owner. He said he does not make a whole lot of money on LBI. He does mostly weddings and things like that. She said herself and 3 other taxi Companies that are on this Island operate from 10:00am until 5:00am 7 days per week. She said she also operates by appointment. Airport runs, etc. Mayor asked if it would totally put her out of business. She said that last year when they had the trial run she said they were wondering where their dinner runs went. It was hard to judge because Hurricane Sandy was still in play last year. We have 6 large vans and 9 drivers. Frank asked what the capacity of the vans is. 10 people. She said they got a lot of calls from Barnegat Light last year. Mayor asked what they charge. Flat rate of \$50.00 from Barnegat Light to Beach Haven. 5 people or more it is \$10.00 per person. Ed Wellington asked is it her contention that this government operation interferes with your business. Yes it is. Dan Malay asked if he could ask Tina a question. There are assumptions that more people will leave Barnegat Light and assumptions that more people will come to Barnegat Light. She thinks more people will be leaving. Fran Puskas asked what is going on with the water tower. They are almost done. We make \$110,000 a year on the phone companies. Is there a limit of how many? Gail said yes 4 is the limit and that is what we have now. It has been a nice revenue for the last 10 years or so. They will be taking the temporary Tower down soon. Dan Malay said the Barnegat Light Tourism Coalition is hosting an event on July 14 called Discover Barnegat Light Day. Highlight what is going on. They want to have a raffle. Gail said they need a state ID to have a raffle. Would the town donate a couple of beach badges to them. Mayor said he didn't see why not. Dick Feehan asked about a refund overpayment to Corelogic is that the group working on the web site. Is there a final completion? It has been going on since the beginning of the year. Gail said it is coming and we are doing the best we can. Gail kept trying to explain to no avail. He said we should send someone out to learn how to do it. Dick wants current information. being no further comment, on a motion by Warr, seconded by Wellington and carried by all the public session was closed.


