THE CAUCUS MEETING of the Mayor and Council was called to order by Mayor Larson at 4:30pm at the Borough Hall, on East 7th Street. He stated that adequate notice of this meeting has been provided in accordance with the New Jersey Open Public Meetings Act. Notice of this meeting was posted on the bulletin board in the Borough Hall on January 4, 2017 and it was published on January 12, 2017 in the Beach Haven Times and the Asbury Park Press, newspapers designated by Mayor and Council on January 4, 2017 to receive such notice, and by filing a copy of the notice with the Acting Borough Clerk on January 4, 2017.

ROLL CALL: Sharpless, Wellington, Spark, Reynolds, Mikuletzky, Warr

The Deputy Clerk said that Mayor Larson was unable to attend. She said that Council President Spark will be running the meeting.

Also present: Kathy Guerrero, Deputy Clerk and Terry Brady

Discussion: Some things that were discussed were the Cub Scouts wanting to camp on the beach and the need for a fire permit, the YMCA is asking for free beach badges for a day trip, a beach wedding, and an upcoming flood map meeting. Councilman Wellington talked about flood maps and that Fema is starting the process over due to an out of court settlement with New York City after Sandy. Councilman Wellington brought up an issue regarding contractors using gas generators instead of power poles to supply their electric. He said that most of the year it's not a problem but in the summer months it is. Council President Spark discussed the installation of water meters with another town and that we were getting closer to working out the numbers and it will be approximately 1/3 of what the original projection. He said the Borough would be paying for everything except repairing the landscapes. He urged residents to find their meter pits. Council President Spark said that the ordinance regarding the building height was being tabled and would not be discussed tonight. It will not be acted on until after the Taxpayers Association meeting. Councilman Mikuletzky talked about the water tower camera. He was under the impression that there would be a 360 degree view but now it's only 180. Terry Brady said that the 1st resolution on the agenda was regarding Verizon Wireless. Verizon wants to install small boxes on the existing poles to improve cell phone service. Councilman Wellington said that the town wide yard sale will be on May 20th. Councilwoman Reynolds said that the LBI Garden Club put in all the landscaping around Borough Hall. She said that now they are requesting to put in a butterfly garden. She said the area and the size would be determined by the Borough. Councilwoman Reynolds said that TNR program is working because there has been a 75% decrease in calls to LBI regarding the feral cats.

Councilman Spark asked for a motion to close the Caucus. On a motion by Reynolds, seconded by Sharpless and carried by all the Caucus Meeting was closed.

COMMITTEE REPORTS:

FINANCE: Councilman Warr said that the bills for the month were \$613,258.61. He also said that the regional school taxes were \$14,117.00 and for the first time more money stayed in Barnegat Light than went out.

PUBLIC SAFETY: Councilman Mikuletzky said that summer is coming and the speed limits will be changing and the traffic lights will be on very soon. He said to be aware.

BEACHES AND PARKS: Councilwoman Reynolds said the beaches will be open June 10th. She said beach badges will be on sale at the preseason rate until June 9th. She said we are looking for an attendant for the BB booth. She said the LIT program still has a few openings. She reminded the audience about the need for entry cards for the dog park and the requirements. She the artwork is now hung in the dog park. She said that the tennis and pickle ball courts are now free to anyone having a seasonal beach badge and if you don't have a badge you can play tennis for \$10.00 per hour.

WATER/SEWER: Councilman Spark said he wanted to make the water sewer report a part of the minutes. He talked about the meter project and said it was getting closer. He said that residents should start exposing their meters.

PUBLIC WORKS: Councilman Sharpless said that the Memorial Day parade will be held on May 28, 2017. He said if residents want their driveways marked out they should call Borough Hall and DPW will mark it out.

DOCKS AND HARBORS: Councilman Wellington said that bluefish and strippers are in town. Ramp fees revenue is up from last year. He said there are 5 open boat slips. He said that at the north end of the public docks we have 6 floating docks and the most northern one has been replaced by a new commercial grade plastic dock that was put in for testing. It's wider and more stable. He said that it was the Boroughs intention to purchase 6 of them. Then he said that Great Lakes Dredging has taken responsibility for the rebuilding of the 16th Street bulkhead which is good news. Councilman Wellington then talked about the pavilion. He said that the drawings have been received from the structural engineer. The Engineer wants all the steel to be galvanized. The steel will have to be purchased, fabricated on site, and then sent out to be galvanized.

OPEN PUBLIC SESSION: Council President Spark asked for a motion to open the public session. On a motion by **Warr**, seconded by **Wellington** and carried by all the public session was open.

Bonnie Brodman, East 10th Street, inquired about the cliffs on the beach. Rich Brodman, East 10th Street, asked when the Beach Committee meetings were held. He also asked about the bay beach. Councilwoman Reynolds said that the bay beach improvements are being discussed. Marilyn Wasilewski, West 7thStreet, asked if the council has considered the impact of the traffic and the parking when the new pavilion is completed. Councilman Wellington and Councilman Sharpless talked about this issue. Mary Ellen Foley asked, with respect to the pavilion and the steel beams, is there a point where using the existing platform doesn't work and you would have to start over? Councilman Wellington said no and explained why. He said if the cost started getting too much the length of the building could be made smaller to cut costs. John Tennyson asked Councilwoman Reynolds when the bike racks are being installed. She said probably around Memorial Day. Mr. Tennyson asked Councilman Spark if a timeline could be placed on our website regarding the water meter project. Councilman Spark said that it was too early because we don't have a signed agreement. Keith Gross East 7th Street said he read about the possibility of raising the building height. He wanted to know what was driving that. He said it would take away the quaintness of the town. Council President Spark talked about this subject in depth. Barry Mescolotto, 19th Street, said that we should look at the ordinances in Harvey Cedars that deals with building height. He said that they had zones where you can go to 32' and zones where you can't.

Councilman Spark asked for a motion to close the public session. On a motion by **Warr**, seconded by **Wellington** and carried by all the public session was closed.

RESOLUTION 2017-073

RESOLUTION OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, GRANTING VERIZON WIRELESS THE RIGHT TO USE UTILITY POLES IN THE PUBIC RIGHT-OF-WAY, SUBJECT TO CONDITIONS.

WHEREAS, Cellco Partnership d/b/a Verizon Wireless, ("Verizon Wireless"), is a provider of commercial mobile service subject to regulation by the Federal Communications Commission; and **WHEREAS**, Verizon Wireless has entered into agreements with parties that have the lawful right to maintain poles in the public right-of-way, upon which Verizon Wireless seeks to use such poles erected within the public right-of-way in the Borough of Barnegat Light.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of the Borough of Barnegat Light, County of Ocean, State of New Jersey, as follows:

- 1. The Borough of Barnegat Light hereby grants permission to Verizon Wireless and its successors and assigns, to use poles erected by other public utilities that have the lawful right to maintain poles within the public right-of-way in the Borough of Barnegat Light, for the purpose of installing and maintaining small network nodes, subject to the following:
 - A. Verizon Wireless, and its successors and assigns, shall adhere to all applicable Federal, State, and Local laws regarding safety requirements related to the use of the public right-of-way.
 - B. Verizon Wireless, and its successors and assigns, shall comply with all applicable Federal, State, and Local laws requiring permits prior to beginning construction, and shall obtain any applicable permits that may be required by the Borough of Barnegat Light.
 - C. Such permission be and is hereby given upon the condition and provision that Verizon Wireless, and its successors and assigns, shall indemnify, defend and hold harmless the Borough of Barnegat Light, its officers, agents, and servants, from any claim of liability or loss or bodily injury or property damage resulting from or arising out of the acts or omissions of Verizon Wireless or its agents in connection with the use and occupancy poles located within the public right-of-way, except to the extent arising from the acts or omissions of Borough of Barnegat Light or its agents.
 - D. Verizon Wireless shall, at its own cost and expense, maintain and supply to the Borough and to all applicable other public utilities its commercial general liability insurance with limits not less than \$1,000,000 for injury to or death of one or more persons in any one occurrence and \$500,000 for damage or destruction to property in any one occurrence; Verizon Wireless shall include the Borough of Barnegat Light as an additional insured.
 - E. Verizon Wireless shall be responsible for the repair of any damage to paving, existing utility lines, or any surface or subsurface installations, arising from its construction, installation or maintenance of its facilities.
 - F. This permission shall apply to existing utility poles and poles lawfully erected by others only, and separate permission must be sought prior to the erection by Verizon Wireless of new or additional utility poles.
- 2. The permission hereby granted shall continue for the same period of time as the grant to the parties whose poles Verizon Wireless is using.
 - 3. That certified copies of the resolution be forwarded to Cellco Partnership d/b/a Verizon Wireless
