THE CAUCUS MEETING of the Mayor and Council was called to order by Mayor Larson at 4:30pm at the Borough Hall, on East 7th Street. He stated that adequate notice of this meeting has been provided in accordance with the New Jersey Open Public Meetings Act by posting a copy of the notice of this meeting on the bulletin board in the Borough Hall on January 4, 2016 and by mailing a copy of the notice to the Asbury Park Press, newspaper designated by Mayor and Council on January 4, 2016 to receive such notice, and by filing a copy of the notice with the Borough Clerk on January 4, 2016.

ROLL CALL: Spark, Sharpless, (absent) Wellington, Reynolds, Mikuletzky, Warr (absent)

ALSO PRESENT: Mayor Larson, Terry Brady, Brenda Kuhn

DISCUSSION: Dredging was the first topic of discussion. Someone wondered if the new gas tax would be used for this type of project. Councilman Wellington brought up the skate park. The council members decided to fix up the park that is in need of repair. They want Ed Sulecki to get a price for the repair of the park including the infrastructure so that the money can be budgeted for 2017. Don Miller, a skate shop business owner, was in the audience. He offered advice on making changes to the park. He left his phone number if anyone wanted to call him. Councilwoman Reynolds asked about the memory benches. She was told that we are not getting new ones but if there were blank ones in town there would be no objections of having someone adding a plaque. The tennis court was the next topic. The Council talked about making some changes. They talked about making it free, possibly requiring a beach badge, changing the fee and if reservations would continue to be taken. Mayor Larson asked for a motion to close Caucus Meeting. On a motion by Reynolds, seconded by Wellington and carried by all the Caucus Meeting came to an end.

THE MEETING of Mayor and Council was called to order by Mayor Larson at 5:00 at the Borough Hall on East 7th Street. COMMITTEE REPORTS:

PUBLIC SAFETY: Councilman Mikuletzky said that everything has been quiet with the Police and Fire Departments. He said that there is a problem with people not picking up after their dogs. He said that it an environmental issue because this is a fishing town. He went on to say that the Police don't want to enforce the

law regarding this because the fines could be as high as \$1000.00. He said that maybe the Taxpayers Association could bring awareness to the public.

BEACHES AND PARKS: Councilwoman Reynolds said that Public Works continuing to build the beach walkways. She said that there may be changes with the fees for the tennis courts. They could possibly be free with a beach badge. She said that pickle ball could also be included. She said that the skate park is closed for repairs. Councilwoman Reynolds said that the holiday beach badge were for sale for the upcoming season.

DOCKS AND HARBORS: Councilman Wellington said that the cooler weather may be responsible for an increase in ramps fees. He said that last month's totals were down by \$1000 and now the totals are up by \$800 compared to last year.

WATER/SEWER: Councilman Spark said that he wanted to make the monthly report a part of the minutes. He said that the water usage went down because the people are leaving.

PUBLIC WORKS: Mayor Larson said that Public Works did such a nice job on the 12th Street boardwalks. They filled in the swamp and they built a causeway out to the sand dunes and they did the same thing on 11th Street. Councilman Mikuletzky said that they have also done a heck of a job cleaning up the Boro yard. He said that everything is organized, the trucks are all lined up and everything is piled up nicely instead of just being thrown in there. Councilman Wellington said we have a great group of guys over there. Mayor Larson and all of the Council agreed.

FINANCE: Councilman Wellington said that the bills for the month were \$1,402,943.73. He said that \$1,051,440.57 paid County taxes and \$147,117.00 paid Regional School taxes.

OPEN PUBLIC SESSION: On a motion by **Spark**, seconded by **Wellington** and carried by all the public session was open.

Barry Mescolotto, 11 West 19th Street, said that he was at the committee meeting a few weeks ago and it looked like the consensus was if you buy a beach badge you can play tennis for free. He said that was real progress and it will probably increase beach badge sales. Councilwoman Reynolds asked if we should require beach badges for the skate park too and everyone seemed to think it would be a good idea. Councilman Spark asked what would happen if someone wanted a badge in December. Councilman Wellington said it's not worth it. The park is there for the kids. Councilman Mikuletzky said he was talking to other councilmen about the bay beach. He said the beach gets closed down a lot in the summer and was told that it only happened one time. Councilwoman Reynolds said that it was from people not picking up after their dogs and heavy rain that washes it into the bay. Kelly Phillips, 1009 Central Ave., asked how much of that is dog waste. She sees said that there are many feral cats defecating all over the place and the bay beach is a giant litter box for them. She said it is a real health issue. Jacques Richard, 1 West 22nd Street, said that he sees the feral cats a lot at night. Councilwoman Reynolds said that we are doing the Trap, Neuter and Return Program here. She said it was the best way to reduce the cat population. Since 2012 to 2015 we have had a 75% decrease between taking the kittens away and the spaying & neutering. Mayor Larson said that he would like to get money in the 2017 budget to handle raccoons. Barry Mescolotto said that the raccoons are very destructive. It's very expensive to get them out and to repair the damage. Mayor Larson said that there are 3 reserves that they can be taken to.

WHEREAS, the elimination of government collection programs has serious potential to cause an increase in illegal dumping activities and the release of environmentally harmful materials contained in CEDs, due to the lack of drop off opportunities provided by CED manufacturers; now, therefore, BE IT RESOLVED, that the Borough of Barnegat Light on this 9th day of November, 2016, calls upon the members of the Senate, General Assembly and specifically the Governor of New Jersey, to support Senate Bill S981 and Assembly Bill A2375 that would enable the continuation of government sponsored collection programs, free of charge to consumers and taxpayers, therefore, fulfilling the intent of the original law.

ORDINANCE 2016-012

AN ORDINANCE OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING THE BOROUGH ZONING CODE REGARDING STORAGE PODS.

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Barnegat Light, County of Ocean, State of New Jersey, as follows:

SECTION 1. Chapter 215 of the Borough Code of the Borough of Barnegat Light, entitled "Zoning," is hereby amended and supplemented to provide a new §215-13.1, to be entitled "PODS and temporary storage units," to provide as follows:

Chapter 215 ZONING

§215-13.1. PODS and temporary storage units.

A. Definitions.

PODS

Pods shall be defined as any temporary storage units which are the equivalent of trailers without wheels or of a lesser size and are typically used for storage or transport of personal property. <u>PERSON</u>

Individuals, partnerships, voluntary associations and corporations.

B. Permit required; Fee.

It shall be unlawful for any person to store, park or place any storage pod upon any residential property within the Borough of Barnegat Light without first filing for a permit with the Barnegat Light Zoning Department containing the information hereinafter specified and obtaining from such clerk made permit to do so, which shall be known as a Pod Permit. The fee for such permit is hereby fixed at \$50 for each issuance. Such filing shall be made at least 48 hours prior to the placement of the pod upon the property within the Borough.

- C. Restrictions on permits.
 - (1) Any temporary storage permit shall be issued for a duration not to exceed 90 days. Any such permit may be reissued for an additional 90 day period without additional fee but no further reissuance shall take place. In no event shall a pod remain upon a property within the Borough Barnegat Light beyond the time frame set forth within the permit. In addition, any pod situate upon property shall not infringe upon any setbacks mandated by the local zoning ordinance with the exception of front yard setback for pods which are placed in a driveway. There will be no POD's stored on Borough of Barnegat Light streets.
 - (2) The use of a pod for the construction or reconstruction of a home for the storage of materials related to that construction may be situated for the duration of the construction but any such pod for construction related purposes shall be removed within 30 days after the issuance of a CO/CA for the dwelling under construction.
- D. Display permit.

Each permit issued under this Chapter must be prominently displayed on the premises upon which the pod is located during the entire period the pod remains upon the property.

- E. Information to be filed.
 - The information to be filed with the Borough Clerk pursuant to this Chapter shall be as follows:
 - (1) Name of the person, firm, group, corporation, association or organization renting or owning the

pod who has responsibility for the placement and removal of the pod.

- (2) Name of the owner of the property upon which the pod is to be located and the consent of the owner if the permit applicant is other than the owner.
- (3) Location upon the property in which the pod is to be located.
- (4) Date upon which the pod shall be removed from the property.
- (5) Purpose for which the pod is to be placed upon the property.
- (6) Sworn statement or affirmation by the person requesting the permit that the information there and given his full and true and known by him or her to do so.
- F. Restrictions:
 - (1) There will be no double stacking of POD's
- G. Waiver of requirements.

Upon application by any bona fide charitable, educational, cultural or governmental institution or organization, the Mayor and Council may waive any or all of the requirements of this Chapter provided that the burden of establishing eligibility for such a waiver shall be on the organization applying for the waiver.

H. Enforcement.

This Chapter shall be enforced by Code Enforcement and/or the Zoning Officer or any other law enforcement entity having jurisdiction within the Borough of Barnegat Light.

I. Violations and penalties.

Violation of this Chapter shall be punishable as provided in Chapter 1, Gen.

Provisions

SECTION 2. This zoning regulation amendment has been initiated and approved by the Barnegat Light Planning Board, as required by N.J.S.A. 40:55D-23.

SECTION 3. This ordinance shall be filed in the Office of Ocean County Planning Board.

SECTION 4. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 5. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

SECTION 6. This ordinance shall take effect after second reading and publication as required by law.






