#### REGULAR MEETING OF MAYOR AND COUNCIL NOVEMBER 11, 2015

THE CAUCUS MEETING of the Mayor and Council was called to order by Mayor Larson at 4:30pm at the Borough Hall, on East 7th Street. He stated that adequate notice of this meeting has been provided in accordance with the New Jersey Open Public Meetings Act by posting a copy of the notice of this meeting on the bulletin board in the Borough Hall on January 5, 2015 and by mailing a copy of the notice to the Beach Haven Times and Asbury Park Press, newspapers designated by Mayor and Council on January 5, 2015, to receive such notice, and by filing a copy of the notice with the Borough Clerk on January 5, 2015.

# ROLL CALL: SPARK, SHARPLESS, WELLINGTON, REYNOLDS, MIKULETZKY WARR WAS ABSENT

#### ALSO PRESENT TERRY F BRADY, ESQ., MAYOR LARSON, KATHY GUERRERO, DEPUTY CLERK, KAT FLANAGAN, CFO, BRENDA KUHN, TAX COLLECTOR, ASHLEY DARMON, ASSISTANT TREASURER & ELAINE TOLLISON, ADMINISTRATIVE ASSISTANT

The Mayor asked if anyone had anything important that they wanted to talk about. He said he wanted to talk about the dog park. There are enough kids in town now and he feels it is time to bring the baseball field back and move the dog park outside the ball field in a fenced in area. The kids would get the baseball field without doing away with the dog park. Frank Mikuletzky said it could be used for flag football or something like that and the Mayor agreed it could be used for anything. He said comments could be heard during the open public session during the regular meeting. He asked if anyone agreed with him and thought it was a good idea. Michael Spark asked if the new park area would be big enough to handle the dogs in the summer, the Mayor said it would. Ed Wellington agreed, there is plenty of room. The Mayor also said Long Beach Township is opening a dog park so some of our volume may go there. He also mentioned the possibility of charging to use the dog park. Dottie Reynolds asked if reopening the baseball field would affect the helicopter landing area and the Mayor said it would not, the gate will just have to be moved. Dottie also asked if new trees would be planted where the dog park is going to be. The mayor said he was not sure, he was just bringing it up for discussion to see how everyone felt about making the change. He felt we should take care of our residents that want to play baseball, the dog park was only supposed to be a temporary thing. Dottie said it was a trial, it was a successful trial. The Mayor said he was thinking about getting a gate with a card swipe to charge for the use. He mentioned that there is a County dog park in Cape May and they charge \$40 for out of county and \$30 for residents. That would also be something to discuss.

The Mayor said there was not anything else to discuss except the Resolution for a Code Official. He asked if anyone had any problems with that, nobody did. He also mentioned the beach badge fees which were being passed with the adoption of the second reading of the ordinance.

He asked Terry Brady about the Resolution for the closed session and he said that was no longer needed.

Scott Sharpless said that there is a new Public Works employee and he is working out well. Public Works has been building boardwalks, the Mayor and Ed Wellington said they are really nice.  $23^{\rm rd}$ ,  $22^{\rm nd}$ ,  $21^{\rm st}$ , and  $20^{\rm th}$  Streets are complete as well as a third of  $19^{\rm th}$  St., they are doing about seven sections per day. Scott said the goal is to be done up to  $15^{\rm th}$  St. by the summer.

The Mayor asked Michael Spark about water meters. He asked if everyone

was in agreement to do water meters and Michael said yes. The Mayor said it would help with the sprinklers and that Harvey Cedars said their usage went way down because people realize how much water they are using. Kat mentioned the infrastructure trust loan and said the deadline passed for this year so it would have to wait until next year. Michael said we have the pits in. Kat said the loan gives a huge percentage. The Mayor said they could start with all new homes. Kat said they could pass an ordinance that is required and the Mayor said it would require all new homes to have a meter to get their CO. Michael said they would have to be sure it is the particular meter, they would have to have the brand and specifications before doing the ordinance. Kat suggested that the specifications not be put in the ordinance, in case they change later. She suggested saying the specifications have to be up from the construction office. Michael said the Borough would have to have a spec in hand prior to passing the ordinance. It was agreed that first reading should be in January. Michael said it is only going to state that the meter has to be installed, not include rates because they are not ready for that yet, that will all have to be established after some research is done. Michael said the town is about 95% pitted, the Mayor said the pits are the wrong size and will not fit the new meters. It is going to be a lot of money and Kat said an infrastructure plan will be needed. The Mayor said he would like to start with the ordinance to require the new homes to put in the new meter pits. The new meters will be through Wi-Fi and all meters will be read remotely and be run through our current system and Brenda can run reports each morning and see if there has been a water main break or any other problems. Frank Mikuletzky mentioned that the town should look into replacing waterlines any time a road is going to be repaved. The Mayor said the main road was just paved so they could not rip that up or awhile and Frank said that was the big one.

Mayor Larson then brought up overnight parking for trailers on all County roads and no parking for trailers between June 1<sup>st</sup> and October 1<sup>st</sup> on the County roads. We need to ask the County for permission to do this. The Mayor said we need to do a resolution to ask the County to consider it and then deal with the other parking issues over the winter. Michael asked if it would include RVs also, the Mayor said yes. Scott Sharpless brought up crosswalks from  $25^{th}$  to  $20^{th}$  Streets and that the Mayor said he spoke to the County Engineer. The Mayor said he & Ed thought that he was said at the Tax Payer's Association meeting that people did not want them. Ed Wellington said that they thought crosswalks were going to be put in on every street all the way down Central Ave. and they did not want that. Scott said it would only be between  $25^{th}$  and  $20^{th}$  Streets, the mayor said that would be fine and that it is just a matter of calling the County Engineer. Scott said they said they would do it but have not done anything yet. Scott said he would write a letter and the Mayor said he would call.

The Mayor Said the Tax Payer's Association is sending out their annual membership survey and said if the borough has any questions that they would like surveyed then they would include it in their survey. The letter will be mailed out in January.

With nothing further to be discussed at caucus a motion to end the caucus was made by Dottie Reynolds and seconded by Frank Mikuletzky and all were in favor.

#### BUILDING & ZONING REPORT:

THE MAYOR asked for a motion to approve the reports. Wellington so moved, seconded by Reynolds. MOTION: WELLINGTON SECOND: REYNOLDS VOTE: AYES: SPARK, SHARPLESS, WELLINGTON, REYNOLDS, MIKULETZKY NAYS: NONE ABSTAIN: NONE ABSENT: WARR

#### COMMITTEE REPORTS:

**WATER/SEWER:** Michael Spark asked to make the report part of the minutes. He said they had a discussion about water meters during the caucus, they are going to start pursuing it and learn as much as they can before they write the ordinance about new properties putting meters in at their curb so they will be in full compliance when the time comes.

**PUBLIC WORKS: Scott Sharpless** asked to make the Public Works report a part of the minutes. Public Works has been busy building boardwalks and shutting down from the summer, they have been working hard. The Mayor said there have been water leaks, a lot of overtime. There will be a fourth guy who will be officially hired at the meeting, he has been working for a couple of weeks now. Dottie Reynolds asked if the new meters will help with the leaks and the Mayor said they would.

DOCKS AND HARBORS: Ed Wellington said the ramp had another good month and is running at \$35,0000 in ramp fees to date, up about \$1420 over last year at this time. He said it was a great weekend last week and if the fish stay around they should do well. He said the liveries are coming up for re-bidding this year. At the request of both of the current livery lease holders, the lease is going to go from a three year lease to a five year lease. Michael Spark asked if anyone could bid on them, Ed said anyone can bid. The Mayor said the current lessees own the building and Ed said they also own the boats. He also said if someone else wins the bid then they would have to buy the building and boats from them or have them removed as Michael Spark added. Ed Wellington said that is the main reason that the current guys would like a longer lease, they would not be at risk every three years. The Mayor said they also need to get on the dredging.

**BEACHES AND PARKS:** Dottie Reynolds said they would be having the second reading of the ordinance to increase the beach badge fees at tonight's meeting. She also said that the Beach Committee will be meeting next week with the Lifeguard Captain and Lieutenant to work on schedules for next summer.

**PUBLIC SAFETY: Frank Mikuletzky** said the IRS scam is still going on, he reminded people that if they receive a phone call from the IRS asking for money, hang up and do not give them any information. He mentioned there are all kinds of scams going on and that it is important to be aware. He also reminded everyone that it is a good idea to register for Nixel alerts so they can receive text message for any alerts or emergency situations in the area. There will be no bicycle or pedestrian traffic on the bridge for awhile. There is a bus schedule which is available on the Borough's website and on the bulletin board at Borough Hall. The bus will transport bicyclists and pedestrians on and off the island. The Mayor mentioned another scam dealing with the warranty on your cars, again do not agree to anything over the phone.

#### OPEN PUBLIC SESSION:

On a motion by Sharpless, seconded by Reynolds and carried by all the public session was opened. Tim Brindley asked what the Master Plan is for the bridge for access across the bridge with a walkway, is it going to be on both sides? The Mayor said the plan is available online and Frank Mikuletzky said he was under the impression, from the meeting that he attended, that the walkway was going to be on one side and bicycle lane on the other side. The Mayor said he did see that in the newspaper last week. John Tennyson said the IRS scam information was put on the Tax Payer's Association's website and they sent it out on Nixel. He also asked the Mayor about two notes that the Tax Payer's Association had sent to the Mayor and Council. The first was requesting permission to put in a free library and they were hoping for an affirmative response and would answer any questions. Frank Mikuletzky asked if what they were looking for is a place to put it and approval and John said they were. It would be just one to start and if it worked they may ask permission later to put in a second one for children's books. Dottie Reynolds said she thought it would be a good idea and suggested putting it near the Post Office. John said that was their first thought and asked if it could be attached to the building or put it by the signboard. Dottie said it may also call attention to the library that is at Borough Hall. It was added that there are some people on the Board of the Tax Payer's Association who would like to come to Borough Hall and rotate the books at Borough Hall into their free library. Dottie asked if Council could do a voice vote so they could proceed, all members of Council were in favor. John added that they would provide immediate corrective action if there was any misuse. He also added that they will evaluate it in six months to see how it is going, if it is working, great, if not they will take it down. The second letter was asking Mayor and Council to think about a question that they would like asked of the residents as part of their annual membership drive. The Mayor said he may want to ask what the Borough should do with the Coast Guard property, but they may get too many varied responses. John suggested that there is ways to ask the question to narrow down the responses. The mayor said we would have to give the parameters of what

it could be used for and let the people know that they would not be able to ask for anything different. John said it is an option that is open to the town and would like them to take advantage of it. Anne Peavy asked if the Mayor and Council would consider what there is in town when deciding what to use the property for. She would like them to strike a balance between what already exists and what they decide to do there. She mentioned how wonderful the concerts are and how beautiful the the sunsets are during the concerts at the Bayview gazebo. She suggested making the open space a Veteran's Memorial, a quiet, tranquil park. The Mayor said at this time no decisions are being made, first the buildings and parking lot needs to be removed and they are in the process of getting prices for that. Scott Sharpless said that the concerts are getting bigger and it is becoming a safety issue because people are going into the street and moving the concert area to the property would be much better and it would only be about seven nights during the summer.

Mary Ellen Foley, East 10<sup>th</sup> St., had two questions. The first question was in regard to the water meters, she said she lives in a two person house with a lot of bathrooms, she asked if there was a way to do a balance between how many people live in a house and how many spigots they have. The Mayor said the bill will only be based on usage, spigot counts will be eliminated. Her second item was a comment about the dog park, she felt that people with big dogs may object to moving the park because the area is not big enough. The Mayor said they are going to do the baseball field and they will work with the area for the dog park. She then asked if they could make a section for small dogs and one for large dogs. The Mayor said he did not see a problem with doing that. Tim Brindley spoke about the Mayor's comment about possibly putting a

bathroom in at the new property, the Mayor s comment about possibly putting a bathroom in at the new property, the Mayor said they were thinking about it because they are probably going to have the concerts there. Tim said he thought it would be good to do that along with some benches and then just let the property find its own use. He also brought up the dog park and the Mayor said the town does not have a recreation area because it is being used as the dog park. Tim said the dog park has become a social area as well, the Mayor said he understood and that and the dog park is not going to be taken away, just moved.

Michelle Wellington, west 12<sup>th</sup> St., thanked the town and the Public Works guys for the beach walkways. She also talked about putting in the crosswalks, she asked if it would necessitate a sign at every crosswalk. The Mayor said no, the town controls that.

Being no further comment, on a motion by Wellington, seconded by Reynolds and carried by all the public session was closed.
