

REGULAR MEETING OF MAYOR AND COUNCIL September 14, 2016

THE CAUCUS MEETING of the Mayor and Council was called to order by Mayor Larson at 4:30pm at the Borough Hall, on East 7th Street. He stated that adequate notice of this meeting has been provided in accordance with the New Jersey Open Public Meetings Act by posting a copy of the notice of this meeting on the bulletin board in the Borough Hall on January 4, 2016 and by mailing a copy of the notice to the Asbury Park Press, newspaper designated by Mayor and Council on January 4, 2016 to receive such notice, and by filing a copy of the notice with the Borough Clerk on January 4, 2016.

Also present: Mayor Larson, Terry Brady, Brenda Kuhn and Nancy Manookian

Discussion: Councilman Wellington said that he followed up on the discussion about storage containers from the previous meeting. He said that he was unable to find ordinances from other towns on the island that pertained to PODS. He said that when you expand the search beyond the island a lot of towns have them. He said they exclude detached permanent buildings such as garages and sheds. He said that the various ordinances that he researched referred to these storage containers as nonpermanent structures that were originally designed for another purpose. These structures include cargo containers, railroad cars, bus bodies, converted mobile homes etc. He stated that most of the ordinances stipulated what zones they can be in and that they always require a permit. In addition to that, most of them require the structure to be anchored to the ground, to meet property setback requirements, no stacking above the height of one container, and not used for advertisement purposes. His research showed that the container must be on the same property as the principal use building and cannot occupy street parking. There are also restrictions on the time frame in which the container should be removed. There was more discussion on this issue. It was decided that it was a land use issue and should be handled by the Planning Board. The next topic that was discussed was dead trees and if the problem is Southern Pine Beetles. Mr. Howe has brought it to our attention there is a \$24,000 grant available for Southern Pine Beetle and the work must be completed by December 31, 2016. Mayor Larson asked if anyone has played pickle ball yet. There was talk of possibly making more courts. Mayor Larson asked council for support on an issue that President Obama was putting into place. He wants to dedicate an undersea range of canyons and peaks of the eastern seaboard as the country's first Atlantic marine national monument. This will affect commercial fishing activity.

Mayor Larson asked for a motion to close Caucus Meeting. On a motion by **Wellington**, seconded by **Reynolds** and carried by all the Caucus Meeting came to an end.

COMMITTEE REPORTS:

WATER/SEWER: Mayor Larson stated that the water/sewer report would a part of the minutes.

PUBLIC WORKS: Councilman Sharpless stated that Public Works has been very busy shutting everything down. They took the Kiddie Beach fence down and then they will be taking down the rollup walk ways. The installation of boardwalks will begin soon. They will start on 12th Street. Then they will do 11th and 10th Streets and then go to the south end of town. Councilman Sharpless said that he wanted to thank Scotty Caffrey for doing a phenomenal job handling the Beach Wheels all summer long. It freed up PW to do a lot of other jobs. Councilwoman Reynolds asked if beach wheels were still available and was told yes. Councilman Sharpless said that the dune grass planting was going to be October 8, 2016 if anyone was interested in helping. It will be on 25th Street at 9:00am. He said that three school groups would be coming during the week to plant.

DOCKS AND HARBORS: Councilman Wellington said that the dock fees revenues were at \$33,000 so far which is \$1000 less than this time last year. He said maybe when the Strippers come it may come up. He said that he followed up on the dredging project that was put on hold because of the freezing of the transportation trust fund projects. Mayor Larson said maybe we could get an emergency permit to do the Coast Guard Station. Councilman Wellington said we have to get it done before the end of the year or we have to wait until next September. He suggested calling the Lt. Governor.

BEACHES AND PARKS: Councilwoman Reynolds said revenue for beach badges were up this year. The prices were increased this year but the numbers of badges sold were also increased in all types of badges with the exception of seasonal. She said that there has been a lot of complaints regarding shells on the beach. She said that there has been a lot of tire tracks on the beach. Tennis fees were down. She said that the pickle ball court is very popular. She stated that the card reader would be installed on the dog park in the fall.

PUBLIC SAFETY: Councilman Mikuletzky said that there was a change in the Long Beach Township Police Chief. Michael Bradley has left due to an illness. The position had been filled with Captain Deely.

FINANCE: Councilman Warr said that the bills for the month were \$810,116.59. He said that \$147,117 was for the regional school tax and \$109, 292 was for the local school tax.

OPEN PUBLIC SESSION: On a motion by Sharpless, seconded by Mikuletzky and carried by all the public session was open to the public.

Mickey Spinelli thanked the Mayor and Council for providing the pickle ball court. Mayor Larson asked what should be charged for using the court. Mr. Spinelli said that one town on the island requires a beach badge. Mary Ellen Foley, 6 East 10th St., said that she felt it would become very popular. She said she didn't know much about it but now she owns two sets of rackets. Mickey Spinelli offered her instruction if she wanted it. Jacques Richard of 1 West 22nd Street said that he left branches out on June 9 and returned on September 9 and they were never picked up. Mr. & Mrs. Richard said that there was an ice cream truck from Black Eyed Susan's that was parked in front of their house for about two weeks. He talked to the police but the truck is still there. Apparently it was broken down. Barry Mescolotto, 11 West 19th Street, discussed the increases in tennis fees. He said the fees were \$8, \$10 and then they were raised to \$12 which was the tipping point. He said that most other towns don't charge for tennis and he felt it should be knocked down to \$10. Mayor Larson said how about \$8. Councilwoman Reynolds said that she would bring the topic up at the Beaches and Parks meeting. Mr. Clay Howe, 1407 Seaview Ave. was at the meeting to discuss the problem with the southern pine beetle. He talked about the \$24,000 grant that is available for counties and municipalities to deal with the issue of the southern pine beetles. The work to get rid of affected trees must be completed by the end of the year. The dead trees are an issue especially with fireworks being set off in the summer. They could become a fire hazard. The Mayor and Council said that we would call the state to get all the information that we would need to possibly apply for the grant. The Council thanked Mr. Howe for bringing this matter to their attention. Connie Higgins asked Councilman Sharpless how far the boardwalks would be going on 11th Street. He told her that it would be just a little further that it is now. She said that 15th Street goes out really far and she was informed that some of that boardwalk would be removed. Councilman Sharpless said that some of the sections of boardwalks would have to be removed from 15th, 16th and 17th Streets.

AN ORDINANCE OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 76 OF THE BOROUGH CODE OF THE BOROUGH OF BARNEGAT LIGHT, ENTITLED "CONSTRUCTION CODES, UNIFORM," TO PROVIDE FOR HOURS OF OPERATIONS LIMITATIONS.

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Barnegat Light, County of Ocean, State of New Jersey, as follows:

SECTION 1. There is hereby created and established a new Section 76-20 of the Borough Code of the Borough of Barnegat Light, to be entitled "Hours of construction," is hereby to provide as follows:

Chapter 76
Construction Codes, Uniform

§76-20. Hours of construction.

- A. Days and hours. Construction and demolition activity, excluding emergency work, shall be performed as follows:
 - 1. Monday thru Friday:
 - a. After Labor Day thru June 30th : beginning no earlier than 7:00am
 - b. From July 1 thru Labor Day : beginning no earlier than 8:00am
 - 2. Saturdays : beginning no earlier than 8:00am
 - 3. Sundays : No construction activity shall be performed on Sundays, except by the homeowner beginning not earlier than 8:00am
 - 4. Stop time : construction and demolition activity shall be concluded no later than 6:00pm
- B. Exceptions. Exceptions may be made to this ordinance under the following circumstances:
 - 1. In case of urgent necessity in the interest of public health and safety
 - 2. The 6:00pm stop time may be extended for the contractor or homeowner to get the house under roof

SECTION 2. All ordinances of parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. This ordinance shall take effect immediately upon its enactment after second reading and publication as required by law

ORDINANCE 2016-010

AN ORDINANCE OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING THE BOROUGH CODE TO INCREASE THE 16TH STREET WEEKLY USE PERMIT FEE.

BE IT ORDAINED by the Mayor and Borough Council of the Borough of Barnegat Light, County of Ocean, State of New Jersey, as follows:

SECTION 1. Section 168-24 of Article V of Chapter 168 of the Borough Code of the Borough of Barnegat Light, entitled "Temporary Use of Public Right of Way," is hereby amended and

supplemented to provide a revised paragraph (6) of subsection A to read as follows:

CHAPTER 168.
STREETS AND SIDEWALKS
ARTICLE V
Temporary Use of Public Right of Way

§ 168-23. Permit required for temporary use of public right-of-way.

No person or entity shall use or occupy the street end of West 16th Street without first obtaining a permit from the Borough of Barnegat Light.

§ 168-24. Application for temporary street use permit.

- A. A person seeking issuance of a temporary street use permit shall file an application with the Borough Clerk, together with an application fee of \$50, setting forth the following information:
- (1) The name, address and telephone numbers (home phone number, work phone number and cell number) of the person requesting the temporary use permit.
 - (2) The name and address of any entity the applicant is representing.
 - (3) The proposed dates for the temporary use/occupancy of the public street, sidewalk and/or right-of-way.
 - (4) A diagram of the area of the street, sidewalk or right-of-way where the use/occupancy is proposed, along with any cross streets.
 - (5) The names, addresses, telephone numbers, blocks and lots of the property owners for each adjacent property on the street or portion of the street where the temporary use/occupancy is proposed.
 - (6) A temporary use fee of \$1000 per week or any part thereof. The application fee shall be credited toward the permit fee.
 - (7) A security deposit of 4 times the weekly use fee set forth above, which may be refunded upon the removal of all materials from the right-of-way no later than the date of the expiration of the temporary use permit.
 - (8) Insurance and indemnity.
 - (a) All applicants must provide a certificate of insurance specifically naming the Borough of Barnegat Light as an additional insured providing general liability, environmental liability, bodily injury and property damage coverage with minimum limits of liability not less than \$1,000,000, in a form and content approved by the Borough. The applicant may request a waiver of this requirement upon a showing of undue hardship.
 - (b) The applicant shall agree to indemnify, defend and the Borough hold harmless from and against all losses, damages, claims, liabilities and causes of action of every kind, or character and nature, as well as costs and fees, including reasonable attorneys' fees connected therewith, and the expense of investigation thereof, based upon or arising out of damages or injuries to third persons or their property caused by the acts, omissions or negligence of the applicant, anyone for whose acts the applicant may be liable, or any claims arising out of or in any manner relating to the activities permitted pursuant to this chapter to the extent permitted by law.
- B. Upon submission of an application for a temporary street use permit and acceptance of the appropriate fees, the Borough Clerk shall forward said application to the Borough Zoning Officer for review and approval, to assure that:
- (1) The temporary use/occupancy and location of the public street, sidewalk and/or right-of-way use/occupancy will not substantially interrupt or impede the safe and orderly movement of traffic.
 - (2) The temporary use/occupancy and location of the public street, sidewalk and/or right-of-way use/occupancy will not be likely to result in damage to persons or property nor cause serious harm to the public health, safety or general welfare.
 - (3) The conduct of the temporary use/occupancy and location of the public street, sidewalk and/or right-of-way use/occupancy will not interfere with the movement of fire-fighting equipment to such an extent that adequate fire protection cannot be provided to the Borough.
 - (4) Such other concerns deemed necessary in order to properly provide for traffic control, street and property maintenance and the protection of the public health, safety and welfare.
- C. If the Borough Clerk and Borough Zoning Officer determine that the criteria set forth herein are satisfied, the Borough may approve the permit application, with or without any special conditions which may be required.
- D. The Borough may waive the application and permit fees for municipal improvement projects.
- E. All such permits shall be nonexclusive, subject to the specific circumstances of the permitted use.

F. The Borough shall notify the Police upon the issuance of each such permit.

§ 168-25. Duties of permittee.

In addition to any duties of the permittee which are a condition of the permit as issued and any other obligations of the permittee delineated otherwise in this chapter, all permittees shall:

- A. Comply with all applicable laws and ordinances.
- B. Be responsible for the removal and clean-up of all materials, equipment, items, trash, garbage and debris from the street which is the subject of the permit prior to the expiration thereof.
- C. Repair and replace any damaged facilities, pavement, bulkhead or other structures.

§ 168-26. Revocation of permit.

The Borough shall have the authority to revoke any permit issued hereunder upon the violation of any of the standards for issuance as set forth in this Article, or in the event of circumstances endangering public health, safety and welfare, or for any other reason deemed appropriate by the Borough.

§ 168-27. Violations and penalties.

A violation of this chapter shall be punishable as provided in Chapter 1, General Provisions, §1-15.

All Borough Code ordinance numbering shall be in accordance with the above section numbers.

SECTION 2. All ordinances of parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. This ordinance shall take effect immediately upon its enactment after second reading and publication as required by law.

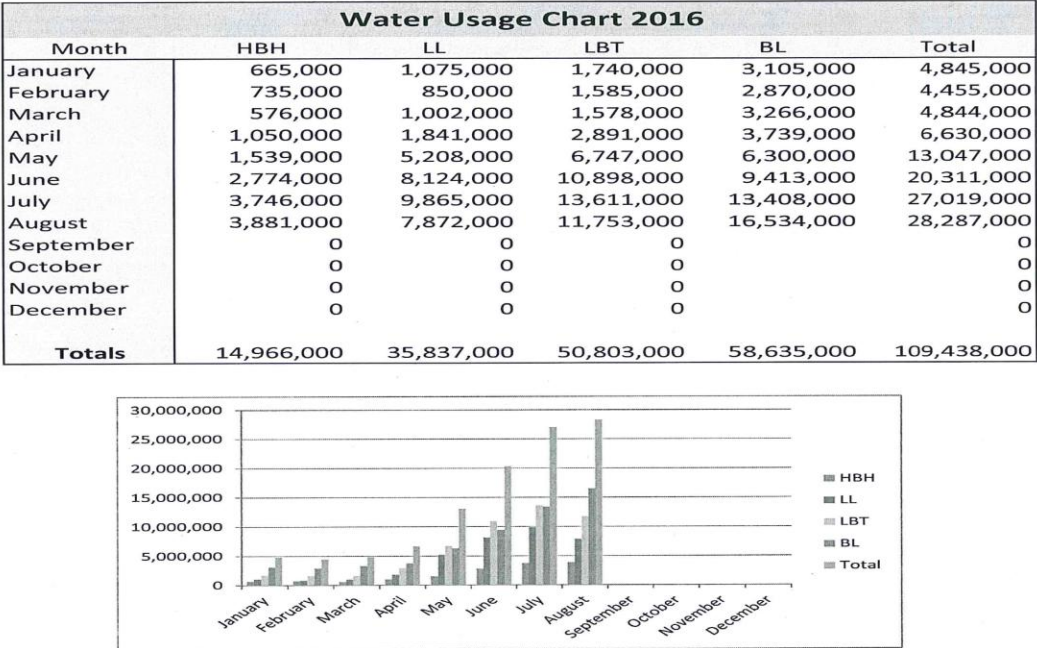

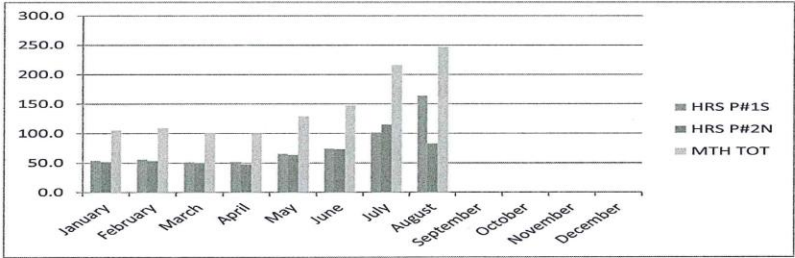
Councilwoman Reynolds said that Taxpayer Association meeting was on Saturday in the morning and it would be followed by the community beach party.

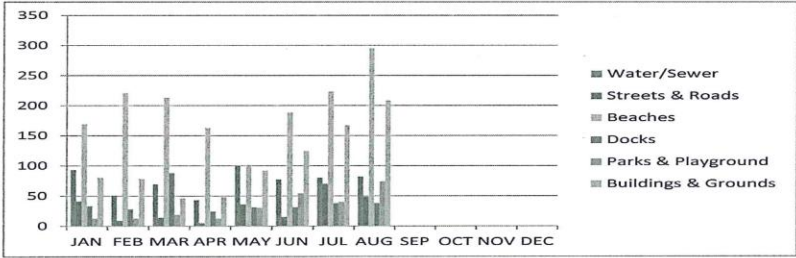
