THE CAUCUS MEETING of the Mayor and Council was called to order by Mayor Larson at 4:30pm at the Borough Hall, on East 7th Street. He stated that adequate notice of this meeting has been provided in accordance with the NJ Open Public Meetings Act. Notice of this meeting was posted on the bulletin board in Borough Hall on January 3, 2018 and was published in the Asbury Park Press on January 8, 2018 and in the Beach Haven Times, both newspapers are designated by Mayor and Council to receive such notice.

ROLL CALL: Spark, Sharpless, Wellington, Reynolds, Mikuletzky and Foley

Also present: Mayor Larson, Terry Brady, Elaine Tollison and Brenda Kuhn.

Discussion: Mayor Larson talked about the need for property owners to find their meters. He said that we would send a notice to owners with our next mailing telling them that the meters must be found. He said that we could mark them out but owners would have to find them or hire a plumber to do it for them and once found they must remain accessible at all times to the Borough.

There was talk about all the broken water pipes in town due to the cold weather and the warming.

Mayor Larson said that someone had inquired about using one of our bulkheads. Currently our ordinance only allows us to accept applications for temporary use of 16^{th} Street. He said that we were going to introduce an ordinance to add 4^{th} & 7^{th} Streets.

Mayor Larson said that we needed to come up with a name for the park and vote on it. The Clerk suggested that everyone come up with a name and bring it to the next meeting.

There was a discussion about pavers for the park and that we should introduce an ordinance at the next meeting to allow it. Councilman Sharpless asked if we needed to setup a Dedication by Rider account for this. They said that the CFO should look into the cost.

Councilwoman Reynolds said that the Taxpayers Association asked for the Borough to submit something for their January newsletter. She said that there were several projects going on and asked if each Chairperson could introduce their committee members and talk a little about their projects.

There was a conversation about the DEP putting a hold on issuing CAFRA permits until the new Governor gets in on the 16th or 17th.

The Clerk said that the CDBG was due in February. She talked with the Superintendent about the grant and he suggested using the money for the bathrooms at the park. There was discussion about the bathrooms.

COMMITTEE REPORTS:

FINANCE: Councilman Spark said that we spent \$239,156.21 out of our 2017 budget. He said that the Regional School tax was \$169,335 and the County taxes were 23,343.94.Councilman Spark congratulated the tax collector for having a 99.70 percentage of collection rate. He talked about the frenzy that was created by the new tax law. He said there was more than a million dollar increase in the amount of taxes collected in December 2017 compared to December 2016.

PUBLIC WORKS: Councilman Sharpless said that the Public Works employees were rock stars. He said there were a lot water pipe breaks and a lot of plowing. He said that they did an awesome job.

WATER/SEWER: Councilwoman Foley said that she wanted to submit the Water Sewer report a part of the record. She said that we need help from the owners in finding the meters. If owners can't find them they will be required to hire a plumber to find it for them. We will only mark out an estimate where it is located.

BEACHES AND PARKS: Councilwoman Reynolds said that we were selling holiday and preseason badges. She said that we are under by \$1200 but a lot of 2018 holiday badges were sold in 2017.

DOCKS AND HARBORS: Councilman Wellington said nobody has been putting boats in the water. He said we awarded a contract for the floating dock system and the construction has begun. He said that they should be completed by February and installed in the spring. Councilman Wellington talked about the progress at the pavilion. He said that the weather has slowed construction down. He said that the gables and dormers are done and the trusses were being supported from inside which is progress that you can't see. He said that the cupolas were being constructed today. Councilman Sharpless asked if the pavilion would be ready for the summer concert series. Councilman Wellington said he thought it would be ready but probably not the landscaping or pavers.

PUBLIC SAFETY: Councilman Mikuletzky said he would like to make the court report a part of the meeting minutes. He also said that it was a low crime month.

OPEN PUBLIC SESSION: Mayor Larson asked for a motion to open the open public session. There was a motion by Sharpless and carried by all.

Connie Higgins thanked Public Works for the good work on New Year's Eves Day. She said that there was a water main break on her street and the DPW worked like dogs in the cold weather and they got the water back on that day. She also recommended the *Best of the Eagles* for part of our concert schedule.

Barry Mescolotto asked if there was any plan for parking at the pavilion. Mayor Larson said that parking wasn't a problem there. He said there was plenty of parking. Mr. Mescolotto said that that it was a bigger venue and he was more concerned with people coming from out of town and signs would help.

Being no further public comments the Mayor asked for a motion to close the Open Public Session. On a motion by Wellington, seconded by Reynolds and carried by all, the open public session came to a close.
