He stated that adequate notice of this meeting has been provided in accordance with the NJ Open Public Meetings Act. Notice of this meeting was posted on the bulletin board in Borough Hall on January 3, 2018 and was published in the Asbury Park Press on January 8, 2018 and in the Beach Haven Times, both newspapers are designated by Mayor and Council to receive such notice.

**ROLL CALL**: Spark, Sharpless, Wellington, Reynolds, Mikuletzky and Foley

**Also present**: Mayor Larson, Terry Brady, Borough Attorney, Kathleen Flanagan, CFO and Brenda Kuhn, Municipal Clerk

**Discussion:** Mayor Larson asked Councilwoman Reynolds to start the discussion. She talked about the Beaches and Parks meeting that was held on January 30, 2018. She started with the lifeguard salaries. She said that there would be a \$10.00 increase for each step, EMT's & LIT instructors would be increased by an additional \$15.00 and the head EMT and head LIT instructor would be increased by an additional \$20.00. The Councilwoman said that using the councilroom of old borough hall was working out very well for the guards. She said that the emergency button should be removed and that she wants the former offices of Mayor and Clerk to be utilized by the guards to store equipment. She said that Scott would talk to Jim Lynch about the beach lender truck.

The Councilwoman said that the ceiling in the main room of the Guard house needed to be replaced and two ceiling lights should be added. Councilman Sharpless said he talked to DPW about this. She said that the guard house would accept furnishings and appliances that were in good shape if needed. She said that donations of paper products, supplies and bagels or donuts for the morning meetings would be accepted. She said the bay beach must be guarded at all times.

Councilwoman Reynolds said that one EMT responder would be designated each day and should only respond if no one else on the squad was available.

She stated that cell phone use while on the stands would not be tolerated and the guards will be fired immediately.

There was a discussion regarding beach badges for seniors, veterans and active military.

Councilwoman Foley said that she will have a meeting regarding water meters with the CFO and Marcel tomorrow. Mayor Larson asked what we would do with the deduct meters. He suggested using spigot count for sewer. The clerk said that the ones that don't go into the sewer would have their own because it would be cleaner.

Councilwoman Reynolds asked if everyone brought their suggestion for the pavilion park name. Mayor Larson said he likes Fisherman's Park. Dottie said she liked Lighthouse Park or Bayview. Someone suggested Bay Breeze Park.

The golf course is moving along but there was some drainage issues that are being addressed.

The Borough Attorney, Terry Brady read the statute regarding beach badges regarding seniors, disabled, active military service and families, National Guard and veterans that have been honorably discharged.

**Mayor Larson** asked for a motion to close the Caucus. On a motion by Reynolds, seconded by Foley and carried by all the Caucus Meeting was closed.

## **COMMITTEE REPORTS:**

**PUBLIC SAFETY: Councilman Mikuletzky** said he would like to make the court report a part of the meeting minutes. He said that the Chief suggested if residents go away that they can register with the police dept. monitor their home.

**DOCKS AND HARBORS: Councilman Wellington** said that the new boat slips should be delivered by the end of February or beginning of March. He said that the progress on the Pavilion has been slowed by the weather. Councilman Wellington said that the electrical materials contract was going to be awarded later in the meeting. He said that the restroom at the docks has been reshingled and it would be painted to match the other municipal buildings.

**BEACHES AND PARKS: Councilwoman Reynolds** said that beach badge sales were ahead of last year. She said that anyone with a season beach badge is eligible to use tennis and pickleball courts all summer. She said that improvements in the sand and the entrance gate would be made at the bay beach. She talked about dog licenses and the increase for weekly for the dog park passes and also for replacement cards.

**WATER/SEWER:** Councilwoman Foley reported that the total water usage was 8.6 million gallons of water was used for the month. She said that the letter regarding the water meters has generated a fair amount of interest.

**PUBLIC WORKS: Councilman Sharpless** said that Public Works had 78 hours of overtime in the month of January.

**FINANCE: Councilman Spark** said the boat slip revenue was \$21,000 which is up from \$14,700 last year. He said the town was booming because construction code fees were \$5200 last year at this time and \$15,000 to date this year. Councilman Spark said that the Auditor was busy preparing the end of year statement and then we will work on the 2018 Budget.

**OPEN PUBLIC SESSION:** Mayor Larson asked for a motion to open the open public session. On a motion by Spark, seconded by Sharpless and carried by all the meeting was open to the public.

Beth Mears Scolfield, Lighthouse Marina wanted to know where parking would be available and how it would be enforced on concert nights. Mayor Larson said that we have plenty of parking. He said that there were 21 spots across from the Coast Guard,13-26 spots where the old basketball courts were and there were another 50-60 spots down to Van's. Peggy said that people think the Marina is public parking. The mayor suggested putting up barrels with ropes or signs. The Mayor said let's see how it goes and we will address it. He said a lot of people ride bikes to the concerts.

Nick, the manager from Kubel's was also concerned about parking on concert nights. He said people try tailgating in their parking lot and they chase them. He said that their sales go down on concert nights by 10% which is significant because of the short season. The Mayor said that we could do an announcement at the concerts that any cars parked at Kubel's would be towed. Nick said that it is a bigger facility and has the potential to draw more people and didn't want to wait to see how it goes because the season is short. Councilman Sharpless suggested putting up signs on 6 & 7 Streets, Pavilion property, directing the people to park at the dock. He also suggested putting up Kubel's parking only signs. Nick said that the owner was putting up cameras. There was also a discussion regarding drinking at the concerts. He said according to ABC rules & regulations that if someone was drinking at the concert and walked onto the Kubel's property, Kubel's would be responsible. Terry Brady disagreed.

John Tennyson, on behalf of the Barnegat Light Taxpayers Association, thanked the Mayor and each Councilperson for submission to their winter newsletter. He said that it was very well done and extremely

well received.

Bike racks for the pavilion property were discussed. Councilman Wellington said we could purchase them through Buildings and Grounds.

CLOSE PUBLIC SESSION: Mayor Larson asked for a motion to close the open public session. On a motion by Spark, seconded by Wellington and carried by all the meeting was closed to the public.

## COMMUNITY DEVELOPMENT BLOCK GRANT 1st HEARING:

At 5:31pm the Mayor stated we were going to have a hearing regarding the CDBG.

On a motion by Councilman Foley, seconded by Councilman Wellington and carried by all the CDBG Hearing was open.

Mayor Larson said that he were going to talk about submitting an application to the Ocean County Community Block Grant. He said that the projects that we have submitted in the past have taken care of most of the needs for handicap access. He said that we were thinking about submitting the application to purchase Beach Wheels and Mobi Mats and asking for \$40,000. He said that some of our beach wheels are in disrepair and in the height of the season we don't have enough to go around. He asked the public if they had any better ideas and there were none.

Mayor Larson announced that there was going to be a 2<sup>nd</sup> Hearing on this matter on Thursday, February 15, 2018 at 10:00am

On a motion by Councilman Reynolds to close, seconded by Councilman Spark and carried by all, the CDBG Hearing was over.

NOW, THEREFORE, BE IT RESOLVED that the governing body of the the Borough of Barnegat Light hereby agrees as follows:

- 1. Become a member of the FUND for the period outlined in the Borough's Indemnity and Trust Agreements.
- 2. Will participate for Dental Coverage as defined pursuant to N.J.S.A. 17B:17-4, the FUND's Bylaws, and Plan of Risk Management.
- 3. Adopts and approves the FUND's Bylaws.
- 4. Execute an application for membership and any accompanying certifications

BE IT FURTHER RESOLVED that the governing body of the Borough of Barnegat Light is authorized and directed to execute the Indemnity and Trust Agreement and such other documents signifying membership in the FUND as required by the FUND's Bylaws, and to deliver these documents to the FUND's Executive Director with the express reservation that these documents shall become effective only upon:

- 1. Approval of the LOCAL UNIT by the FUND.
- Receipt from the LOCAL UNIT of a Resolution accepting assessment.
   Approval by the New Jersey Department of Insurance and Department of Community Affairs.

# **ORDINANCE 2018-01**

ORDINANCE OF THE BOUROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriations and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Borough Council of the Borough of Barnegat Light in the County of Ocean finds it advisable and necessary to increase its CY 2018 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Borough Council hereby determines that a 1.0 % increase in the budget for said year, amounting to \$ 19,639.37 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the Borough Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriations in either of the next two succeeding years

NOW THEREFORE BE IT ORDAINED, by the Borough Council of the Borough of Barnegat Light, in the County of Ocean, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2018 budget year, the final appropriations of the Borough of Barnegat Light shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5 %, amounting to \$68,737.80, and that the CY 2018 municipal budget for the Borough of Barnegat Light be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

AN ORDINANCE OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, INCREASING THE FEES FOR THE BOROUGH DOG PARK.

**BE IT ORDAINED** by the Mayor and Borough Council of the Borough of Barnegat Light, County of Ocean, State of New Jersey, as follows:

**SECTION 1.** Section 57-18.1 of the Borough Code of the Borough of Barnegat Light, entitled "Municipal Dog Park," is hereby amended and supplemented to provide revised subsection D to read as follows:

# § 57-18.1. Municipal Dog Park.

Proof of licensing and registration with the Borough shall be required annually. There shall be no fee for residents and homeowners, and there shall be a fee for nonresidents of \$30 annual fee or a weekly fee of \$15 payable to the Borough of Barnegat Light. Passes are not transferrable between owners. The annual keycards will expire on January 31<sup>st</sup> after the date of issue. Applications and passes may be obtained from the Barnegat Light Borough Hall offices weekdays from 8:00am to 3:00pm or the Beach Badge Booth when in operation. Lost or replacement keycard passes may be issued upon payment of a \$15 fee for the same.

All other subsections, paragraphs and provisions of Borough Code § 57-18.1 shall remain in full force and effect.

**SECTION 2.** All ordinances of parts of ordinances inconsistent herewith are hereby repealed. **SECTION 3.** This ordinance shall take effect immediately upon its enactment after second reading and

publication as required by law.

The Municipal Clerk read Ordinance 2018-02 by title. Mayor Larson asked for a motion to open the Public Hearing. On a motion by Sharpless, seconded by Foley and carried by all the Public Hearing was open.

# ORDINANCE 2018-03

AN ORDINANCE OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING SECTION 168-23 OF THE BOROUGH CODE, ENTITLED "PERMIT REQUIRED FOR TEMPORARY USE OF PUBLIC RIGHT-OF-WAY," TO ADD WEST 4<sup>TH</sup> & WEST 7<sup>TH</sup> STREETS.

**BE IT ORDAINED** by the Mayor and Borough Council of the Borough of Barnegat Light, County of Ocean, State of New Jersey, as follows:

**SECTION 1.** Section 168-23 of Article V of Chapter 168 of the Borough Code of the Borough of Barnegat Light, entitled "Permit required for temporary use of public right-of-way," is hereby amended and supplemented to provide as follows:

## CHAPTER 168.

## STREETS AND SIDEWALKS

#### **ARTICLE V**

#### Temporary Use of Public Right of Way

# § 168-23. Permit required for temporary use of public right-of-way.

No person or entity shall use or occupy the street end of West 4<sup>th</sup> Street, West 7<sup>th</sup> Street or West 16<sup>th</sup> Street without first obtaining a permit from the Borough of Barnegat Light in accordance with this Article.

**SECTION 2.** All ordinances of parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 3.** This ordinance shall take effect immediately upon its enactment after second reading and publication as required by law.

The Municipal Clerk read Ordinance 2018-03 by title. Mayor Larson asked for a motion to open the Public Hearing. On a motion by Reynolds, seconded by Foley and carried by all the Public Hearing was open.

John Alchus asked what this was about. Mayor Larson said that currently in our code book we can charge for use of bulkhead on 16<sup>th</sup> Street for loading or unloading of barges, etc. He said that we are adding 4<sup>th</sup> and 7<sup>th</sup> Streets to the code to allow us to charge a fee for the same purposes.

Being no further public comment, Mayor Larson asked for a motion to close the Public Hearing. On a motion by Wellington, seconded by Reynolds and carried by all, the public hearing was closed.
