REGULAR MEETING OF MAYOR AND COUNCIL February 8, 2017

THE CAUCUS MEETING of the Mayor and Council was called to order by **Mayor Larson** at 4:30pm at the Borough Hall, on East 7th Street. He stated that adequate notice of this meeting has been provided in accordance with the New Jersey Open Public Meetings Act by posting a copy of the notice of this meeting on the bulletin board in the Borough Hall on January 4, 2017 and transmitting a copy of the notice to the Beach Haven Times and the Asbury Park Press on January 4, 2017 which will be published on January 12, 2017 and January 18, 2017, respectively, newspapers designated by Mayor and Council on January 4, 2017 to receive such notice, and by filing a copy of the notice with the Acting Borough Clerk on January 4, 2017.

ROLL CALL: Sharpless, Wellington, Reynolds, Mikuletzky, Warr, Spark was absent, **Also present**: Mayor Larson, Terry Brady, Kathleen Flanagan, Edward Sulecki and Brenda Kuhn

Discussion: Mayor Larson discussed the possibility of raising the height limit on new construction from 30' to 32'. He said that it was already 32' in the Marine Commercial zone. He said that it was brought up at a Planning Board Meeting and they voted to bring it to Mayor and Council. It was approved unanimously. Councilman Wellington said in the past 20 years many people have come in to ask if they could raise their house one or two feet above the current 30' limit and were told that they couldn't do it. He said that if the Floodplain gets raised then at that time the height restriction should be address. Councilman Mikuletzky suggested just raising the limit in the low areas. Councilman Wellington said that we should see what the public thinks. Mayor Larson suggested that it could be put in the Taxpayers Association Newsletter. Mayor Larson talked about the crown of the road. He said people wanted their homes above the crown of the road. Terry Brady said he sits on the Planning Board in Lavallette. He said that the height restriction there is 28'above BSE, Base Flood Elevation, plus 2' of free board. This gives you 2 ½ stories. They do not use the crown of the road because that could change due to paying of the road. Councilman Wellington said that they should look at the difference of using the BFE versus the crown of the road and see what that would do with the whole town. Terry Brady said that he spoke to Frank Little's office and they said that we need to award a contract on the 2015 Streets Ordinance by June 24, 2017.

Mayor Larson asked to close the Caucus. All were in favor and the Caucus Meeting was closed.

COMMITTEE REPORTS

FINANCE: Councilman Warr said the bills for the month of January were \$1,324,117 and of that \$1,033,919 went to county taxes and \$14,117 went to pay regional school taxes.

PUBLIC SAFETY: Councilman Mikuletzky said that not much was going on. He said that a storm was coming. He said that the Nixle link was on the Boroughs website and the acting clerk said that it already was.

BEACHES AND PARKS: Councilwoman Reynolds said that beach badge sales were down from last year but it was probably due to the sales in November and December.

DOCKS AND HARBORS: Councilman Wellington said that there were 7 boat slips still open. He said that the engineer, the dock committee and he were doing the ground work for replacing the town slips sometime next year. There was an architects' model of a pavilion on the table. He urged everyone to take a look at it because that is what we intend to build on the old Coast Guard property. He said that he hoped that construction would begin possibly in April. Kat Flanagan asked what types of events would be held there. Councilman Wellington said that the concerts would be held there among other types of events.

PUBLIC WORKS: Councilman Sharpless said that most of the boardwalks are in now with the exception of 30th Street. He said that he was glad that that wasn't done because it would be covered by 3 feet of sand from the last storm. The kiddie park fence is now in. He said that there are some major cliffs on the beach from 14th Street to the inlet. He said if you see anyone digging holes, tunnels, etc. please tell them to stop. It is a safety issue. We put a warning on the website and in the Post Office.

WATER/SEWER: Mayor Larson said that the water/sewer report would be a part of the minutes.

OPEN PUBLIC SESSION: Mayor Larson asked for a motion to open the public session. On a motion by **Sharpless,** seconded by **Wellington** and carried by all the public session was open.

Tim Brindley, 1404 Bayview Avenue, said that today is the 110th anniversary of the Boys Scouts of America and over 100,000 kids that have gone through the organization. Councilwoman Reynolds said that he was doing a great job as scout leader. He also asked about the Peddlers ordinance. John Tennyson, 6 West 22 Street, said that he liked the idea of the "pavilion". He said that it was a wonderful addition to that area. He suggested using as much synthetic product so that it would last for 30 or 40 years. He said it would be a wise investment. Mr. Tennyson asked if council had anything that they would like to include in the Taxpayers Associations survey which will be done online. Mayor Larson said he would like a question added regarding increasing the building height limit from 30' to 32'. Mr. Tennyson asked how it should be worded. He was told that they would get back to him. Arlene Morrison, 23 West 8th Street, was at the meeting to discuss the Peddling and Soliciting ordinance. She asked council to consider raising the current fee, issuing a maximum of 3 permits per year, and enforcing the current ordinance in regards to the trucks not being able to sit for more than five (5) minutes. Ryan Kelly said that he agreed with Arlene Morrison. He said if a lot of trucks came into town it would be a problem and felt that we should be in compliance with the rest of the island. Councilman Warr said that he didn't think the 5 minute limit was enforceable. Ms. Morrison said that maybe raise it to 15 minutes. Councilman Sharpless talked about the ice cream trucks that came to the concerts last year. He said that the clerk called the vendors and told them they were not allowed to sit at the event. He said that there were complaints of them sitting there with the exhaust bothering everyone. Mary Ellen Foley, 6 East 10th Street, wanted to know why the current ordinance was put into place and why the ice cream trucks couldn't sit there at a concert. She felt that is would make sense to let them be there during an event. Councilman Wellington said that the ordinance was in place long before we had concerts and it was put there to keep the trucks moving. Ms. Foley said it would make sense to let them sell ice cream at an event. Councilman Wellington said he could support restricting the number of vehicles in town. He said he thinks it is self controlling because there's not enough business here to get 10 ice cream trucks. He said he doesn't support raising the fee. He said that if we raise the fee maybe no one would want to come here to sell ice cream. Mayor Larson said that it would be a disservice to the town if we raised the cost and lost the ice cream vendors that we do have. Ryan Kelly said he felt the fee should be raised. The CFO said that technically we should be putting these permits out to bid. Tim Brindley said if the 6pm curfew is put in the ordinance you might as well not even have an ice cream truck at all. Someone mentioned that we have set precedence for

bidding because we do that for our liveries. Terry Brady said that the liveries are a lease of land and that is done by public bid. He also said that in the past the boat slips were also done by bid but it was changed to permit so we didn't have the necessity of public bidding. Councilman Mikuletzky said there is a problem with the 5 minute rule in the ordinance because selling ice cream at the beach would take much more time. Tim Brindley asked if everyone knows that the beach badges are associated with the tennis courts and pickle ball this year and Councilwoman Reynolds said that that hasn't been determined yet. Councilman Wellington said we don't have a good process for that yet. Mayor Larson said that he thought that within the next month something should be done about the courts. Councilman Sharpless brought up the vendor permits again and said that he felt the fee should be raised. Mayor Larson said let's just limit the number of vendors and discuss the fee next year. Kevin Mimm, 16 West 9th Street, wanted to tell council that since there's a new gate on the dog park there is an increase in the unleashed dogs running on the municipal property outside the dog park. Councilwoman Reynolds said that we do have an ordinance prohibiting that and that's the reason that the dog park was put in. Mr. Mimm asked how that is enforced and he was told that it would be enforced by the police department. Mary Ellen Foley asked if there was a sign up because some people drive a distance to use the dog park. Connie Higgins, 10 East 11th Street, asked if anything would be done about the cliffs on the beach. Mayor Larson told her that they could be knocked down with a loader.

CLOSE PUBLIC SESSION: Mayor Larson asked for a motion to close the public session. On a motion by Wellington, seconded by Reynolds and carried by all the public session came to an end.

ORDINANCE 2017-001

ORDINANCE OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (*N.J.S.A.* 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, *N.J.S.A.* 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to .5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, *N.J.S.A.* 40A:4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Mayor and Council of the Borough of Barnegat Light in the County of Ocean finds it advisable and necessary to increase its CY 2016 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Mayor and Council hereby determines that a 3.0% increase in the budget for said year, amounting to \$ 55,669.99 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Mayor and Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Mayor and Council of the Borough of Barnegat Light, in the County of Ocean, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2017 budget year, the final appropriations of the Borough of Barnegat Light shall, in accordance with this ordinance and *N.J.S.A.* 40A:4-45.14, be increased by 3.5%, amounting to \$ 64,948.32 and that the CY 2017 municipal budget for the Borough of Barnegat Light be approved and adopted in accordance with this ordinance; and,






