## **REGULAR MEETING OF MAYOR AND COUNCIL July 13, 2016**

**THE CAUCUS MEETING** of the Mayor and Council was called to order by Mayor Larson at 4:30pm at the Borough Hall, on East 7<sup>th</sup> Street. He stated that adequate notice of this meeting has been provided in accordance with the New Jersey Open Public Meetings Act by posting a copy of the notice of this meeting on the bulletin board in the Borough Hall on January 4, 2016 and by mailing a copy of the notice to the Asbury Park Press, newspaper designated by Mayor and Council on January 4, 2016 to receive such notice, and by filing a copy of the notice with the Borough Clerk on January 4, 2016.

ROLL CALL: Spark, Sharpless, Wellington, Reynolds, Mikuletzky, Warr

Also present: Mayor Larson, Terry Brady, Brenda Kuhn and Kathleen Flanagan

**Discussion:** Mayor Larson said that he wanted to talk to the Recreation Committee about Frisbee Golf. He said on the east side of our dunes there's a lot of room to do something like that. He said maybe we could make a course of 9 holes and possibly expand to 18. He said it would be approximately \$300.00 per hole which would be cemented into the ground. He said the holes average about 250' but you can make it whatever you want. Mayor Larson said that people playing wouldn't have to start at the first hole; they could just start at the end of their street. Councilman Spark said the in golf you call that "shotgun". Councilman Mikuletzky asked if it would be taken away in the winter and Mayor Larson said no. The "holes" could actually be baskets on trees. Mayor and Council said that they could start with 9 holes. Councilman Warr asked if pickle ball was going to be pursued. Mayor Larson asked if he wanted to. He said we had one "NO" letter. Councilman Sharpless said that it is very loud. Mayor Larson said that every time he passes tennis courts, there's no one on them. Then he said that they could get a portable net, tape off the court and if it becomes a problem they just have to pull the tape up and take down the net. Mayor Larson asked if they wanted to get a net and try it out and Council thought it would be a good idea and it wouldn't be costly. Then Mayor Larson said that Council should consider an ordinance to prevent residents from private pickle ball courts in their backyards. The Council members agreed. Terry Brady suggested that he take a look at the ordinances by the next meeting and see where we can best fit it and arrange to regulate it. Mayor Larson urged the Council to have a first reading and include it under lot coverage. Councilman Wellington said that the courts are small enough that if someone had 1 ½ to 2 lots adjoining that they could fit a pickle ball court on their property. He said that it could be controlled by lot coverage. The Borough Attorney said that the ordinance would have to go before the Planning Board. He said that we could have first reading tonight. The Mayor and Council discussed fires next. They mentioned fires from fire pits and chimineas and how they smoke is a problem. Mayor Larson asked if Council wanted to pass an ordinance to prevent the fire pits and chimineas or to just talk about it for a while. Someone in the audience wanted to talk and the mayor asked him if he wanted to talk about pickle ball and he said he wanted to talk about fire pits. The mayor said that we would open to the public soon. Councilman Mikuletzky said that Lieutenant Governor Kim Guadagno was in town yesterday. Mayor Larson said that she spent a lot of time in town. She climbed the Lighthouse and went to Viking Village to the coffee shop. Then she went to the fishing docks and watched the grading of tuna and saw the scallops. After that Ron talked to her about ice for emergencies and told her that if there was an outage on the mainland they would send the ice from Viking Village to help keep food from spoiling. The councilman said that they were probably the largest icemaker in Ocean County. Councilman Wellington said that purpose of her visit was to promote non-beach tourism. Councilman Mikuletzky said that a dedication to the Lighthouse Gazebo was going to be held and Robert Geist, from the DEP, said he would like to have as many council members as possible in attendance. Mayor Larson stated that the Lt. Governor talked to his daughter at length about the minimum wage and how it would affect small businesses. The Mayor and Council discussed the ramifications that increasing the minimum wage to \$15.00 would have.

Mayor Larson asked for a motion to close Caucus Meeting. On a motion by **Reynolds**, seconded by **Spark** and carried by all the Caucus Meeting came to an end.

#### **COMMITTEE REPORTS:**

**WATER/SEWER:** Councilman Spark stated that he would like to make the report a part of the minutes. See report at the end of minutes.

**PUBLIC WORKS: Councilman Sharpless** stated that he would like to make the report a part of the minutes. He said that he wanted to go over a couple of things. He said that about 175 kids participated in the 4<sup>th</sup> of July Parade. Councilman Sharpless said that the Beach Olympics would be held tomorrow on 24<sup>th</sup> Street. He said that next Monday will be the Lighthouse Band concert and Saturday Our Gang Players will be doing a Broadway Review. Discover Barnegat Light Day was 2 days ago he stated that he thought it was successful and the Razorback concert was held that night with attendance being around 300-350.

**DOCKS AND HARBORS: Councilman Wellington** stated that ramp revenue is up about \$2600.00 this year. He said that the last time he looked at sales for the non-motorized watercraft tags, 110 had been sold. He said that it was working out very well for such a soft implementation. He said that more anchors would be put in between 10<sup>th</sup> and 12<sup>th</sup> Street. Councilman Wellington said that there was a glitch. There were a couple of bigger boats that want to be able to anchor the stern end. He said someone has a structure built there and we are allowing him to use it this year but it must be taken down at the end of the season. Councilman Spark said that it was much nicer in that area.

**BEACHES AND PARKS: Councilwoman Reynolds** said that beach badge sales are up this year by about \$6500.00. She said that our tennis revenues are up \$575.00. She stated that we had a couple of Piping Plovers on the beach but didn't know the status. Mayor Larson asked if the trucks could drive through that area yet. Councilwoman Reynolds stated that the Lifeguard Captain was in touch with the Endangered Species Program. The mayor said we can't stop the trucks from going through if we have a drowning or other emergency.

**PUBLIC SAFETY: Councilman Mikuletzky** said that the Police Department asked him to bring up cell phones. He said it was a good idea to lock your phone to protect the information that you have on it. Also there is a "Find My Phone" feature that you can use to locate a lost phone. The Councilman said that hurricane season is coming and families should have an emergency response plan. He said that re-entry passes should be kept in the glove compartment of your primary car. He said that there would be various events in Brant Beach. There would be a bike safety course, a K9 demonstration, and a National Night Out. He said that Barnegat Light is having the Bike Rodeo on August 21<sup>st</sup>. Councilman Mikuletzky stated that Long Beach Township Police are continuing to be aggressive on fireworks. He said there were several arrests and many warnings.

**FINANCE: Councilman Warr** said that the bills for the month were \$400,627.90. The Regional School tax was \$14,7117.00. The Audit report has been completed and there were no recommendations or comments which means the audit was perfect. He said that our staff, Kathleen, Brenda and all the other office staff deserve a thank you and congratulations!

**OPEN PUBLIC SESSION:** On a motion by **Warr**, seconded by **Spark** and carried by all the public session

Robert Parsky, 21 East 10<sup>th</sup> Street, said that the smoke from fire pits is a big problem. He wanted to urge the council to consider addressing the usage of fire pits. Mayor Larson said that we have an ordinance on the books and said that we could amend to add fire pit regulations. Councilman Spark asked if it was a year round or seasonal issue. Mary Ellen Foley, 6<sup>th</sup> East 10<sup>th</sup>, stated that fire pits are used in all seasons. They talked about time frame that they wanted to address this issue if the decided to go forward with amending the ordinance. Mayor Larson asked if council would be in favor of having a first reading on an ordinance

amending the existing one. Mary Ellen Foley, 6<sup>th</sup> East 10<sup>th</sup>, wanted to know if there was a way to require people to take down dead trees. Terry said that there was already an ordinance along those lines. Councilwoman Reynolds said that's really important to get them down because they could be infested with the beetles. Cheryl Curren, 11 Alma Road, High Bar, came in because she uses our beaches and has a problem with parking. She inquired about the 20' allowance for driveways. She said that she carries the ordinance with her because people try to stop her from parking the whole length of their property. She wanted to know how this is supposed to be marked. Councilman Sharpless said that we sent a letter to property owners urging them to designate their driveways on their own but if they need assistance to call the Borough and we would help. He said that after we see how the parking goes this summer we would take the next step and tell property that they must designate their driveways. She said that in South Carolina, Foley Beach, has an ordinance that says you can park anywhere but all 4 tires must be off the pavement. Mayor Larson said that that's okay on Central and Bayview. Eric Svelling, 2506 Central Avenue, wanted to thank Mayor and Council for taking up the serious problem of illegal fireworks. He said that the problem is not isolated to the holidays. It happens almost every Saturday night on the beach. He said that the police told him that there are serious fines associated with fireworks and Councilman Mikuletzky said that the police are still going to pursuing fireworks and give out tickets. Mr. Svelling said that we have Piping Plovers on our beaches and if fireworks are used within a mile the nests it could cause abandonment of the nest. Mr. Svelling proceeded to discuss the extent of the type of fireworks that were being used and the length of time that they are going off. Robin Pearson, 16 West 11<sup>th</sup> Street, said she attended the last council meeting and there was a discussion regarding sirens. Councilman Mikuletzky said that the FD was going to put a timer on the alarm but at the last meeting the officers decided not because there is a problem with the phone paging system. The siren will be left on until the paging system is updated. Dave Walton and Jack Byrnes both of Seaview Avenue informed the Mayor and Council that they had gotten permission to remove the black pines. The trees are grown up again and they asked if they could remove the trees that obstruct their ocean view. It was discovered that the trees are on Borough property. Mr. Walton asked for permission to top the trees. Mayor Larson asked Council if they would approve the request and they replied yes with conditions. Councilman Sharpless said he should tag the trees at the height that they would be cut. Mayor Larson said that he couldn't take them all the way down, just enough to get back the view. Superintendent would be sent there to take a

**NOW, THEREFORE, BE IT RESOVLVED,** by completing a flood insurance assessment (FIA), a copy of which is attached hereto, marked Exhibit A, in that 83.7% of the properties in Barnegat Light, a barrier island, are insured through the National Flood Insurance Program, and that by completing the Island wide program for Public Information and executing that program, this level of coverage will remain high due to the fact that insurance is mandatory for properties that have federally backed mortgages in the special flood hazard area, and furthermore post "Sandy", that flood insurance is a wise investment for all property owners including year round renters.
