Also present: Mayor Larson, Terry Brady, Ed Sulecki, Sponge Washburn and Brenda Kuhn

Discussion: Mayor Larson began the caucus meeting by talking about parking on West 6th Street. Someone said that 6th Street is the truck route and it gets very busy and tight now and when the mini golf opens the problem will likely escalate. It was decided that an ordinance to prohibit parking on West 6th Street between Broadway and Bayview would be introduced and before the adoption the site plan for the mini golf would be reviewed. Mayor Larson mentioned that a salary ordinance would be introduced. Next the Mayor started a conversation regarding a new regulation regarding the sewer system. He had the Superintendent give a brief description on the problem. The new regulation would require anyone working on the sewer lines to notify the Borough prior to doing any work on the sewer system and if any damage occurred that they would be responsible to do the repairs. The next topic of discussion was Airbnb's and if there should be any regulations regarding them. The noise ordinance was also discussed because someone was powerwashing a house a 9:00pm and another person was putting siding on a house after hours. Mayor Larson said that the taxpayers association asked if there were any type of tax breaks for businesses to keep them in town. The bank and the gas station were mentioned. One of the livery leasees inquired about having propane tanks for sale.

Mayor Larson asked for a motion to close the Caucus. On a motion by Mikuletzky, seconded by Wellington and carried by all the Caucus Meeting was closed.

COMMITTEE REPORTS:

PUBLIC WORKS: Councilman Sharpless did not attend the meeting.

FINANCE: Councilman Spark said that the bills for the month were \$591,693.69 and that regional school tax was a big part of that total.

WATER/SEWER: Councilwoman Foley said that she would like to make the monthly report a part of the minutes. She reported that the water usage almost doubled from April to May. She said that there was a major issue at our largest water plant and thanks to Eddie and his crew it was fixed before Memorial Day. Councilwoman Foley said that the commercial meter installation was almost done and the rumor has it that there were five installations left.

BEACHES AND PARKS: Councilwoman Reynolds said that the beaches are open and the beach badge sales are over \$5,000 more than last year at this time. She said that at high tide the water is covering the beach between 9th & 14th Streets and the Beach Patrol would keep an eye on it to determine whether to put a stand there or not. She said that there would be surfing on 14th Street. Councilwoman Reynolds and an extra stand may be placed between 27th and 30th. She said that the Bay beach looked beautiful and on the few nice days it was packed. She said that we have sold 111 passes for the dog park to non-residents.

DOCKS AND HARBORS: Councilman Wellington said that the ramp fees were down by \$2800 from last year and he felt it had to do with the weather. He said that the framing for the new shed at the ramp was built with repurposed wood that was used as scaffolding at the pavilion and that the windows, doors and electrical were new. He said that it would take on the character of all of our other buildings. Councilman Wellington reported that the pavers around the pavilion were almost done and that the sprinkler system installation would begin soon. He said that we have sold approximately 80 memorial bricks.

PUBLIC SAFETY: Councilman Mikuletzky said that he would like to make the monthly report a part of the minutes. He said that court collected \$195.00. The Councilman said that Judge Salzer was retiring and that we were appointing Judge Ligouri as his replacement. The Clerk said that our current Interim Court Administrator received her certification and we would be appointing her to a 3 year term.

OPEN PUBLIC SESSION: Mayor Larson asked for a motion to open the open public session. There was a motion by Foley, seconded by Spark and carried by all.

Sandy McDade and Art Turner, 15 E 21 Street, were at the meeting to ask for approval to have Greenwood Tree Service to trim the trees in front of their home. Ms. McDade said that they submitted all the information needed and support from their neighbors. Dead trees on the dunes and on properties were discussed. Mayor Larson asked for a motion to approve their request. Councilwoman Foley made a motion and all were in favor. Mayor Larson thanked John Tennyson for the Taxpayers Associations donation of benches for the pavilion.

CLOSE PUBLIC SESSION: Mayor Larson asked for a motion to close the open public session. There was a motion by Spark, seconded by Reynolds and carried by all.
