### **REGULAR MEETING OF MAYOR AND COUNCIL June 14, 2017**

**THE CAUCUS MEETING** of the Mayor and Council was called to order by Mayor Larson at 4:30pm at the Borough Hall, on East 7<sup>th</sup> Street. He stated that adequate notice of this meeting has been provided in accordance with the New Jersey Open Public Meetings Act. Notice of this meeting was posted on the bulletin board in the Borough Hall on January 4, 2017 and it was published on January 12, 2017 in the Beach Haven Times and the Asbury Park Press, newspapers designated by Mayor and Council on January 4, 2017 to receive such notice, and by filing a copy of the notice with the Acting Borough Clerk on January 4, 2017.

Also present: Mayor Larson, Terry Brady, Elaine Tollison, Ashley Darmon, Sponge Washburn and Brenda Kuhn

**Discussion:** Mayor Larson talked about the Taxpayers Association Meeting and how there was a vote about raising the building height limit. He said there was a vote and that it was approximately 95-5 opposed to raising the limit. There was lot of discussion about this topic such as starting 1' off the crown of the road, using fill, having an uneven skyline, flooding and many other things.

The next topic of discussion was water meters and pits. Councilman Spark said that we have been working with Stafford Township to locate the meters and 25-30 have never been found. He is urging the property owners to uncover and locate their meters. He cautioned the public that 10-15' from the road is actually Borough property and many have landscaped and hardscaped this area. Councilman Mikuletzky mentioned that once the pits are exposed that they must remain exposed for access by the Borough. Councilman Spark said that going to meters is mandated by the state.

Mayor Larson talked about putting a non-binding referendum question on the ballot for the general election. The question is "Do the people of this town really want a dog park?" He stated that there have been many problems with the dog park.

Councilwoman Reynolds said she thought we should consider the ban on balloons. She said that some other towns have been adopting ordinances to ban them.

Councilman Sharpless said that that there is a lot of support for the skateboard park. He was looking for the consent of council before he moves forward with planning the renovations of the park. He gave some ballpark figures and the Mayor told him to get something together. Councilman Mikuletzky added that the users of the park must start obeying the rules.

Mayor Larson asked for a motion to close the Caucus. On a motion by Reynolds, seconded by Sharpless and carried by all the Caucus Meeting was closed.

**Mayor Larson** announced that Brenda Kuhn passed the Municipal Clerks exam and she is taking the oath of office and she is going from Acting Borough Clerk to the real Clerk! Terry Brady, the Borough Attorney administered the oath of office.

### **COMMITTEE REPORTS:**

**WATER/SEWER:** Councilman Spark said that he would like to make the monthly report a part of the meeting minutes. He said there was a big increase in the water usage.

**PUBLIC WORKS: Councilman Sharpless** said that Public Works was busy. He told everyone that the Independence Day Parade will be July 1, 2017 and line up starts at 6pm on West 11<sup>th</sup> Street.

**DOCKS AND HARBORS: Councilman Wellington** said that the boat ramp revenue is consistent with last year. The total for this year is \$15, 400. He said that the NJDOT channel dredging project is back on track for this fall with Great Lakes Dredging doing the work. He said that it will probably be November or December before they will get to our project. Councilman Wellington talked about the Pavilion project. He said that we were getting prices for the steel and that Stanley Madsen has completed the materials list and will provide it to the CFO and Engineer.

**BEACHES AND PARKS: Councilwoman Reynolds** said tennis fees are down but that was because of the new rules. She said that seasonal beach badges revenue is up. Councilwoman Reynolds said there was an unusual number of Piping Plovers on our beaches and she cautioned everyone to observe caution in and around the fenced nesting areas. She said vehicle use must be limited to emergencies only.

**FINANCE: Councilman Warr** said that the bills paid for the month were \$348,085.67 and of that \$147,000 was Regional School Tax.

**PUBLIC SAFETY: Councilman Mikuletzky** said he would like to make the court report a part of the meeting minutes. The he spoke to Chief Deely and was told that they are going to be concentrating on pedestrian and bike safety rules. He said that on Friday the traffic lights would be on.

**OPEN PUBLIC SESSION:** Mayor Larson asked for a motion to open the public session. On a motion by **Wellington,** seconded by **Reynolds** and carried by all the public session was open.

Joe Cornell, 2902 Bayview Ave. said that he was there to commend the Mayor and Council for putting in the walkways on 30<sup>th</sup> Street. Bob Crimmins, 16 E 18 Street, thanked the Mayor and Council on reconsidering raising the building height. Ron Goebel, 11 E 7 Street, said that he had water issues and talked to the code enforcement officer about it. He said he was asking for help. Sponge Washburn said that it was hard to tell where the water is coming from but his property is lower than most on the street. He said that he called Frank Little to see if he had any ideas. Tom Scangerello, Professional Planner, said he was there representing Bob Dole. Bob Dole then spoke to the Mayor and Council about his concerns. Mr. Scangerello said that they were concerned about the character, safety, health and welfare of Barnegat Light. Ernie Branin, 16 W 26 Street, want to ask about access to meter pits and he wanted to know who was responsible to raise the meter to the level that is required. Councilman Sparks said that the property owner would be responsible. Mr. Branin then discussed the crown of the road and raising the building height. He was concerned about where the water runoff would go. There was further discussion about water and how raising the building height would affect it. He said that another issue was the rising tides. Connie Higgins, 10 E 11 Street, said that she didn't understand why the meters couldn't put on the outside of the house. She was told that we need access to the meters without trespassing on the properties. There were problems with this because we need to be able to repair, replace, the meters but we also need to get to the shutoffs at the curb. He said that Harvey Cedars made their property owners pay for the new meters. Mary Ellen Foley, 6 E 10 Street, asked if the Borough wanted people to call when they locate their meter pits. John Tennyson, 6 W 22 Street, said that the Taxpayers Association's survey asked what do people like to do in the form of recreation and 47% said miniature golf. He thought it was interesting since most people were not in favor of the proposed miniature golf course being built in Barnegat Light.

Section 3. This ordinance shall take effect as provided by law.

### ORDINANCE OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, DETERMINING POSITIONS ELIGIBLE FOR THE DEFINED **CONTRIBUTION RETIREMENT PROGRAM**

WHEREAS, the State Legislature has adopted Chapter 92 of the Laws of 2007 (N.J.S. 43:15C-1 et seq.) to create the Defined Contribution Retirement Program to provide retirement benefits to various county and municipal officials; and,

WHEREAS, N.J.S. 43:15C-2 requires the governing body of each county, municipality, and other local entity to adopt, as appropriate, either a resolution or ordinance to determine the positions that are substantially similar in nature to the advice and consent of the Senate for appointments by the Governor of the State, pursuant to guidelines or policy that shall be established by the Local Finance Board in the Department of Community Affairs, and for which officials appointed to such positions shall be eligible for and shall participate in the Defined Contribution Retirement Program, subject to the provisions of law; and,

WHEREAS, the Mayor and Borough Council of the Borough of Barnegat Light has considered the guidelines issues by the Local Finance Board;

### NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Borough Council that:

- 1. Pursuant to N.J.S. 43:15C-2, the following positions are deemed to be eligible for and shall participate in the Defined Contribution Retirement Program:
  - a. Construction Code Clerk
  - b. Zoning/Code Enforcement Officer
- 2. Individuals serving in the following positions are exempt from Defined Contribution Retirement Program membership, pursuant to N.J.S. 43:15C-2:

  - a. Tax Collectorb. Chief Financial
  - c. OfficerQualified Purchasing Agent
  - d. Tax Assessor
  - e. Superintendent of Public Works
  - f. Construction Code Official
- 3. This ordinance shall be implemented, construed and subject to the aforesaid Chapter 92 of the Laws of 2007 (N.J.S. 43:15C-1 et seq.) as amended from time to time, and any regulations or guidance documents from the Local Finance Board or the Division of Pensions and Benefits.
- 4. Should any part or parts of this ordinance be held to be invalid by any competent court of law, such invalidity shall only affect the part or parts held to be invalid, and all other parts shall remain in effect.
- 5. A copy of this ordinance shall be filed with the Director of the Division of Pensions & Benefits of the New Jersey Department of the Treasury.

**SECTION 1.** There is hereby created and established a new Section 76-21 of the Borough Code of the Borough of Barnegat Light, to be entitled "Prohibited construction operations," to provide as follows: **Chapter 76** 

### Construction Codes, Uniform

### §76-21. Prohibited construction operations.

- A. Power generators. Gas powered electric generators shall be prohibited on construction sites, but rather a temporary electric power pole shall be installed and activated to bring electric power to the construction site.
- B. Exceptions. Exceptions may be made to this ordinance under the following circumstances:1. In case of urgent necessity in the interest of public health and safety
- SECTION 2. All ordinances of parts of ordinances inconsistent herewith are hereby repealed.

**SECTION 3.** This ordinance shall take effect immediately upon its enactment after second reading and publication as required by law
