RESOLUTION OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AWARDING A CONTRACT FOR THE PURCHASE OF VARIOUS SPECIFIED MATERIALS FOR THE PAVILION CONSTRUCTION PROJECT.

WHEREAS, the Borough of Barnegat Light is in need of various specified materials for the Pavilion Construction Project, a list of which is attached hereto and is incorporated herein by reference; and

WHEREAS, the anticipated cost of said materials purchase is expected to exceed \$40,000.00 so as to require public bidding in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq.; and

WHEREAS, the Borough of Barnegat Light duly advertised for the receipt of bids for the same on May 24, 2018 for a June 7, 2018 bid opening, and again on June 14, 2018 for a June 26, 2018 bid opening; and

WHEREAS, at both times, places and dates set for the receipt of bids, ZERO bids were received by the Borough; and

WHEREAS, according to NJSA 40A:11-5(3), a contract which exceeds the bid threshold may be negotiated and awarded by resolution of the 2/3rds vote of the fully authorized membership of the governing body without further advertising for bids if bids have advertised on 2 occasions and no bids were received on both occasions in response to the advertisements; provided that the specifications in the negotiated contract are not substantially different from those where were advertised; and

WHEREAS, it is the desire of the Mayor and Borough Council of the Borough of Barnegat Light to award a contract for the purchase of various specified materials for the Pavilion Construction Project, per the attached list, to 84 Lumber for the price of \$9,514.77.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of the Borough of Barnegat Light, County of Ocean, State of New Jersey, as follows:

- 1. That the Mayor and Borough Council of the Borough of Barnegat Light do hereby award a contract for the purchase of various specified materials for the Pavilion Construction Project, per the attached list, to 84 Lumber for the negotiated price of \$9,514.77.
- 2. That the Mayor and Borough Clerk are hereby authorized to execute an agreement with 84 Lumber for said purchase, said purchase to be in conformance with bid specifications and the negotiated price specified above.
