COMMITTEE REPORTS:

WATER/SEWER: Councilwomen Foley reported that there were a few discrepancies with the commercial meters and that was being worked on. She asked the CFO about the status of the residential meter project. The CFO said the package was sent to the proper agency for approval. Once the plan is approved we can go out to bid. The Councilwoman said that a couple of our generators were being repaired and asked Councilman Mikuletzky to talk about the progress.

PUBLIC WORKS: Councilman Wellington reported that the Post Office had been refurbished. It was painted and new trim and flooring was installed. He said that he was working on a plan to regrade the bay

beach. The Councilman stated that he talked to Kevin Kuhlman about the replacement of 6 pilings that needed to be replaced. Councilman Spark said that EZ Docks should be called regarding placement of the pilings. He also said that EZ Docks was aware of the need for a floating dock. Councilman Wellington was questioned about the run off at the bay beach. There was a lot of discussion which included storm drains, flooding on the road, erosion and the county not doing what has been requested in the past. The CFO stated that a letter should have been received from the county that asked the town to schedule a meeting with the county to discuss the concerns with the town. She said that she was going to send them an email to let them know that Barnegat Light wants to meet with them.

DOCKS AND HARBORS: Councilman Alloway said that there were nine boat slips still available.

BEACHES AND PARKS: Councilwoman Reynolds said that beach badge sales were down by \$1,200.00. She said that 21 people have bought dog park pass and the revenue was down \$500.00. She said that the sun will be shining and all will be well!

PUBLIC SAFETY: Councilman Mikuletzky said that he wanted to make the January & February court reports a part of the minutes. He stated that not much money has been taken in.

FINANCE: Councilman Spark said that the Tax /Utility Collector took in \$1,606,000 between tax and utility. He complimented the taxpayers for paying on time. He said when people don't pay it affects our tax rate. He said that our biggest expenditures of the month were the school tax. He said that the regional was \$158,000 and the local was \$15,000. He said that the CFO was getting close on the budget process and that another budget workshop will be held on March 28, 2019 at 2:00pm at Borough Hall.

RESOLUTION OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, OPPOSING ASSEMBLY BILL A-4580, WHICH WOULD AMEND THE LOCAL PUBLIC CONTRACTS LAW TO REQUIRE THE RELEASE OF THE BID LIST PRIOR TO BID DATE.

WHEREAS, it is the desire of the Borough of Barnegat Light to oppose Assembly bill A-4580 which would amend the Local Public Contracts law to require release of bid list prior to bid date,

WHEREAS, this bill will impact public works procurement at local levels of government and impede the governing body members, Qualified Purchasing Agents, and responsible public works professionals causing them to expend already limited resources on an action that will diminish their duty to protect the

public trust, the integrity of the procurement process, and remove the clearly defined cornerstone of bidding: full, fair, free competition.

WHEREAS, it is already permissive, not mandatory, to maintain a Bidders List if the governing body so desires. This can be achieved simply by maintaining a list accessible to the public. However, the legal publication of a Notice to Bidders is an open invitation to all who would participate in the process.

WHEREAS, new Jersey's public procurement statutes and related rules already burden the contracting process and the proposed legislation adds costs and probable delays or disputes to the process.

WHEREAS, many small municipalities and agencies do not have in-house staff to process and administer such contracts. Therefore, the handling of these bids may be conducted off-site by professional service contractors and incur additional costs to these projects, many of which are critical to taxpayers and the public.

WHEREAS, an arbitrary benchmark on bidders notification may serve to induce more protests, disruptions, and delays in the entire process.

WHEREAS, the Borough sees no cumulative data on minority owned, women owned subcontracting business being prevented from submitting proposals to General Contractors. What is documented by historical experience is the public works contractors tendency to utilize subcontractors they have previously worked with and who demonstrate their experience and expertise to make an economic proposal and efficient work product.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Barnegat Light, County of Ocean, State of New Jersey, as follows;

- 1. That the Mayor and Borough Council hereby oppose the enactment of legislation to require release of the bid list prior to bid date.

WHEREAS, the Township of Long Beach has created a Municipal Transportation System to address the need for public transportation, to support the goal of the alleviation of traffic and parking problems, fill a need for an immediately available emergency transportation system required during declared emergencies, enhance and support the economic activities in Township and region as a whole, and benefit the experience and way of life of the residents, businesses, and visitors of Long Beach Island, as well as generally protect the public health, welfare, and safety; and

WHEREAS, Long Beach Township has offered to all Long Beach Island municipalities the opportunity to participate in said municipal transportation system by way of a shared service agreement; and

WHEREAS, it is the desire of the Borough of Barnegat Light to join in a shared service agreement to provide for a municipal transportation system to service all Long Beach Island municipalities, with Long Beach Township as Lead Agency and Barnegat Light Borough as a participating municipality to receive part of the service rendered and to fund a part of the cost of the service; and

WHEREAS, N.J.S.A. 40A:65-4 (Common Sense Shared Services Pilot Program Act) provides that any local unit may enter into an agreement with any other local unit to provide or receive any service that each local unit participating in the agreement is empowered to provide or receive within its own jurisdiction, including services incidental to the primary purposes of any of the participating local units, when approved by resolution under N.J.S.A. 40A:65-5.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Borough Council of the Borough of Barnegat Light, County of Ocean, State of New Jersey, as follows:

- 1. The Mayor and Borough Council of the Borough of Barnegat Light do hereby authorize a shared services interlocal agreement with Long Beach Township for Long Beach Township to provide for a municipal transportation system to service all Long Beach Island municipalities, with Long Beach Township as Lead Agency and Barnegat Light Borough as a participating municipality to receive part of the service rendered and to fund a part of the cost of the service. Barnegat Light Borough shall pay \$20,000 towards said costs for the period of May 1, 2019 to April 30, 2020 on or before May 1, 2019. The agreement may be extended pf a maximum of four (4) one (1) year additional terms following the initial term. Said mutual, written consent must be agreed upon not later than November 1 of the calendar year preceding the termination of each one-year (1) term.
- **2.** That the Mayor and Borough Clerk are hereby authorized to execute the attached Municipal Transportation System Shared Service Agreement, and any and all other documents necessary for said services.
