THE CAUCUS MEETING of the Mayor and Council was called to order by Mayor Larson at 4:30pm at the Borough Hall, on East 7th Street. He stated that adequate notice of this meeting has been provided in accordance with the NJ Open Public Meetings Act. Notice of this meeting was posted on the bulletin board in Borough Hall on January 3, 2018 and was published in the Asbury Park Press on January 8, 2018 and in the Beach Haven Times, both newspapers are designated by Mayor and Council to receive such notice.

ROLL CALL: Spark, Sharpless, Wellington, Reynolds, Mikuletzky and Foley

Also present: Mayor Larson, Terry Brady, Elaine Tollison, Sponge Washburn, Brian Logan, Don Adams, Scott Caffrey and Brenda Kuhn

Discussion: Mayor Larson asked Councilman Sharpless to talk about the skate park. The Councilman said they were waiting for the budget to pass. He said that there was a committee meeting and the competitive bid process was discussed. They talked about a prior list which included design, location features and cost. He said there would be another meeting to work on the features that were wanted and the design. The Mayor asked Councilman Wellington to report on the pavilion. Councilman Wellington gave an update on the progress of the Pavilion. He talked about the significant progress over the last couple of weeks. He said that the electricity is now connected to the pole, one set of stairs on the west side was finished, the handicap ramp was completed, and the cedar shakes were done and capped. He also reported that the gravel was in the parking area and curb stops will be ordered soon. The Councilman said that the benches were being ordered, the sprinkler system will be started in 2-2 ½ weeks, and once the sprinklers were in, the sod would be laid. In regards to the parking area, he said that a privet hedge would be planted between the sod and the parking area to help retain the water. The "Pave the Pavilion" engraved brick program was the next topic. The Councilman explained how to order via a link on the Borough website and he said that 19 have already been sold. Councilman Wellington also reported on the Borough docks. He said that the new docks were installed; aluminum ladders were purchased to replace the rotted wooden ones, a broken piling was replaced and the gangways were installed. He said the restroom was cleaned, painted and had a new roof. He said that the dock has taken in \$4,020 over the last couple of weeks. He also said that the fish finally showed up yesterday. Mayor Larson talked about a letter that was brought in at the end of the day regarding a walkway that was in need of repair. The letter said that the walkway leads you to the beach from 5th, 6th, and 7th Streets. Mayor and Council discussed it and they said they didn't put it there and aren't responsible for maintaining it. Councilman Wellington brought up the public access walkways at North Light Villas. He said the decking is dangerous and there were a lot of spindles missing. He thought that it was our responsibility to write to them to address the repairs. Mayor Larson brought up the closed gas station. He said he talked to John Brennan, the owner of the gas station, and John said he was trying to get someone to bring gas back in to Barnegat Light.

Mayor Larson asked if the council was in favor of closing the Caucus Meeting. All Councilmembers were in favor. The Caucus Meeting came to an end.

COMMITTEE REPORTS:

PUBLIC SAFETY: Councilman Mikuletzky said that he would like to make the court report a part of the minutes. He reported that \$574.00 was collected by the court. He said that the traffic lights would be coming on and the speed limits will be changing soon. Councilman Mikuletzky said to beware of phone scams.

DOCKS AND HARBORS: Councilman Wellington reported during the caucus.

BEACHES AND PARKS: Councilwoman Reynolds said that the \$39,000 in beach badge revenue was down from this time last year. She urged everyone to get their badges before the price goes up. She announced that there was a part time position open for the Beach badge Booth. She said that a few beaches would be open on June 9th. The Councilwoman said that there were still openings for the LIT program. The bay beach will be getting new sand as soon as the budget passes and wood chips were put down on 12th Street. Councilwoman Reynolds said that the Piping Plover were looking for places to nest and there was an Osprey nest on the end of 24th Street at the bayfront. She said "Mrs. Osprey" had two suitors, both bringing her fish!

WATER/SEWER: Councilwoman Foley said the water usage was about 4,000,000 gallons and that there were about four commercial meters left to install. She said that all that is left are the big ones with 2" pipes and they were waiting for parts. She said it should be done in approximately a week.

PUBLIC WORKS: Councilman Sharpless said that DPW was really busy trying to get ready for the summer. He reported that the Memorial Day Parade would be on May 27th, the lineup will be at 6:00 and it would start at 6:30. The parade will head down to the Lighthouse for a ceremony. He added that he has been told that the ceremony is the best on the island.

FINANCE: Councilman Spark said that the 2018 Municipal Budget was introduced at the last meeting with a 0% increase. He thanked the CFO and the Auditor for their hard work.

municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and WHEREAS, pursuant to N.J.A.C. 5:30-7.2 through 7.5, the *Borough of Barnegat Light* has been declared eligible to participate in the program by the Division of Local government Services, and the Chief Financial officer has determined that the local government meets the necessary conditions to participate in the program for the 2018 budget year.

NOW THEREFORE BE IT RESOLVED by the governing body of the *Borough of Barnegat Light* that in accordance with N.J.A.C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the governing body has found the budget has met the following requirements:

- 1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
 - a. Payment of interest and debt redemption charges
 - b. Deferred charges and statutory expenditures
 - c. Cash deficit of preceding year
 - d. Reserve for uncollected taxes
 - e. Other reserves and non-disbursement items
 - f. Any inclusions of amounts required for school purposes.
- 2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).
- 3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
 - 4. That pursuant to the Local Budget Law:
- a. All estimates of revenue are reasonable, accurate and correctly stated,
 - b. Items of appropriation are properly set forth
- c. In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality.
- 5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.
- 6. That all other applicable statutory requirements have been fulfilled. BE IT FURTHER RESOLVED that a copy of this resolution will be forwarded to the Director of the Division of Local Government Services upon adoption. DATED: May 9, 2018

He thanked the Mayor and Council for the use of that space. He said he thought we had the best beach patrol on the island. Keith Ray, 1611 Seaview Ave., was at the meeting to follow up on the request that was submitted at the last meeting. He explained the area that he wanted to trim and said he was using a licensed and insured arborist. Councilman Sharpless said that he thought cedars and holly trees should not be touched. The Council said that Sponge should go out see the area. The Mayor asked for a motion to approve Mr. Rays request. There was a motion and all were in favor. Sandra McDade & Art Turner asked what the procedure is to get approval for removing dead trees and trimming others. They were told to write a letter to the Borough outlining what exactly they are proposing to do, neighbors consent and photos of the area and then it can be voted on. WHEREAS Joseph D. Coronato was named Ocean County Prosecutor in 2013 and since that time has led Ocean County's law enforcement community through difficult times and challenges in particular through the unprecedented opiate drug epidemic that has led to thousands of overdoses and that has cost the lives of many of our residents; and

WHEREAS the Mayor, Council and residents of the Borough of Barnegat Light are most appreciative of the tremendous efforts and multi-faceted campaign brought forth by Prosecutor Coronato; and

WHEREAS Joseph Coronato immediately recognized the severe threat of opiate abuse and engaged with police agencies and community groups throughout the region to empower people through education and information, creating a myriad of seminars and available resources to help individuals and families in crisis: and

WHEREAS in his ongoing effort to fight the scourge of addiction created by the availability of opioids, Prosecutor Coronato was the first in New Jersey to find the funding to equip law enforcement officers with lifesaving Narcan, in addition to increasing use and efficiency in the Ocean County Drug Court Program and also spearheading a countywide "Blue HART" (Heroin Addiction Recovery and Treatment) program allowing addicts to get needed help at local police department without fear of arrest; and

WHEREAS Prosecutor Coronato from his first day in office took a tough on crime stance, with a nononsense approach to reducing gang violence, domestic violence and assaults, apprehending drug pushers, seeking the toughest penalties for those men and women guilty of providing illegal drugs leading to deaths, making arrests in cases of child pornography, apprehending contractors who preyed on the most vulnerable following Superstorm Sandy, all while making certain the victims of crime were not lost in the bureaucratic maze of what can be a confusing and overwhelming justice system; and

WHEREAS Prosecutor Coronato's office is known for its professionalism with a well-trained and knowledgeable staff that has assisted in his efforts to protect the public at all times. His efforts have received national recognition most notable in his multi-faceted programs to fight the far-reaching opioid epidemic which have been highly effective and now serve as the model for other programs being introduced nationwide; and

WHEREAS, Master Gardeners of Ocean County, INC. was formed in 1990 and is a non-profit organization working in cooperation with the Ocean County Board of Freeholders and Rutgers NJ Agricultural Experiment Station to promote the mission of the Rutgers Master Gardener volunteer program by utilizing research-based information to educate the public throughout Ocean County on best practices in consumer horticulture and environmental stewardship; and

WHEREAS, the Master Gardeners of Ocean County, Inc., under the direction of the Rutgers Master Gardener Program, provides services for tick identification and have tracked the tick population in Ocean County since 2010; and

WHEREAS, over the past five years, Master Gardeners of Ocean County, Inc. has tracked an increase in the tick population; and

WHEREAS, while Lyme Disease cases are reported on in the Ocean County and New Jersey area, the U.S. Department for Human Services, Center for Disease Control and Prevention has updated its pamphlet "Tickborne Diseases of the United States 'A Reference Manual for Healthcare Providers" to include additional less known diseases that impact the health of our citizens.

WHEREAS, these additional diseases include Anaplasmosis which is most frequently reported in areas that correspond with the known geographic distribution of Lyme disease; Babesiosis which is most frequently reported from the northeastern and upper midwestern United States; Ehrlichiosis most frequently reported from the southeastern and south-central United States, from the eastern seaboard extending westward to Texas; Rocky Mountain Spotted Fever cases have been reported throughout most of the contiguous U.S.; Powassan virus infections have been reported primarily from Northeastern States and the Great Lakes region; and

WHEREAS, the Master Gardeners of Ocean County, Inc. are committed to provide tick identification and preventative information, as well as promote the awareness of diseases set forth by the Center for Diseases and Prevention to citizens of Ocean County.
