REGULAR MEETING OF MAYOR AND COUNCIL October 12, 2016

THE CAUCUS MEETING of the Mayor and Council was called to order by Councilman Spark at 4:30pm at the Borough Hall, on East 7th Street. He stated that adequate notice of this meeting has been provided in accordance with the New Jersey Open Public Meetings Act by posting a copy of the notice of this meeting on the bulletin board in the Borough Hall on January 4, 2016 and by mailing a copy of the notice to the Asbury Park Press, newspaper designated by Mayor and Council on January 4, 2016 to receive such notice, and by filing a copy of the notice with the Borough Clerk on January 4, 2016.

ROLL CALL: Spark, Sharpless, Wellington, Reynolds (absent), Mikuletzky, Warr

Also present: Terry Brady, Brenda Kuhn, Councilwoman Reynolds arrived at 4:35

Discussion: Councilman Wellington began discussing an ordinance regarding storage containers (pods) that was being introduced. He explained that permits would be required and the cost would be \$50. The permits would be issued for 90 days and would be renewable one time for no additional cost. He explained that construction containers would be permitted to remain for the entire time of construction and would be required to be removed from the site within 30 after the CO or CA was issued. Councilman Wellington also wanted to discuss a resolution that was on the agenda that would support the Borough of Ship Bottom in the purchase of the LBI School for \$4,000,000 and also support a referendum to renovate the EJ School in the amount of \$16,000,000. He said that this afternoon an email was received from the Mayor of Ship Bottom requesting our support.

THE MEETING of Mayor and Council was called to order by Councilman Spark at 5:00 at the Borough Hall on East 7th Street. He stated that adequate notice of this meeting has been provided in accordance with the New Jersey Open Public Meetings Act by posting a copy of the notice of this meeting on the bulletin board in the Borough Hall on January 4, 2016 and by mailing a copy of the notice to the Asbury Park Press, newspaper designated by Mayor and Council on January 4, 2016 to receive such notice, and by filing a copy of the notice with the Borough Clerk on January 4, 2016.

The Acting Clerk stated that the meeting was being recorded and that a written copy would be available in the Clerk's office and that the next meeting would be November 9, 2016.

COMMITTEE REPORTS:

FINANCE: Councilman Warr said that the bills for the month were \$443,226. He also wanted to discuss the Best Practices Checklist. Kathleen Flanagan said that this is a questionnaire that must be completed for the state in order to get State Aid. She said to qualify you must get 22 yeses or N/As and we did so there will be no loss of State Aid.

PUBLIC SAFETY: Councilman Mikuletzky stated that the speed limits have been raised and the traffic lights are blinking. He said that anyone going away for the winter could register with the Long Beach Township Police Department. The department will keep an eye on the registered properties and the police would have contact information if they needed to contact the owners.

BEACHES AND PARKS: Councilwoman Reynolds said the beaches are closed and that is was a good summer. She said that the beach badge revenue was up this year. She said that there was going to be a Beaches and Parks meeting. At the meeting many things will be discussed such as tennis court fee, the skate park and its future, the dog park etc. Councilwoman Reynolds said that the bay beach parking lot needed attention. She said it needed packing gravel.

WATER/SEWER: Councilman Spark said that he wanted the report to be a part of the minutes. He stated that he thought it was very weird that Barnegat Light used 16,000,000 gallons of water and LBT used 11,000,000 gallons of water last month.

DOCKS AND HARBORS: Councilman Wellington said that the current ramp revenue was at \$34,800 which was \$1200 less that the same time last year. He thought that the revenue will go up when the strippers come in. He talked about the dredging that was on hold because of the freeze. He said that if it wasn't finished by the end of the year the project would have to wait until next September.

PUBLIC WORKS: Councilman Sharpless said that department was busy. The rollups have been removed and they were going to be installing the permanent boardwalks. He said that the summer help was being hired as a Labor I. Then Councilman Sharpless discussed the planting of dune grass. He said that within the next few weeks a couple of school groups would be coming to plant the dune grass and if anyone wanted to help with the planting...plant away!

OPEN PUBLIC SESSION:

On a motion by Sharpless, seconded by Wellington and carried by all the public session was opened.

Rich Brodman, 4 East 10th St, asked Councilwoman Reynolds about the tennis revenue. She said she didn't have the numbers in front of her but it wasn't a lot.

Elise Lemcke, 26 West 10th St, said that we are losing boat ramp fees because a lot of people are using the boat ramp in the middle of the night and are gone in the morning. She said she put a piece of plywood over a big hole across from her house. She said it wasn't in the dog park but was between the fence and the grassy area. She asked about the status on the lock system for the dog park. Councilwoman Reynolds said that there were some issues with the fencing and when that was finished we would be moving forward with it. She asked if the agenda was posted anywhere prior to the meeting.

There was a lot of discussion about the resolution that we were asked to pass by the Mayor of Ship Bottom. Approval of the resolution would support Ship Bottom in the purchase of the LBI School for \$4,000,000 and also would support putting a referendum on the ballot to renovate the EJ School for \$16,000,000.

John Tennyson, President of the Taxpayers association, 6 West 22^{nd} St, asked for an explanation of resolution 2016-130 and asked if there was a financial caveat to it. Councilman Wellington said that the LBI School was originally for sale with a price tag of \$10,000,000 and why can Ship Bottom buy it for the much lower price. He didn't think that Ship Bottom wanted to use the entire property and the gap would be able to help with the renovations to the EJ School. There are a lot of issues that need clarification because the BOE wasn't revealing information regarding the proposed sale.

Bonnie Brodman, 4 East 10th St, asked why they were selling it cheaper. Kathleen Flanagan told her there were no written offers.

Richard Feehan, 12 East 15th St, stated that there wasn't enough information to pass the resolution. He urged the council not to vote until more information is received.

Vince Roth, 6 West 17th St, agreed that there wasn't enough information.

Barry Mescolotto, 11 West 19th St, said that an appraisal must be done. He said that there could be deed restrictions or title matters.

Councilman Sharpless said that the price of the renovation for the EJ School was climbing. There was talk about demographics and the declining population.

John Tennyson talked about the expansion of 100 seats in the BOE 5 year plan. He talked about the 43 Choice students that come from off the island. He said these choice students are mandated at 20% of the student population and that they have to stay until they are finished. \$2000 is paid for each choice student however it costs \$16,000 to educate each student.

Terry Brady said that all of the issues that are being discussed should be decided by the school board and the council has no authority.

Connie Higgins, 10 East 11th 'St, said that she thought if the council wasn't voting on the resolution, the borough should let the BOE know the reasons why the sale wasn't being supported.

Kathleen Flanagan, CFO, said that there was a Tidelands Claim against the property and it would take \$1.3 million to clear the title.

John Alchus, 8 West 7th St, thanked the council for standing their ground.

CLOSE PUBLIC SESSION: On a motion by **Sharpless**, seconded by **Wellington** and carried by all the public session came to an end.

WHEREAS, as an express condition of consummating any agreement to sell the LBI School to Ship Bottom, the Board is requiring that all municipalities within the District pass a resolution setting forth that the municipalities support the sale of the LBI School to Ship Bottom; and

WHEREAS, in order to satisfy the Board's foregoing condition of selling the LBI School to Ship Bottom, the Borough of Barnegat Light hereby passes the within resolution, expressing its support for the sale of the LBI School to Ship Bottom and further setting forth and acknowledging that any and all decisions regarding the scope and cost of the renovations to the EJ School is the Board's and District voters' decision alone.

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Borough Council of the Borough of Barnegat Light, in accordance with the aforesaid Recitals, which are expressly incorporated herein by reference, hereby supports the Board's sale of the LBI School to Ship Bottom, and further supports the ultimate decision made by the voters in the District regarding the design, plan, scope, and cost of any renovations to the EJ School.

ORDINANCES: SECOND READING

ORDINANCE 2016-011

AN AMENDED ORDINANCE OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AMENDING AND SUPPLEMENTING CHAPTER 164 OF THE BOROUGH CODE, ENTITLED "SOLID WASTE," TO PROVIDE REGULATIONS FOR DUMPSTERS.

WHEREAS, the New Jersey Department of Environmental Protection, Division of Water Quality, Bureau of Nonpoint Pollution Control, requires that the Borough adopt an ordinance requiring dumpsters and other refuse containers that are outdoors or exposed to stormwater to be covered at all times and prohibits the spilling, dumping, leaking, or otherwise discharge of liquids, semi-liquids or solids from the containers to the municipal separate storm sewer system so as to protect public health, safety and welfare, and to prescribe penalties for the failure to comply.

NOW, THERFORE, BE IT ORDAINED by the Mayor and Borough Council of the Borough of Barnegat Light, County of Ocean, State of New Jersey, as follows:

SECTION 1. Article II of Chapter 164 of the Borough Code of the Borough of Barnegat Light, to be entitled "Refuse Containers/ Dumpsters," is hereby amended and supplemented to provide revised Sections 164-18 & 19 to provide as follows:

Chapter 164 SOLID WASTE

ARTICLE II

Refuse Containers / Dumpsters §164-18. Prohibited Conduct.

Any person who controls, whether owned, leased, or operated, a refuse container or dumpster must ensure that such container or dumpster is covered at all times and shall prevent refuse from spilling out or overflowing. Any person who owns, leases or otherwise uses a refuse container or dumpster must ensure that such container or dumpster does not leak or otherwise discharge liquids, semi-liquids or solids to the municipal separate storm sewer system.

§164-19. Exceptions to Prohibition.

The standards of this Article do not apply to:

Litter receptacles (other than dumpsters or other bulk containers);

Individual homeowner trash and recycling containers;

Refuse containers at facilities authorized to discharge stormwater under a valid NJPDES (New Jersey Pollutant Discharge Elimination System) permit;

Large bulky items (e.g., furniture, bound carpet and padding, white goods placed curbside for pickup)

SECTION 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3. If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held to be invalid or unconstitutional by a court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions thereof.

SECTION 4. This ordinance shall take effect after second reading and publication as required by law.

NOTICE






