REGULAR MEETING OF MAYOR AND COUNCIL August 12, 2020

THE CAUCUS MEETING of the Mayor and Council was called to order by Mayor Larson at 4:30pm at the Barnegat Light Fire Hall, on West 10th Street. He stated that adequate notice of this meeting has been provided in accordance with the NJ Open Public Meetings Act. Notice of this meeting was posted on the bulletin board in Borough Hall and was published in the Asbury Park Press and the Beach Haven Times, both newspapers are designated by Mayor and Council to receive such notice.

ROLL CALL: Spark, Wellington, Alloway, Reynolds, Foley was absent, and Mikuletzky

Also present: Mayor Larson, Terry Brady, Michele Inman, Sponge Washburn and Brenda Kuhn

Discussion: Mayor Larson talked about the water meter project. He said that about 200 meters have been picked up and over 50 have been activated.

Then the Mayor said that he had been talking to Sponge about the businesses that have been popping up in town and then talked about the possibility of requiring a mercantile license. Sponge was going to look into it.

Councilman Alloway said there was a situation at the ramp. He explained that at the area where boats tieup is dangerous because a couple of the pilings are broken which causes the dock to go down on the west side. He said that the money was appropriated a few years ago, the plan was ready and no one would give a quote. The money went back into reserve. He wanted to know if there was money in the budget to fix this dangerous problem.

Councilman Wellington said that he would like to use the money that was leftover from another project to resurface the cracked tennis court surface. He said that there was an opening the in the first two weeks in September and asked if anyone had any objection.

Mayor Larson talked about a request from a homeowner to extend the "no dogs on the beach" and to extend the season until the end of September. The council talked about if beach badges would be required and if the tram would still be running for the people at the north end. After reviewing the Borough Code, the Borough Attorney said that it could be extended by resolution.

Mayor Larson said there was a request from Judie Putt to have a free Zumba class at the pavilion, one day a week through October. The Mayor and Council discussed this and the only concern was about the possibility of loud music bothering the neighbors.

Mayor Larson asked for a motion to close the Caucus. On a motion by Reynolds, seconded by Wellington and carried by all the Caucus Meeting was closed.

COMMITTEE REPORTS:

FINANCE: Councilman Spark talked about George Warr who recently passed away.

He said that the big item on the bill list was the County tax. He also complimented the new Assistant Treasurer, Michele Inman, for the job that she was doing.

PUBLIC WORKS: Councilman Wellington said that we all loved George Warr.

He said that DPW installed street signs on the beach side and that the restroom at the pavilion is now completed and was open last Monday for the concert. He said that DPW cleaned and trimmed at the beach ramps. He added that they do this one time every two weeks. He said that a new stone driveway was installed at the park and flowerbeds were put in. He stated that the flowers would come later. Councilman Wellington said that a new tennis wall had been built and it was currently being painted. The wall would be installed later this week. He said that the tennis courts would be resurfaced in September. Mayor Larson said that people are really enjoying the pickleball courts.

DOCKS AND HARBORS: Councilman Alloway talked about the repairs that had to be made at the docks. He wanted to find out if the money that had been previously appropriated for the repairs was still available. He was advised to talk to the CFO about the money.

BEACHES AND PARKS: Councilwoman Reynolds said that the beach badge revenue was up slightly from last year and the dog park revenue was down. She said that the bay beach was being used a lot and the water quality there was much improved because of the work that was done by the DPW. She said that lifeguards would be on the beach through September. She said that there were Mutt mitts around town and people were using them. She reported on the rescues on the beach. She also mentioned the Piping Plovers, Oystercatchers and Osprey. The Councilwoman said that there would be a dog show at the pavilion tomorrow at 4pm.

WATER/SEWER: No report, Councilwoman Foley was absent and no report was given.

PUBLIC SAFETY: Councilman Mikuletzky said that he would like to make the court report a part of the minutes. He reported that the court brought in \$1151.53 and Barnegat Light kept \$708.50. He added that nothing went to fish and game. Councilman Mikuletzky said that the bike signs were on order and he urged everyone to be careful making right turns. Mayor Larson said that plans were being made to bring back the court to Barnegat Light. He said that it wouldn't cost a lot to make the changes that would be required.

OPEN PUBLIC SESSION: Mayor Larson asked for a motion to open the open public session. There was a motion by Spark, seconded by Alloway and carried by all.

Rich Broadman applauded the comments that were made regarding the polluted beaches articles. Nancy Manookian was concerned about all the dead pine trees in town.

Barry Mescolotto asked about the beach mats. The Clerk said that we were waiting to hear from the county about the Community Development Block Grant that we applied for. She said that we usually receive a letter from the county in late August.

Judie Putt, was at the meeting to ask about having a free Zumba class at the pavilion.

John Alchus asked about business zoning. Sponge gave a short explanation about this. He asked who was responsible for the walkway down by the condos. The Mayor said that they condos are responsible.

Brian Grimmett, 14 East 22 Street, asked who was responsible for the bulkhead. The Mayor said that they were required to put it in as part of their CAFRA permit.

CLOSE PUBLIC SESSION: Mayor Larson asked for a motion to close the open public session. There was a motion by Spark, seconded by Alloway and carried by all.
