REGULAR MEETING OF MAYOR AND COUNCIL August 14, 2019

THE CAUCUS MEETING of the Mayor and Council was called to order by Mayor Larson at 4:30pm at the Borough Hall, on East 7th Street. He stated that adequate notice of this meeting has been provided in accordance with the NJ Open Public Meetings Act. Notice of this meeting was posted on the bulletin board in Borough Hall on January 2, 2019 and was published in the Asbury Park Press and Beach Haven Times on January 10, 2019, both newspapers are designated by Mayor and Council to receive such notice.

ROLL CALL: Spark, Wellington, Reynolds, Foley, and Mikuletzky, Alloway was absent

Also present: Mayor Larson, Terry Brady, Ed Sulecki, Al Morison, Sponge Washburn, and Brenda Kuhn

Discussion: Prior to starting the Caucus Meeting the Mayor Larson said that he and the Council wanted to recognized Ed Sulecki upon his upcoming retirement. He said that Ed worked for the Borough for more than 35 years with the last ten years as serving as the Superintendent of the Department of Public Works and the Water/Sewer Department and doing an excellent job. Ed thanked the Borough for the opportunity that was given to him and that he really enjoyed working here for more than half of his life. The Mayor said that Ed knows this town 10 feet under to the top of the water tower and that he really would be missed.

The Mayor introduced Patrolman Neil Rojas of the Long Beach Township Police Department who was at the meeting to speak about LSV, golf carts. The Patrolman came with a handout for the Mayor and Council and proceeded to speak about the issue on behalf of the Police Department. He warned the Council to give this issue careful consideration in terms of liability if they decided to pass an ordinance to allow LSV in our town. There was discussion regarding this topic, pros and cons. Councilwoman Foley recommended that the Governing Body table the adoption of Ordinance 2019-13 Low Speed Vehicles to have more time to consider all the implications that may arise from going against state law to allow LSV in our town. Terry Brady stated that a public hearing was advertised and there were members of the public that were at the meeting. He recommended that the ordinance be opened to the public and then if the council decided to table the vote on the ordinance until next meeting the public hearing wouldn't have to be repeated or readvertised. Mayor Larson asked if Patrolman Rojas would like to stay for the public hearing. The next topic was regarding pickle ball. A letter was received that requested more pickle ball courts. There was discussion about looking in to a location and budgeting for creating more courts. Mayor Larson said that we received a follow up on the request, that was approved by the GB, regarding a motorized wheel chair. Councilwoman Reynolds said that she saw it and it was great and that it goes through the sand beautifully. Patrolman Rojas recommended that the driver wear a helmet at the minimum.

Mayor Larson asked for a motion to close the Caucus. On a motion by Reynolds, seconded by Foley and carried by all the Caucus Meeting was closed.

The Mayor had to leave after the caucus meeting, therefore Council President Spark would conduct the regular meeting.

COMMITTEE REPORTS:

PUBLIC SAFETY: Councilman Mikuletzky said that he wanted to make the court report a part of the minutes. He said that the court took in \$2033 and the Borough kept \$392.50. He also said the Fish and Game's portion of that was \$800.

WATER/SEWER: Councilwoman Foley said that she wanted to make the water report a part of the minutes. She said that as expected, July water usage was way up and that a flannel shirt was taken out of the sewer system. She said that she was working with the Taxpayer's Association to create a survey on the subject of water meter installation.

BEACHES AND PARKS: Councilwoman Reynolds said that beach badge sales were down approximately \$9,000 and that revenue was almost \$220,000. She said that the bay beach had been guarded every day and then she reported on the Beach Patrol report with regard to rescues and injuries. She said that the dog park revenue was slightly down and all of the birds were gone.

FINANCE: Councilman Spark said he didn't have a lot to report except that one of the big bills this month was for the Regional School system. The CFO added that the audit report would be ready next month.

DOCKS AND HARBORS: Councilman Alloway was absent and no report was given.

PUBLIC WORKS: Councilman Wellington said that he wanted to make the DPW report a part of the meeting minutes. He said that the DPW was very busy. He reported the hours spent working in various areas as follows: 103 water/sewer, 64 streets, 211 beaches, 111 parks and 123 building and grounds.

OPEN PUBLIC SESSION: Council President Spark asked for a motion to open the open public session. There was a motion by Reynolds, seconded by Foley and carried by all.

John Tennyson, 6 West 22nd Street, asked Councilwoman Foley about the water meter project. Councilwoman Foley said that a decision hasn't been made yet but there were a few options. The options that were discussed included, putting the project out to bid and awarding to the lowest bidder, the Borough giving the property owners a two-year window to have their own plumber install the Borough supplied meter and pit, and the possibility of the Borough hiring laborers to do the job in house. The Councilwoman said that sometime in the fall she could comment further on this topic. Marilyn Wasilewski, 18 West 7th Street, asked if we had fewer lifeguards this year. She said that she heard that some of the beaches weren't guarded. She also asked if we were keeping up with the salaries. Councilwoman Reynolds replied that we did not have fewer lifeguards and that the salaries are not out of line with the rest of the island. Mrs. Wasilewski also asked if we had a problem getting beach badge checkers and the answer was yes. Rich Brodman, 4 East 10th Street, said he was very apprehensive about having golf carts in town. John Richardson, 809 Central Avenue, asked if any thought has been given regarding the water condition of the bay beach. Councilwoman Reynolds told him that a study was being done. Connie Higgins, 10 East 11th Street, wanted to thank council for the yoga classes. She asked if they would consider adding Thursday afternoons. Dennis Pantzer, 4 East 8th Street, said that he would like to have yoga on Saturdays.

CLOSE PUBLIC SESSION: Council President Spark asked for a motion to close the open public session. There was a motion by Foley, seconded by Reynolds and carried by all.

SECOND READING-PUBLIC HEARING

ORDINANCE 2019-13

AN ORDINANCE OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING LOW-SPEED VEHICLES UPON BOROUGH ROADWAYS THAT DO NOT EXCEED 35MPH SPEED LIMITS

OPEN PUBLIC HEARING:

Council President Spark asked for a motion to open the public hearing. On a motion by Wellington, seconded by Foley and carried by all, the public hearing was open.

John Richardson, asked why did we need golf carts in town. Dennis Pantzer, asked if a poll or survey on how many people are interested in passing this ordinance and are we going to change the quality of life for the whole town to please one or two people. He said that they belong on golf courses, and on the streets they are dangerous. He said it poses a particular danger and the council should consider this. Joy Luedke, 7th Street, said she is the person driving around town in a golf cart. She urged the council to pass the ordinance for various reasons. She said that LSV were environmentally, turtle, and pedestrian friendly. Ms. Luedke said that the speed limit should be reduced to 25mph because it makes drivers more aware of the bikes and pedestrians. She said that it is a fantastic idea. James Gutowski Jr., 11West 28th Street, was at the meeting to support the passage of the LSV ordinance. He said that some of the street ends were overgrown and needed attention. He said it would just lower the speed in town. Sponge Washburn said as Zoning/ Code Enforcement Officer that he would get a lot of complaints if we allowed LSV on Bayview and not on Central Avenue. He said that as an EMT and firefighter, this was discussed at the Fire House and the consensus was that they weren't concerned about the drivers of the golf carts but more concerned about the other drivers that were coming into town from all over and not paying attention to the road. He talked about a rear end collision that occurred in Loveladies and the car was destroyed. He added that if it was a golf cart that was rear ended the occupants would not have survived. John Richardson said that cell phones usage by drivers were a big issue because the golf carts would be vulnerable. Connie Higgins asked about getting to the beach with a LSV when you can only cross Central Avenue at 10th & 20th Streets. She asked how would she do it. Council President explained that we were intending to table the ordinance and Patrolman Neil Rojas, LBTPD, said that if we pass the ordinance, we may be liable if something happens. The Patrolman said that the first step in lowering the speed limit was to write a letter of request to the Ocean County Engineering Department.

CLOSE PUBLIC HEARING:

Being no further public comment, Council President Spark asked for a motion to close the public hearing. On a motion by Wellington, seconded by Reynolds and carried by all, the public hearing was closed.

Council President Spark asked for a motion to table.
