**THE CAUCUS MEETING** of the Mayor and Council was called to order by Mayor Larson at 4:30pm at the Borough Hall, on East 7th Street. He stated that adequate notice of this meeting has been provided in accordance with the New Jersey Open Public Meetings Act by posting a copy of the notice of this meeting on the bulletin board in the Borough Hall on January 5, 2015 and by mailing a copy of the notice to the Beach Haven Times and Asbury Park Press, newspapers designated by Mayor and Council on January 5, 2015, to receive such notice, and by filing a copy of the notice with the Borough Clerk on January 5, 2015.

Ed Wellington brought up the fact that we do not put fluoride in our water and wondered why. What is the history behind not doing so and why wouldn't we. He spoke to Ed Sulecki and he indicates that there is some natural fluoride in our water. Frank Mikuletzky said he has always been totally against it. From what he remembered years ago about it they could never prove it did anything good. Ed said it is one of the 10 greatest health achievements of the 20<sup>th</sup> century. He said it is relatively inexpensive. 50 cents to \$3.00 a year per person. He thinks we should look into it. He has heard that if you over fluoridate it can in fact make people ill. Mike Spark said he remembers it coming up but does not remember why or why not we didn't do it. Frank said you don't drink the water as much. There are toothpastes, rinses, etc. Mayor said most people buy bottled water to drink. Scott said there are fluoride drops for children and when their teeth come in you stop it. The mayor spoke of a better way to allow people in the yard to work on the water tower and rules and regs for same. We are planning to have a meeting with all the carriers to discuss ways to improve. Terry said whoever does the damage is responsible for same. Mayor suggested a bond. Terry said that is not an expedient way of handling a claim. We will work on this.

**HEARING 2015 BUDGET**

As indicated at the last meeting there is no tax increase this year. Brian Logan explained in a bit more detail. There is also no increase in the water/sewer rates. He also mentioned that the state permits

municipalities that are in good financial condition to do a self review. We have a resolution on the agenda this evening to do so, which we did. You can adopt your budget then adopt the resolution for the self review. Mike Spark asked how this self review is decided. Brian said they break the state up into different groups and each group is looked at every couple of years. They make a determination of whether or not you or eligible or ineligible. Last year post Sandy they did not give anybody a self review. It is possible we can be a self review again next year.

Mayor asked for a motion to open the hearing. Spark so moved, seconded by Reynolds and carried by all. The question was asked as to what CLF is. Kat said Capital Improvement Fund. Steve Donatos asked about what we put away in surplus. Brian said any budget appropriation is open for a 2 year period. What you don't spend in any given year you have the next 3 months of the following to spend that and after that it lapses back to surplus and can be used to offset future budgets. The public hearing was closed on a motion by Wellington, seconded by Reynolds and carried by all.

Gail read the resolution for adoption of the budget. Reynolds so moved to adopt, seconded by Wellington.

#### **COMMITTEE REPORTS:**

**WATER/SEWER: Michael Spark** asked to make the water and sewer report a part of the minutes. By the numbers people are starting to come home which is a good sign.

**PUBLIC SAFETY: Frank Mikuletzky** said the scam is still going on with the IRS. They do not call you on the phone. They only send letters. There is a clothing bin being put in at the borough yard. It will benefit the local PBA. It is behind the cardboard. Megan Keller is coming up for a medicine drop. They might come to the Taxpayers meeting. There is one at the Township Police Station all the time. Frank mentioned the new yield sign at Broadway and Central. The road has been reconfigured to make it safer for pedestrians and bikers. There was a stop sign, but the Mayor lobbied with the county to have the yield sign. There will no longer be a left turn lane onto Central.

**DOCKS AND HARBORS: Ed Wellington** said thanks to Scott's guys the docks are ready and opened as of April 1<sup>st</sup>. We have a bunch of new fingers built over the winter. We also put new aluminum gang planks in to replace the old wooden ones. The ramp is ready and will be open this weekend and we still have 3 slips available.

**BEACHES AND PARKS: Dottie Reynolds** said our beach badges are still ahead of last year. We are about \$1800.00 ahead of 2014. Not as far ahead as we were in March. You can still order your beach roll up walkways. Lifeguard tryouts will be June 6<sup>th</sup> and applications are in Borough Hall. The guards will be starting June 13<sup>th</sup>. There will be a mandatory drug test for the guards before they start. The Captain has sent a letter out asking who will be coming back. Getting ready for another nice summer.

**PUBLIC WORKS: Scott Sharpless** asked to make the public works report a part of the minutes. We are losing Frank from public works and we have a new employee - Willie. The kiddie part on 10<sup>th</sup> Street is going to be closed down for the next couple of weeks while we rebuild it. We can now order wood chips, etc. because the budget has passed.

**FINANCE: George Warr** was absent.

#### **OPEN PUBLIC SESSION:**

session was opened. Tim Brindley said a stop sign ticket is \$80.00. Vince Roth spoke of access to the tower. Why can't we do more. Mayor said the problem is they don't respect anybody. Tim Brindley said that yield sign is great. Ashley Sanchez almost got hit there last summer. We put cones up but people kept stealing them. We lost 15 cones. He said he noticed they did not put an access for 6<sup>th</sup> street to cross to the opposite side of the road. 6<sup>th</sup> street is such a heavily traveled area. **RESOLUTION OF THE BOROUGH OF BARNEGAT LIGHT  
COUNTY OF OCAN, STATE OF NEW JERSEY  
FOR SELF EXAMINATION OF THE BUDGET**

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

WHEREAS, pursuant to N.J.A.C. 5:30-7.2 through 7.5, the *Borough of Barnegat Light* has been declared eligible to participate in the program by the Division of Local government Services, and the Chief Financial officer has determined that the local government meets the necessary conditions to participate in the program for the 2015 budget year.

NOW THEREFORE BE IT RESOLVED by the governing body of the *Borough of Barnegat Light* that in accordance with N.J.A.C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the governing body has found the budget has met the following requirements:

1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
  - a. Payment of interest and debt redemption charges
  - b. Deferred charges and statutory expenditures
  - c. Cash deficit of preceding year
  - d. Reserve for uncollected taxes
  - e. Other reserves and non-disbursement items
  - f. Any inclusions of amounts required for school purposes.
2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).
3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
4. That pursuant to the Local Budget Law:
  - a. All estimates of revenue are reasonable, accurate and correctly stated,
  - b. Items of appropriation are properly set forth
  - c. In itemization, form, arrangement and content, the budget will

permit the exercise of the comptroller function within the municipality.

5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.

6. That all other applicable statutory requirements have been fulfilled.

BE IT FURTHER RESOLVED that a copy of this resolution will be forwarded to the Director of the Division of Local Government Services upon adoption.
