

THE CAUCUS MEETING of the Mayor and Council was called to order by Council President Spark at 4:30pm at the Borough Hall, on East 7th Street. He stated that adequate notice of this meeting has been provided in accordance with the New Jersey Open Public Meetings Act by posting a copy of the notice of this meeting on the bulletin board in the Borough Hall on January 5, 2015 and by mailing a copy of the notice to the Beach Haven Times and Asbury Park Press, newspapers designated by Mayor and Council on January 5, 2015, to receive such notice, and by filing a copy of the notice with the Borough Clerk on January 5, 2015.

George Warr brought up the Pinto Brothers letter regarding the selling off part of their fleet and some of their routes to Meadowbrook. Is this permissible? He thought this was a question for Terry Brady. Terry Brady stated that council members have the letter and that this is not something that just simply happens with a government contract. Meadowbrooks will have to supply the same documents that Pinto provided when they were awarded the contract. Terry received a package from Meadowbrook via FedEx just before he left his office. He suspected everything was included; however he did not have time to look it over. He stated he would like to say we are ready to move on it at this meeting, but felt it would be wise to analyze and make sure all of the documents that are required from Meadowbrook have been provided and that we are satisfied that the assignment can happen without any disruption or reduction in service to the residents of the Borough. Original documentation was left and Terry advised that it should be looked over to make sure it matches up with the original Pinto Brothers contract. Ed Wellington stated that as he understands Terry Brady is going to review the documents and also Scott Sharpless and we will act on it as soon as everything is correct. Dottie Reynolds asked if it would be soon enough so no pick-ups would be missed. Terry said we should be fine because Pinto is still responsible because they are under contract. George said the second issue, which does not affect Barnegat Light residents directly, but will impact boaters leaving from Barnegat Light, is Island Beach State Park having lifeguards at Tice's Shoal. Kathy stated that a swimming area will be covered by lifeguards and a fee of \$3.00 per person will be charged for boaters who use the swimming area. George suggested posting a notice for boaters at the Ramp. Ed Wellington said Council needs to talk about the Resolution that is being requested by other towns about the schools. Michael Spark said everyone could state their opinion at the end of caucus. Dottie talked about the TNR (Trap, Neuter Release) ordinance. It's the most humane way to control the cat population. Stray cats are trapped, spayed, neutered, micro-chipped, given their shots and medication and returned to the same area and the person who had them trapped must agree that they will feed them. Kittens are given to a foster and put out for adoption. It saves money for the community. Since the program was introduced on the island, the cat calls to the shelter have decreased by 70%. The ordinance would state that we have a TNR Program and the Friends of the Animal Shelter would run it. There would be no cost to the Borough, only a savings. Scott Sharpless would like to re-visit banning smoking on the beach. He understands there is not time for this year but maybe for the future. George Warr said his only concern is the policing of it, Scott said signage would go a long way. Ed Wellington returned to the school issue. The main concern is to do what is best for the students and the tax payers. The Borough of Ship Bottom and the Borough of Surf City passed a Resolution to keep the school in Ship Bottom open. Based on an engineer's survey the Surf City school is the better of the two although both schools would require money to make it the school to consolidate

to. Politics do play a role in the decision. Council all agreed the decision should be made by the School Board and any resolution that we do should state just that. Kathy mentioned the Town Wide garage Sale on May 16th, LBI PTA is doing a clothing fundraiser on May 30th, and Rigid plastic Recycling program available at the Ocean County Recycling Center, items can be dropped off. There will be a Household Hazardous Waste drop-off on June 6th at the Southern Ocean Recycling Center. Dottie mentioned the Firehouse Auction on May 23rd.

COMMITTEE REPORTS:

PUBLIC WORKS: Scott Sharpless said Public Works has been busy. They had some repairs at the docks and working on the kiddie park with a couple of major setbacks with that causing some delays. He asked to make the public works report a part of the minutes. The Memorial Day Parade will be Sunday May 24th, line-up at 6:00pm on 11th St. and begin at 6:30pm and will end at the State Park with a ceremony.

DOCKS AND HARBORS: Ed Wellington said he did not have any financial numbers, but business has been slow primarily because of the weather. There has been talk for a long time about dredging the public dock area and area up by Bobby's. Today he met with engineers from Frank Little's office and they did soundings in the creek area and they will be made

part of the application for the DEP to apply for a maintenance dredging permit for the entire area, so we are finally starting to move on that.

WATER/SEWER: **Michael Spark** asked to make the water and sewer report a part of the minutes.

BEACHES AND PARKS: **Dottie Reynolds** said she did not have the latest beach badge sales figures, but reminded everyone to buy their beach badges by June 10th at the pre-season rate. She mentioned everything is getting spruced up for the summer and told everyone she hoped they will enjoy their summer.

PUBLIC SAFETY: **Frank Mikuletzky** asked to make the court report part of the minutes. Not a lot of money was collected, there was not much activity, people must be behaving and fishermen were not doing too much. The traffic lights will be going on soon on the island and the speed limits will be changing. They were changed today. Reminded everyone about the prescription drop-off at the Long Beach Township Municipal Building and they will have one at the Tax Payers Association Meeting on Saturday May 16th.

FINANCE: **George Warr** said the bills paid this month were \$456,378.26, of that \$194,992 went to the schools.

OPEN PUBLIC SESSION:

On a motion by Mikuletzky, seconded by Sharpless and carried by all the public session was opened. Steve Danatos, President of BL Tax Payer's Association, said the Association and its members strongly urged the Council not to support Ship Bottom in attempting to maintain two separate schools. The simple economic fact is, it costs more to run two separate schools. There are less than 300 students from Long Beach Island and 36 choice students. The sending districts do not pay anything to the Long Beach Island Consolidated Schools, the State subsidizes by paying the receiving district a little less than \$12,000 per student. Tax Payers Association and members also believe it should be about the kids first and then the economics. The school is Ship Bottom has structural issues, the engineer said it needs a \$75,000 immediate fix because the timbers that support the floor are not stable. The long term fix could be \$1,000,000 that has not been appropriated which would cost the tax payers. He said it is not viable to keep the Ship Bottom school and there is no reason to maintain two separate schools. He urged Council to send a letter in support of consolidation. Richard Feehan wanted to know why this was coming up again, he believed it was a done deal. John Tennyson said the Tax Payers Association conducted a survey during their last membership drive and he had a summary of the results. Members are happy with the way things are running. They plan on taking the results of the survey and putting the answers into three columns, what can the BLTA do? What is the responsibility of the Borough? And the third concerns items that the the BLTA and/or Borough are involved in indirectly? Ed Wellington said he noticed one of the concerns is how the tax payers can know what is happening in the town and what is happening at Council Meetings, he said the BLTA can help by referring the members to the Borough website. Darren Stivale spoke about a letter he wrote to Mayor and Council regarding the noise in the Borough Public Works yard. First, is the noise from the back-up alarms on the Public Works vehicles. He had some suggestions for some cost effective ideas to reduce the use of loud alarms. He asked Scott Sharpless to work with him to explore other options. The second source of noise is the equipment associated with the cell phone towers. He would like someone from the town to work with him to do some sound measurements and explore options with the cell carriers to install some barriers or different types of equipment.

Scott agreed to work with him. Delores Svelling spoke about a letter she wrote to Council concerning neighbors who do not take care of their properties. Her two main concerns were trees that are overgrown and hang onto her property and she pays to have them cut back and bamboo which is very invasive. She would like an ordinance about people not being permitted to plant bamboo. She said Ocean City has an ordinance and she would be willing to look into what they have. She would also like an ordinance about the height of trees that are allowed on people's properties. Ed said there are towns on the Jersey Coast that have an ordinance outlawing Black Pines and feels we could do the same for bamboo and/or Black Pines. Steve Nieswand spoke about another incident that he had with a subcontractor to a subcontractor working on a cell tower and did damage to his property. There was a meeting with Terry Brady and he suggested a meeting with the communications companies so they can do something to protect the surrounding properties when they are working on the towers and said he would send something to Gail. Mr. Nieswand would like to be part of the meeting. He sent an e-mail to Gail with some suggestions about workers signing in when they arrive to do work on the tower which should include names, contact information and what company they are doing work for. There should be more security. Eric Svelling commented on the water main break on 11th & central, he felt that there should have been a police car out there while they were working and maybe should have had more help, possibly from the County. Now the dip in the road where the hole was is getting worse. Michael Spark said it was still settling and it was pretty wet underneath. Scott Sharpless said the County sent a letter about it but it is still settling and once it settles a little more it will be patched over again. Steve Danatos said the BLTA members support the Borough supporting the LBI Shuttle bus, but they wanted more information about the town paying money for advertising. The members do not feel Borough money should be used for advertising. Scott Sharpless explained that the Borough would only be paying \$2000 and the bus will be wrapped to promote Barnegat Light and business names will be on the back. Terry Brady stated the statute that allows municipalities to appropriate funds for advertising. Ed Wellington said the Mayor had said the business in town came up with the majority of the funds and that the town should give the rest because of services that the businesses do not get and pay for on their own. They felt the advertising would be good for the town. Being no further comment, on a motion by Warr, seconded by Wellington and carried by all the public session was closed.
