

REGULAR MEETING OF MAYOR AND COUNCIL April 13, 2016

THE CAUCUS MEETING of the Mayor and Council was called to order by Mayor Larson at 4:30pm at the Borough Hall, on East 7th Street. He stated that adequate notice of this meeting has been provided in accordance with the New Jersey Open Public Meetings Act by posting a copy of the notice of this meeting on the bulletin board in the Borough Hall on January 4, 2016 and by mailing a copy of the notice to the Asbury Park Press, newspaper designated by Mayor and Council on January 4, 2016 to receive such notice, and by filing a copy of the notice with the Borough Clerk on January 4, 2016.

ROLL CALL: Spark, Sharpless, Wellington, Reynolds, Mikuletzky, Warr was absent

Also present: Mayor Larson, Terry Brady, Elaine Tollison, and Brenda Kuhn

The Mayor talked about the lowering of the flag for residents that passed away. He stated that they used to keep it lowered for a couple of days and now the Borough will only keep it lowered for a day, 24 hours. He asked if everyone was okay with that and all agreed. The Mayor said that we would still put the notice in the Post Office.

Then Mayor Larson brought up the controversial Dog Park. He said that we decided to keep the dog park where it is and the ballpark will be in the northeast corner. A backstop will be built there.

Mayor Larson asked Councilman Wellington to talk about the bayfront ordinance. Councilman Wellington said that we were going to do a 1st reading on an ordinance which is going to try to organize the areas of the bay beach where it is common for people to park their kayaks. The last few years the area has accumulated a lot of cinder blocks, old tires filled with concrete and other things that people would use to anchor the non-motorized watercraft. We want to clean up the area. The owners of the watercraft will register with the Borough and pay a onetime \$10.00 fee to cover administration. They will be issued a sticker with a number that is specific to their registration and they will be asked not to bring any of their own anchoring materials. The area will look better and be safer. This ordinance will not pertain to the mooring watercraft.

Mayor Larson began talking about the dog park and the access card readers. The time on the machines will be set at times that will be decided by all. There will be no fee for residents who register their dog with the Borough of Barnegat Light and a fee set for non-residents for weekly and seasonal passes.

Parking on streets was the next subject that was discussed. There will be no parking on Central Ave. between June 1 and October 1st. Councilwoman Reynolds said that it would be safer on Central Ave. for pedestrians and bicyclist. Mayor Larson said that another part of the ordinance is “no overnight parking of trailers” between the hours of 12-5 anywhere, not even on the side streets.

Mayor Larson said that he read in the newspaper that there is a proposal for the Sandy Hook Bay National Marine Sanctuary. They want to close the area to hunting and fishing. Mayor Larson said he thought that we should do a resolution to oppose this. If that goes through Barnegat Bay could be next.

Mayor Larson asked if everyone noticed that the “Coast Guard Property” is being graded. The contractor said that the topsoil was on him! The mayor said that the office staff asked him if we could name the property. Councilman Sharpless suggested “Not the Coast Guard Property”. Mayor Larson said that Kathy came up with “Bay Breeze Park”.

Mayor Larson said we will take a 5 minute break. All were in favor. The Caucus ended.

COMMITTEE REPORTS:

WATER/SEWER: Councilman Spark said he would like the report a part of the regular minutes.

PUBLIC WORKS: Councilman Sharpless said that DPW is up to 13th Street with the boardwalks.

DOCKS AND HARBORS: Councilman Wellington said that the ramp opened on April 1st. The weather hasn’t helped sales but a couple of the commercial guys bought their season passes. The report shows that we have sold \$640.00 of ramp fees so far this year. Councilman Wellington stated that he received an invitation to a pre-construction meeting with DOT regarding dredging. He said that he would be attending the meeting.

BEACHES AND PARKS: Councilwoman Reynolds said that tennis passes are available and we have sold \$160.00 worth so far. She also stated that we have \$12,112.00 more in beach badge sales than at this time last year. She said that we will be ordering the rollup walkways soon. She stated that anyone that is interested in purchasing a roll up could go into Borough Hall to do so.

PUBLIC SAFETY: Councilman Mikuletzky said he would like to make the court report a part of the minutes. The report showed that the court took in \$211.00 and the Borough got to keep \$106.00. Councilman Mikuletzky said the LBTDP Police Chief informed him that they had an upgrade in their radio communication system. They spent \$500,000.00 on the computers, radios etc. All the towns on the Island contributed to this effort.

FINANCE: Councilman Warr was absent so there was no report given.

PROCLAMATION: Linda Feaster, The Branch Manager of the Long Beach Island Branch of the Ocean County Library introduced herself to Mayor, Council and the public. She passed out informative pamphlets. She said that the theme this year was “Libraries’ Transform” which means that they have to transform with the times, electronically and be a library with no walls.

OPEN PUBLIC SESSION: On a motion by Reynolds and seconded by Wellington and carried by all the public session was opened.

Becky Tarditi was concerned about the parking because she has a 3 family unit on Central Avenue. She asked what happens when you have guests. Mayor Larson said each home is supposed to have 3 parking spaces. Ms. Tarditi said she thinks it will cause a hardship. She asked about the Lifeguard Races and the Church. Mayor Larson told her that there would be a waiver by resolution for these types of things. Ms. Tarditi asked if homeowners could get stickers so they would be exempt from the no parking ordinance. Terry Brady said that everyone has the right to park anywhere that it is **legal** to park and the municipality doesn't have the authority to say that this parking space can be used by one person but not by another person. It's either parking or it's not.

A man who didn't identify himself asked where are people going to park if they go to the beach on 30th Street. Councilwoman Reynolds said that people could park on the west side of Central because they are empty.

Evelyn Pergola, 906 Bayview Ave., thanked mayor and council for leaving the dog park where it is. She also stated that she drives to 29th or 30th Street in the summer to go to the beach and she parks on Central and the "No Parking" will be an issue. Councilman Mikuletzky said that the solution to the beach parking issue is that one person can drop off their crowd and park the car on the west side.

Michelle Wellington, 12th Street, said she just wanted to reinforce what Dotty said. She said that even in the middle of the summer the side streets on the bay side of Central are wide open and that it's less than another 100 yards to walk to the beach. She didn't feel that that would be a hardship.

Mary Ellen Foley from 10th Street said she had a question about the kayak registration. She asked what happens if someone comes down for a vacation on the weekend and bring a couple of kayaks. Councilman Wellington stated that the stickers would be available at the beach badge booth.

Tim Brindley of 1404 Bayview said that last August we had a bad storm and he felt that all of the boats should have been removed from the bay area. He also asked about some of the details pertaining to the registration of the non-motorized watercraft.

Mike Greenblatt from 706 Central Avenue wanted to clarify where the backstop was going to be and what the hours would be for the dog park. He asked if there would be further discussion on the times that the dog park would be open. Mayor Larson said that 8:30 to dusk was being talked about.

Elise Lemcke said that you can't use dusk as a closing time for the dog park. She suggested sunset or to just pick a time. She said she lives right across the street and when she bought the property when it was a ballpark and now it's a dog park and she loves it. Her biggest complaint is that there is no control and the police do nothing. She said she wants people to respect what we have. Mayor Larson said that what he and the Council were trying to do is to have more control over the dog park.

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

WHEREAS, pursuant to N.J.A.C. 5:30-7.2 through 7.5, the *Borough of Barnegat Light* has been declared eligible to participate in the program by the Division of Local government Services, and the Chief Financial officer has determined that the local government meets the necessary conditions to participate in the program for the 2016 budget year.

NOW THEREFORE BE IT RESOLVED by the governing body of the *Borough of Barnegat Light* that in accordance with N.J.A.C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the governing body has found the budget has met the following requirements:

1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
 - a. Payment of interest and debt redemption charges
 - b. Deferred charges and statutory expenditures
 - c. Cash deficit of preceding year
 - d. Reserve for uncollected taxes
 - e. Other reserves and non-disbursement items
 - f. Any inclusions of amounts required for school purposes.
2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).
3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.
4. That pursuant to the Local Budget Law:
 - a. All estimates of revenue are reasonable, accurate and correctly stated,
 - b. Items of appropriation are properly set forth
 - c. In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality.
5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.
6. That all other applicable statutory requirements have been fulfilled.
