### Requirements:

1. Application fee: Check in the amount of \$50 (non-refundable)
2. Permit fee: Check in the amount of \$200 (non-refundable)
3. Security deposit: Check in the amount of \$500. (After event, you must request, in writing, a refund of deposit.) If no damages are found or any clean up required, the entire \$500 will be refunded. Check will be mailed after approved at the first Council Meeting following your written request. Please include in your request, name the check should be payable to and address to mail the check. The Borough reserves the right to retain the entire security deposit for damages and/or clean and may charge additional fees for extensive damage, exceeding \$500.
4. Certificate of liability insurance naming the Borough of Barnegat Light as additionally insured, \$1,000,000 minimum.
