# REGULAR MEETING OF MAYOR AND COUNCIL July 14, 2021

**THE CAUCUS MEETING** of the Mayor and Council was called to order by Mayor Larson at 4:30pm at the Borough Hall, 10 East 7<sup>th</sup> Street, Barnegat Light, NJ. He stated that adequate notice of this meeting has been provided in accordance with the New Jersey Open Public Meetings Act. Notice of this meeting was advertised in the Asbury Park Press and Beach Haven Times on January 27, 2021, both newspapers designated by Mayor and Council to receive such notice.

ROLL CALL: Spark, Wellington, Alloway, Reynolds, Foley, and Mikuletzky

Also present: Terry Brady, Stuart McGowan, Sponge Washburn, Michele Inman, and Brenda Kuhn

**Discussion:** Mayor Larson brought up the topic of height restrictions and the issue with flooding on the east side of Bay Avenue. Councilman Wellington said there was a meeting to discuss the flooding issue and to come up with a plan that would be in the best interest of the community for the long term. He said that elevation points were taken and it revealed that there was a 4' difference between Central Ave. and Bayview Avenue at the crown of the road. He said that they would be proposing to allow new construction to on east Bayview to raise the property 2' and keep the same 30' building height. He said that there would also be a requirement to have a retaining wall to protect water runoff on the adjoining properties and to have drainage to the street. Another issue is the high water table.

There was a lot of discussion about this topic. Mayor Larson said they would work with the engineer to come up with an ordinance to address this problem.

Councilwoman Reynolds said that the children's playground equipment will be arriving next Tuesday. She said that it would take a maximum of 2 weeks to complete. She asked Council if it should be installed now or wait until September. Everyone agreed to start it now so that it could be enjoyed for the rest of the summer.

Mayor Larson had tips for saving water. He said that when we start billing from the meters people will be surprised at how much water they use, especially if they have a leaky toilet, leaky faucets or sprinklers. He said their bill could double or triple. He said when Harvey Cedars put in meters, after a year they saw a 30% reduction in water usage. Councilwoman Foley said that she had Stuart look at the usage last month for her and two of her neighbors. She said the two with watering systems used 98,000 and 128,000 gallons and the neighbor without the watering system used 14,000 gallons. She said that cutting the time for watering from 20 minutes to 5 minutes would be beneficial.

Mayor Larson brought up the cardboard drop off. He said that people just drop off boxes without breaking them down and trash. He said that the cardboard for recycling is just corrugated, not pizza boxes or any other trash. Sponge suggested that we put up a sign that says, "boxes must be broken down". There was more discussion about recycling in general.

**Mayor Larson** asked for a motion to close the Caucus. On a motion by Wellington, seconded by Reynolds and carried by all the Caucus Meeting was closed.

## **COMMITTEE REPORTS:**

**PUBLIC SAFETY: Councilman Mikuletzky** said he would like to make the court report a part of the minutes. He said that the court brought in \$1750.08. He said that \$1140.00 was for Fish & Game and Barnegat Light would keep \$374.00. He said that there was a problem in Beach Haven with a large group of out of control kids. He heard that fifty were arrested. He said that all the Island Police responded and Stafford Township Police assisted. Mayor Larson said that Avalon just closed their beaches earlier due to the same problem. Councilman Mikuletzky said that the concert and parade were good and the weather held out.

**WATER/SEWER: Councilwoman Foley** said there were approximately 30 meters left to activate. She said that the training has been done. She said that if there is any leaks the guys will be able to tell.

**BEACHES AND PARKS: Councilwoman Reynolds** said reported on the Beach Patrol report that was submitted by Captain Schulze. The report included promotions to the position of Lieutenant for Andrew Baxter and Zak Westerberg, the preseason requirements that included swimming tryouts, rookie school, preemployment screenings and certifications for first aid and CPR. The report also included the NJDEP restrictions due to the nesting Piping Plovers, the guarded beaches and the upcoming 12<sup>th</sup> annual Barnegat Light Ocean Mile Swim that will be held on July 31<sup>st</sup> and the Long Beach Island Lifeguard August 6<sup>th</sup> & 7<sup>th</sup>. The report also accounted for the number of beach rescues and first aid. Councilwoman Reynolds said that the beach badge and dog park revenues were both up from this time last year. She said that there were 6 Piping Plover nest this year but all but one were lost to the storm and coyotes. She added that one American Oyster Catcher fledged from the restoration area.

DOCKS AND HARBORS: Councilman Alloway said that he did not have anything to report.

**PUBLIC WORKS: Councilman Wellington** said that DPW did all the basic maintenance of the parks, properties and beach entrances. He said that the overgrowth on the trails leading to the beaches were cut back, the tram trail was graded, stone was installed at the lifeguard house, about 50% of the cedar shakes were installed at the lifeguard house, the Borough owned catch basins were cleaned, the grass was moved and memorial pavers were installed at the pavilion. The Council said that the grass at the pavilion looks great! Mayor Larson said that the ribbon cutting for the new butterfly garden will be on July 28<sup>th</sup>.

**FINANCE: Councilman Spark** said that the Finance Committee approved the bills that were submitted. He said the big tickets were to the County at almost \$1,000,000 and \$55,000 for 3<sup>rd</sup> quarter sewer. He said that the tax rate for 2021 was .89, down a penny from last year.

**OPEN PUBLIC SESSION:** Mayor Larson asked for a motion to open the open public session.

Rich Brodman, on behalf of the BL Taxpayers Association, said there would be a Taxpayers Association Meeting at the pavilion on July 24<sup>th</sup>. He said that the meeting would be devoted to the potential implications of wind farms regarding economic and environmental impact. There was more discussion on this topic.

Sarah Lambert, 1609 Seaview Avenue, asked when the tax bills would be going out. The clerks said in within two weeks. Ms. Lambert said that the water pressure at the dog park was terrible. The Mayor responded that it has been like that since we purchased the property.

Connie Higgins, 10 East 11<sup>th</sup> Street, asked what the new rates for water billing would be. Mayor Larson told her that they have not been set yet but it should be similar to what they are paying now. He said that

if you have leaking faucets or toilets, you should get them repaired before we start billing from the meter readings. He also warned about running irrigation systems for long periods of time.

Katie Espositio, 1004 Central Avenue, asked why the agenda wasn't posted on the website or posted in the newspaper. The Attorney told her that we are not required to advertise those things in the newspaper. He told her that we advertise the list of all of the meetings in the paper. She also wanted to know why the minutes were not on the website for three meeting. She was told that they do not get post until they are approved at a meeting and the May minutes were not provided to Council in time for their review and there were two meetings in June. All of them would be approved at this meeting.

**CLOSE PUBLIC SESSION:** Mayor Larson asked for a motion to close the open public session.

## RESOLUTION 2021-097

RESOLUTION OF THE BOROUGH OF BARNEGAT LIGHT, COUNTY OF OCEAN, STATE OF NEW JERSEY, OPPOSING SENATE BILL NO. 3926 AMENDING THE "OFFSHORE WIND ECONOMIC DEVELOPMENT ACT" AND GRANTING THE BOARD OF PUBLIC UTILITIES AUTHORITY TO SUPERSEDE CERTAIN LOCAL GOVERNMENTAL POWERS UPON PETITION FROM OFFSHORE WIND PROJECTS

WHEREAS, the New Jersey Legislature is currently considering legislation that would fast-track offshore wind energy projects by removing the ability of local governments to control power lines and other onshore components of offshore wind farms; and

WHEREAS, the bill would amend the "Offshore Wind Economic Development Act," to authorize a qualified offshore wind project or an open access offshore wind transmission facility approved by the Board of Public Utilities ("Board") to place, replace, construct, reconstruct, install, reinstall, add to, extend, use, operate, inspect, and maintain wires, conduits, lines, and associated infrastructure, whether underground or overhead, or within, under, or upon the public streets, thoroughfares, rights-of-way, or any other public property of any municipality, county or other instrumentality of the state; and WHEREAS, the bill also authorizes a qualified offshore wind project or an open access offshore wind transmission facility approved by the Board to file a petition with the Board seeking a determination that all municipal or county approvals, consents, or affirmative filings with other public entities required to construct the qualified offshore wind project are preempted and superseded, upon a finding by the Board that such municipal or county approvals, consents, or affirmative filings are reasonably necessary for the construction of the qualified offshore wind project; and

WHEREAS, if the Board makes a determination preempting municipal or county action that is a condition of a permit or other approval of the Department of Environmental Protection or any other department or agency of the state, the department or agency may proceed to act without prior municipal or county approval, consent, or affirmative filing; and

WHEREAS, the bill provides that a qualified offshore wind project approved by the Board is to be deemed an electric power generator for the purposes of the "Municipal Land Use Law," which would allow for an appeal of a Local Land Use Board decision to the Board; and

WHEREAS, the bill further provides that a municipality, county or other instrumentality of the state may not prohibit, or charge a fee for, the use of public streets, thoroughfares, or rights-of-way for the aforementioned purposes, other than a fee for a road opening permit; and

WHEREAS, the proposed development of offshore wind power projects has resulted in significant and growing concern throughout New Jersey's coastal communities due to the potential negative environmental impact on New Jersey's most pristine natural resource, as well as the detrimental impact on tourism, the recreational and commercial fishing industries and local property values; and WHEREAS, in spite of the economic and environmental concerns raised by a number of citizen groups and local governmental leaders, which have advocated for greater and more meaningful input in the review process, the legislature is considering Senate Bill No. 3926 which fast-tracks wind energy projects and preempts local government control; and

WHEREAS, the governing body of the Borough of Barnegat Light wishes to go on record as opposing Senate Bill No. 3926.

NOW, THEREFORE BE IT RESOLVED, this 14<sup>th</sup> day of July, 2021, by the governing body of the Borough of Barnegat Light, County of Ocean, State of New Jersey, as follows:

That the governing body does hereby oppose Senate Bill No. 3926 amending the "Offshore Wind Economic Development Act" and granting the Board of Public Utilities Authority to supersede certain local governmental powers upon petition from offshore wind projects.

That a certified copy of this resolution shall be forwarded by the Municipal Clerk to the Governor, 9<sup>th</sup> District State Legislators, Ocean County Board of Commissioners, and all Long Beach Island Mayors.
